**CITY OF DEADWOOD  
PARKING AND TRANSPORTATION COMMITTEE**

June 27, 2024

**1. ROLL CALL:**

The City of Deadwood Parking and Transportation Committee met Thursday, June 27, 2024, in the Century Room in City Hall. Justin Lux called the meeting to order at 9:00 a.m. Present were Justin Lux, Cory Shafer, Dory Hanson, Kevin Kuchenbecker, Trent Mohr, Tom Riley, Jim Lee, John Rystrom, Misty Trehwella and Andy Goodwin. Commissioner Mike Johnson was present.

Absent was Lornie Stalder.

**2. APPROVAL OF MINUTES:** June 23, 2024.

Minutes for the meeting on Thursday, June 23, 2024, were approved unanimously by a motion from Mr. Kuchenbecker and a second by Mr. Riley.

**3. INFORMATIONAL ITEMS ON AGENDA**

- a. Whitewood Creek Updates:** Mr. Kuchenbecker indicated the FEMA project continues. It's all done on Sherman Street except some landscaping behind Taco Johns and the Monument. They are moving on to the Comfort Inn. Most of the bank stabilization is completed. They will be going down Ryan Road. Still waiting on some connectors for the elbows and angles. The next phase is the large utility island that will take 2 parking spots in the parking lot next to City Hall. There are 4 pieces of equipment for Black Hills Power transformers and switches, as well as vaults and pedestals for BluePeak and Midco. That island will be 20x26. Trenching and staging will begin.

The other Whitewood Creek project is the Boardwalk or the Deadwood Welcome Center Trail/Whitewood Creek Trail. There has been some sloughing on Railroad Street. They started setting blocks on the uphill side.

**4. NOTICE TO CONTEST PARKING TICKETS:**

- a. 1155638:** Discussion. Motion to uphold the citation by Mr. Kuchenbecker, second by Mr. Riley; motion carried.

**5. NEW BUSINESS:**

- a. Recommend approval for motorcycle parking in front of 681 Main Street on July 13, 2024 from 8:00 am – 4:00 pm for the Harley Davidson Passport Ride:** Harley filled out an event application but it was filed too late for a public hearing so commissioners asked it to come to P&T committee. It's a scramble that starts in Rapid City. The riders only stop for a few minutes at a time. Discussion. There haven't been issues in the past. Motion to recommend approval to allow

contingent upon them policing/monitoring the area during the event by Mr. Mohr, second by Ms. Trehwella; carried with one opposed.

- b. Pedestrian Traffic at the Post Office:** Mr. Lux indicated he spoke with Mike Percevic who expressed concern with the speed of vehicles north bound leaving the intersection of Sherman Street and Pine Street and the pedestrian traffic crossing from the Roadhouse side of the street. The question was if there was a possibility of installing a crosswalk there. Discussion.

## 6. OLD BUSINESS:

- a. Canyon Cab:** They have not paid up – they owe \$420.24. They have been sent multiple letters to remind them to pay. In addition to the reminders, following the last P&T meeting attempts were made to reach them with no success. They are still operating. All other cab companies have paid their fees. Discussion. Motion to recommend the Chief of Police suspend the license and move it forward to City Commission for possible revocation of the license at July 1 meeting by Mr. Mohr, second by Chief Shafer; motion carried.

## 7. INFORMATIONAL ITEMS NOT ON AGENDA:

Mr. Lux indicated there were no updates on the Deadwood Hill lot as it is moving at the pace of molasses. He's working on getting appraisals.

BID 8 paid for the City to lease the slag pile for the duration of the summer. The City will encourage people with trailers to utilize that lot for short stays and also as overflow parking. A sign will be made to put up there. It's been bladed and it will be mowed to encourage use.

With no further business for the committee to consider, Mr. Riley moved to adjourn, second by Mr. Kuchenbecker; motion carried. Next meeting is July 11, 2024, at 9:00 am.

**CITY OF DEADWOOD

July 11, 2024

**1. ROLL CALL:**

The City of Deadwood Parking and Transportation Committee met Thursday, July 11, 2024, in the Century Room in City Hall. Justin Lux called the meeting to order at 9:00 a.m. Present were Justin Lux, Cory Shafer, Dory Hanson, Kevin Kuchenbecker, Trent Mohr, Tom Riley, Lornie Stalder and Misty Trehella. Commissioner Mike Johnson was present.

Absent were Jim Lee, John Rystrom and Andy Goodwin.

**2. APPROVAL OF MINUTES:** not available

**3. INFORMATIONAL ITEMS ON AGENDA**

- a. **WWC FEMA Update:** Mr. Lux indicated the project is still moving along. The only snag is that they ran into a Century Link line up on Ryan Road; they won't abandon this line and they are 30 days out from rerouting it.
- b. **WWC Boardwalk:** Mr. Lux indicated it will be closed to vehicular traffic during the Days. The City should contact the Days committee to let them know this will be closed to horses, as well.
- c. **Slag Pile:** There is a big sign coming (4x8) advertising overflow and trailer parking.
- d. **Lower Main Street Closures During Special Events:** Mr. Lux and Chief Shafer went to a meeting where the Badlands section of Main Street indicated they wanted to do a bump out for vendors on the west side of Main Street (Wild Bill Bar side). It will be limited to about 20' of the roadway. Traffic will be north bound only (one way). This will be when the full Main Street closure is going on. Jersey barriers were part of the discussion.

**4. NOTICE TO CONTEST PARKING TICKETS: None**

**5. NEW BUSINESS:**

- a. **Designated Spots for the Welcome Center:** Mr. Lux indicated this came up in the event committee meeting. They would like 10 spaces for staff parking labeled Welcome Center and one or two 20-minute parking spaces. Mr. Kuchenbecker indicated that when that parking lot was designed the far end was intended for chamber employee parking so that the closer spots would be maintained for visitors. Discussion. Motion to install 1 or 2 temporary stanchions for two 20-minute parking stalls for guests of the Welcome Center made by Mr. Stalder, second by Mr. Kuchenbecker; motion carried.

- b. July 20 Motorcycle Ride: Approximately 30 vehicles in front of the Wild Bill Bar:** Request is to park in front of the Wild Bill Bar from noon for about an hour. This is a Saturday and there isn't anything else on the event calendar. The Stagecoach may be the only issue. They would need to monitor the area and the City wouldn't have to do anything. Discussion. Could this be moved to 2:00 as the stagecoach is done at 2:00? Motion to recommend approval on the condition that they are responsible for policing it and that there be a possibility of changing the time to avoid conflict with the stagecoach by Mr. Mohr, second by Chief Shafer; motion carried.

**6. OLD BUSINESS: None**

**7. INFORMATIONAL ITEMS NOT ON AGENDA:**

Commissioner Johnson indicated he had been working with BluePeak for repairs to his service at his home. They found the issue and they will need to replace lines. BluePeak indicated there would be no service overnight (maybe several nights) in the neighborhood while repairs are made and that may affect the police department as well. Commissioner Johnson wanted the committee and the police department to be aware.

**8. ADJOURNMENT:**

With no further business for the committee to consider, Mr. Stalder moved to adjourn, second by Mr. Riley; motion carried. Next meeting is July 25, 2024, at 9:00 am.
