- Mr. John Haranzo 56 Tanglewood
 - Mr. Haranzo 1st wanted to thank the Board for their hard work and efforts in our Community. Secondly, he came to share is concern for our community regarding the upcoming road closure on Highbanks beginning on June 5th. Mr. Haranzo provided the

Board with statistics and facts from FL DOT on the volume of traffic on Highbanks and with the detours, could potentially put our OH roads at risk. According to Mr. Haranzo, in 2022 an average of over 4,100 cars per day travel on Highbanks. His concerns: Effects of the residents, wear and tear of our streets, and no sidewalks providing a public safety issue all raise valid concerns. The Board questioned if the city had completed Impact Studies for the construction project. The Board shares the same concerns as Mr. Haranzo; however, there may not be enough time to act prior to the start of the project. Actions discussed included: 1) Requesting the city pay for any road damage during the project due to the increased traffic on Sackett, Gracie, and Lake. 2) Research Barricade companies to add temporary barricades on Sackett and Gracie) to help minimize traffic coming through.
