 Property Tax Bill listed the Assessment Fee.

- The Board agreed then that the Linton's egress is on Spruce Drive next to the Orlandia mailboxes. The Lintons do not ingress or egress onto any Orlandia streets and feel they should not have to pay the \$300.00 assessment fee to maintain the roads.
- This is now the 3rd time Mrs. Linton has come before this board.
 - Nov 18, 2021 / Nov 17, 2022 / Sept 28, 2023
 - It is of the opinion of the Board that this is a City responsibility and should be handled with the Tax Office, not the OHNID
 - There are other homes in OH exempt from the Special Assessment; why is Mrs. Linton's home the exception?
- This exemption should remain in effect until further notice.
 - Motion by Chris, 2nd by Nancy. Approved 3/0
