CALL TO ORDER

1. Jess Peterson, R6 Regional Council; Training on Annual Mandatory and Relevant Issues for both P&Z Commission and City Council

Peterson discussed the importance of having a strong Social Media Policy in Delta City's Policies and Procedures and will work with office staff to draft an ordinance defining and implementing this.
