5. Steve Styler: Veracity Investments, LLC; Preliminary Plat Approval - Extension Request - 311 S. Center Street, Delta, Utah

Steve Styler appeared before the Planning and Zoning Commission for an extension request on 311 S. Center Street. Styler has made adjustments to the utilities to fit the townhome changes.

Commission Member Christensen <u>MOVED</u> to approve the preliminary plat extension request for 311 S Center Street. The motion was <u>SECONDED</u> by Commission Member Curtis. Chairman Droubay asked if there were any questions or comments regarding the motion. There being none, he called for a vote.

Steve Styler appeared before the Planning and Zoning Commission for a final plat review and approval for 311 South Center Street. Public Works Director Kirkland remarked that it would usually be after the infrastructure has been installed, so this would be conditioned upon an irrevocable letter of credit to bond.

Council Liaison Killpack <u>MOVED</u> to approve the final plat review and approval for 311 S. Center Street conditioned upon an irrevocable letter of credit to bond. The motion was <u>SECONDED</u> by Commission Member Christensen. Chairman Droubay asked if there were any questions or comments regarding the motion. There being none, he called for a vote.

Steve Styler will come back to the February Planning and Zoning Commission meeting to apply for an amended plat because of the new townhome ordinance. Attorney Anderson asked the Commission if they would like to proceed with having a 50-foot street instead of a 60-foot street in this situation. The Commission agreed. Kelly Carter remarked that the road does not exist today, and he would need to make a new road. A narrow right of way is 45 feet or less but this will be wider at 50 feet. He would dedicate the road to the city for maintenance. Attorney Anderson will start working on drafting the language.
