CALL TO ORDER

Mayor Niles called the meeting to order at 7:00 p.m. He stated that notice of the time, place, and agenda of the meeting had been posted at the Delta City Complex, on the Delta City website, on the Utah Public Notice website, had been provided to the Millard County Chronicle-Progress, LLC and each member of the City Council at least 24 hours before the meeting. Mayor Niles conducted a roll call. Council Members Killpack, Chase, and Bogue were present. Council Member Western was absent. Council Member Carter arrived after the roll call at 7:08 p.m.

Council Member Killpack offered the opening remarks.

PLEDGE OF ALLEGIANCE

Mayor Niles led those in attendance in the Pledge of Allegiance.

CONSENT AGENDA

Minutes Approval: RCCM 2025-01-15

The Regular City Council Meeting minutes held on 1/15/25 were presented for approval. Council Member Chase MOVED to approve the Regular City Council Meeting minutes held on 1/15/25. Council Member Bogue SECONDED the motion. Mayor Niles asked if there were any other questions or comments regarding the motion. There being none, he called for a vote.

Motion made by Council Member Chase, Seconded by Council Member Bogue. Voting Yea: Council Member Chase, Council Member Killpack, Council Member Bogue Council Members Western and Carter were absent.

2. Accounts Payable, Payroll, and Electronic Disbursements Approval: 2025-02-05 \$1,093,197.01

The Council reviewed the accounts payable, payroll, and electronic transactions for the period ending 2/5/25 for \$1,093,197.01. Council Member Killpack MOVED to approve the disbursed payments dated 2/5/25 for \$1,093,197.01. Council Member Chase SECONDED the motion. Delta City Attorney Todd Anderson opened a discussion about the code enforcement policy review. Public Works Director Kirkland remarked that staff members would like to skip the recommended first step of the phone call and send a courtesy letter instead.

Council Member Chase recommended that Recorder Westbrook research whether the new phone system can send automated messages.

Council Member Bogue would like someone from Delta City to contact the violator first. Public Works Director Kirkland explained that the first letter would be a soft letter informing them of the violation. Council Member Bogue would like to see a draft of the first letter.

Council Member Bogue asked Attorney Anderson about the status of the Sherwood Shores water policy. Attorney Anderson remarked that the code will need to be rewritten.

3. Public Works Director, Dent Kirkland; Approval of Airport Pavement Maint.

Action: Discussion/Consideration for approval

Public Works Director Kirkland presented a scope of work for the airport. The runway will be crack-sealed, asphalt maintained, and repainted. The State of Utah will pay 90%, and Delta City will be responsible for 10%.

Council Member Carter <u>MOVED</u> to approve the airport pavement maintenance. The motion was <u>SECONDED</u> by Council Member Killpack. Mayor Niles asked if there were any questions or comments regarding the motion. There being none, he called for a vote.

 Sherri Westbrook, City Recorder: Administrative Update Discussion only

City Recorder Sherri Westbrook provided an administrative update to the Council. The office staff have been updating task lists and transition updates. Recorder Westbrook has been updating the SAM registration.

There was a discussion about the advertisement for the Treasurer position. Council Member Bogue questioned if there was a policy about advertising for the open position to the public even if it was offered in-house first.

 Dent R. Kirkland, Public Works Director, Public Works Update Discussion Only

Public Works Director Kirkland provided a public works update to the Council. The public works department has been crack-sealing and fixing water leaks. Katie Rodriguez has been cleaning and painting the city shop. The sewer project has been going well, and the traffic master plan has been upgrading roads to submit to the state for Class B money.
