Alex Narteh: Final Plat approval -Tenny's Corner project - 200 South 500 West Action: Discussion/Consideration for approval.

Alex Narteh appeared before the Planning and Zoning Commission seeking final plat approval for Tenny's Corner located at 200 South 500 West. Commission Member Stewart asked what the changes are from the preliminary approval. Narteh explained that the improvements have been bonded and there are not any changes from the preliminary approval. Commission Member Stewart and Council Liaison Killpack discussed the need of the improvement cost sharing agreement to be finalized as it would apply to the double chip sealing of the 50 street in this case.

Commission Member Stewart MOVED to approve the final plat for Tenny's Corner Project – 200 South 500 West. The motion was SECONDED by Commission Member Dutson. Commission Member Smith asked if there were any questions or comments regarding the motion. There being none, he called for a vote.

Rob Droubay: Notch Peak View Subdivision, Phase 6 Preliminary Plat Approval Action: Discussion/Consideration for approval.

Rob Droubay appeared before the Planning and Zoning Commission seeking preliminary plat approval for Notch Peak View Subdivision, Phase 6. Droubay explained that this is the last three lots of the preliminary plat about twenty years ago. All utilities are in, the curb is in but the sidewalk still needs to be done.

Council Liaison Killpack MOVED to approve the Notch Peak View Subdivision, Phase 6 Preliminary Plat. The motion was SECONDED by Commission Member Stewart. Commission Member Smith asked if there were any questions or comments regarding the motion. There being none, he called for a vote.

Council Liaison Killpack discussed some of the changes that will be coming with the legislative changes on subdivisions in the future. Preliminary approvals will most likely still come before the Planning & Zoning Commission with the Final approvals being given administratively. There will be guidelines and checklists that developers will need to comply with before approvals will be issued. A road plan will need to be established as well.
