MINUTES OF SISTER CITIES INC. BOARD OF DIRECTORS MEETING KATY DEPOT CONFERENCE ROOM MONDAY, DECEMBER 4, 2023

CALL TO ORDER

Announce the presence of a quorum.

Carrie Boettger calls the meeting to order at 5:34pm. Sister Cities Board of Directors present were Carrie Boettger, Brandon Cates, Paisley Conrad, Lee Thornton, Emily Crow, and Tracy Bullard. Board members not present included Rita Cole. Staff present was Tourism Manager Rachel Reinert.

2. ITEMS FOR INDIVIDUAL CONSIDERATION

A. Receive a report, hold a discussion, and take action on approve the Meeting Minutes from the September 11, 2023 meeting.

Board Action

The minutes passed unanimously.

B. Receive a report and hold a discussion regarding the chaperone applications received for the 2024 Exchange Program.

Board Action

The board reviewed the three submitted applications for chaperones, and unanimously voted to interview all three candidates with an interview committee consisting of board members and staff.

C. Receive a report and hold a discussion regarding the student applications received for the 2024 Exchange Program.

Board Action

The board reviewed the student applications for the 2024 exchange and unanimously voted to interview all ten applicants with an interview committee consisting of board members and staff.

D. Receive a report, hold a discussion, and take action on accepting student applications that do not meet application qualifications.

Board Action

The program received an application from a student who currently lives outside of Grayson County, which is a requirement listed in the student application. The board discussed the student's situation and unanimously voted to interview the student and as normal and to make an exception for the living situation.

E. Receive a report and hold a discussion on approving a plan for student and chaperone interviews, schedules, and home visits.

Board Action

The board created a schedule for an interview committee made up of board members and staff for both chaperones and students, as well as dates for home visits. The interviews will be held December 11th through the 13th at the DHS Counseling Office and Home Visits will be conducted by board members on January 6th.

F. Receive a report and hold a discussion regarding connections with the French students and exchange program scheduling.

Board Action

The board discussed dates for the 2024 exchange. Board Member Brandon Cates will reach out to our French partners to confirm when students will be out of school and when Denison students can arrive in France.
