Summary

- Current policy only allows qualifying residents assistance a maximum of twice.
- That policy was adopted due to the amount of emergency repair funding available.
- Staff is proposing to amend the amount of assistance an eligible resident may receive.
- Eligible Residents would only be approved for one (1) project per program year.
- Eligible residents would only be approved for two (2) projects over a span of five (5) program years.
- If two approved projects do not exceed \$5,000.00 dollars, an eligible resident may receive an additional approval.
- There would be a hard cap of three (3) approvals over a span of five (5) program years.
- Residents may apply for additional assistance after a project moves past the five (5) year assistance limit.

Staff Recommendation

Staff recommends approval of increasing the frequency an eligible resident may receive CDBG assistance.

Recommended Motion

"I move to approve an increase in the of number of assistance projects an eligible resident may receive."

Background Information and Analysis

Current policy only allows for qualifying residents to receive assistance a maximum of two (2) individual projects. These two projects may not be in the same program year. This policy was adopted due to the amount of emergency repair funding available. Due to the varying costs of each project, staff is proposing the following thresholds for receiving assistance.

- Eligible residents may only receive assistance on one (1) qualifying project in a program year.
- Eligible residents may only receive assistance on two (2) qualifying projects over a span of five (5) programs years if the total costs of the two (2) projects exceed five thousand dollars (\$5,000.00).

• In the event that the two (2) projects combined are under \$5,000.00, an eligible resident may receive assistance one (1) additional year in a five (5) year window, making a hard cap at three (3) eligible repairs of a span of five (5) program years. Residents would be eligible to apply for additional assistance as a project moves past the five (5) year limits.
