## CITY OF DENISON PARKS AND RECREATION COMMISSION MEETING MINUTES

# Thursday, September 7, 2023

# **1. CALL TO ORDER**

Announce the presence of a quorum.

Commission Chair Means called the meeting to order at 1:35pm. Commissioners present were Charlie Means, Vincent Rhodes, Joel Luper, and Ryan Cassell. Staff present were Justin Eastwood, Director of Parks and Recreation; Virginia Cantrell, Management Assistant of Parks and Recreation; Andrew Means, Recreation Manager; and Chip Egger, Park Administrative Superintendent.

#### 2. PUBLIC COMMENTS

No request to Speak Cards were turned in by this point in the meeting. Therefore, no public comments were received.

# 3. ITEMS FOR INDIVIDUAL CONSIDERATION

A. Receive a report, hold a discussion, and take action on approving the Minutes from the Parks and Recreation Commission Meeting held on May 3, 2023.

#### Commission Action

On motion by Commissioner Cassell, seconded by Commissioner Rhodes, the Parks and Recreation Commission unanimously approved the Minutes from the Parks and Recreation Commission Meeting held on May 3, 2023, as presented.

B. Receive a report and hold a discussion on the THF Birthday Bash and upcoming recreation events.

Commission Action

Andrew Means, Recreation Manager, gave a review of the 5<sup>th</sup> annual THF Birthday Bash that included waterslides, inflatables, zip line, laser tag, touch-a-truck, foam cannon, a helicopter, and more. Two to three thousand people were estimated to have been in attendance.

Mr. Means then detailed the upcoming events from September through December, including Yellow Jacket Tailgating starting September 1<sup>st</sup>, Mother/Son Party planned for October 28<sup>th</sup>, the Senior Fishing Festival at Waterloo Lake Park on November 3<sup>rd</sup>, Denison On Ice beginning November 18<sup>th</sup>, and Wonders of Winter on December 8<sup>th</sup>. No Commission action was needed.

C. Receive a report and hold a discussion regarding programming and reservations at Waterloo Lake Regional Park.

#### **Commission Action**

Andrew Means, Recreation Manager, gave an update on the effected areas of Waterloo Lake Park by the Public Works sewer project, including the building, pavilion, boat ramp, kayak station, parking lot, and the pond. Kayak rental has been unavailable during the duration of the construction, and two of the fishing derbies were cancelled. Once the project is complete, Waterloo Lake Park will have a new concrete parking lot and boat ramp, as well as additional parking at the overlook area with ADA parking. The project will be complete before the Senior Fishing Festival on November 3<sup>rd</sup>. No Commission action was needed.

D. Receive a report and hold a discussion regarding staff updates and the new Parks and Recreation office location.

## **Commission Action**

Justin Eastwood, Director of Parks and Recreation, gave a report explaining the Parks and Recreation team is moving from City Hall to Old City Hall at 500 W. Chestnut, with the expected move being at the beginning of October. Mr. Eastwood also discussed two new staff members in the recreation department and a new aquatics maintenance coordinator at Waterloo Pool. No Commission action was needed.

E. Receive a report and hold a discussion regarding the shade structure at Jones Park.

#### Commission Action

Chip Egger, Park Administrative Superintendent, gave an update announcing the completed shade structure at Jones Park, showing visuals of the completed project. No Commission action was needed.

F. Receive a report and hold a discussion regarding the parking at THF Park.

#### **Commission Action**

Chip Egger, Park Administrative Superintendent, gave a report regarding the ongoing project of creating additional parking at THF Park. Mr. Egger showed a map that illustrated the location of the 50 new parking places and explained the addition of ADA parking spots. No Commission action was needed.

G. Receive a report and hold a discussion regarding Waterloo Pool.

#### **Commission Action**

Justin Eastwood, Director of Parks and Recreation, gave a report explaining the results of an assessment of the enclosure at Waterloo Pool by Huitt Zollars. The enclosure was deemed unsafe in winds stronger than 25mph due to erosion. City Council has voted to repair the enclosure and also gave direction on how to move forward regarding safely operating the pool during this time. The repairs will allow for a 20-year lifespan for the structure and will take roughly six to eight months to complete. The total cost is for the repair is \$2.4 million. At this time, staff is waiting to receive design option from Huitt Zollars. No Commission action was needed.

There being no further business to come before the Parks and Recreation Commission, the meeting adjourned at 2:03pm.
