#### I. Call to Order

Chair Matt Cyrus called the meeting to order at 5:32 p.m. Planning Commissioners present in person: Chair Matt Cyrus, Vice Chair Susan Altman, Kelsey Kelley, Jessica Kieras. Present via Zoom: Toni Williams, Mark Stockamp, Nathan Hovekamp. Staff present: Will Groves, Planning Manager, Nicole Mardell, Senior Planner, Stephanie Marshall, Senior Assistant Legal Counsel.

#### II. Approval of Minutes

The Planning Commission (PC) reviewed the minutes from the July 10, 2025, meeting.

Motion: Commissioner Kelley moved to approve the minutes. Vice Chair Altman seconded the motion.

Vote: The motion passed unanimously.

#### IV. Action Items

##### 1. Housing Panel Discussion

Presenter: Nicole Mardell

Nicole introduced a housing panel discussion addressing regional housing planning, which emerged from the PC's work plan development process. The panel included representatives from:

- Brent Bybee, Community Development Director, City of La Pine
- Brian Rankin, Senior Strategist, and Matt Stewart, Real Estate Director, City of Bend
- Morgan Greenwood, VP Government Affairs, Central Oregon Builders Association
- Ryan Kelling, Executive Director of Human Resources, Bend-La Pine Schools

The panel provided comprehensive information on housing supply status, construction constraints, and how cities plan for growth with housing. Key topics addressed included development trends, infrastructure challenges, affordability concerns and workforce housing needs across the region. Presentations and a

housing statistics handout are attached to these minutes. The housing statistics handout utilizes data provided by Cascades East Association of Realtors.

**2. Request to Review Hearings Officer Decisions**

**Presenter: Will Groves**

Will presented a request to review the Hearings Officer decision for cases 247-23-000302-DR and 247-25-000093-A. Staff explained that under current ordinances, the PC's quasi-judicial review authority was modified in 2000, limiting the Commission to recommending quasi-judicial review to the Board of County Commissioners rather than conducting such reviews directly.

Commissioner Kieras made a motion to schedule a work session to discuss the topic and better understand land use decisions. Commissioner Williams seconded the motion.

**Discussion:** The majority of Commissioners expressed interest in reviewing the cases to better understand land use decision processes. Commissioner Hovekamp expressed concern about setting precedent and indicated he would not participate if the Commission proceeded with review.

**Vote:** The motion passed with a majority aye vote.

Staff will prepare a presentation for the October meeting providing case history and procedural context for the Commission's educational review.

**V. Planning Commission and Staff Comments**

Staff provided updates on various ongoing projects and upcoming agenda items, including dark skies lighting amendments, Terrebonne community planning efforts, and the comprehensive plan reconsideration process. Commissioners expressed appreciation for the informative housing panel presentation.

**VI. Adjournment**

Chair Cyrus adjourned the meeting at 8:07 pm.
