#### I. Call to order

Chair Rachel Stemach call the meeting to order at 5:30 pm. Historic Landmarks Commissioners present in-person: Chair Stemach, Lily Syphers, Eli Ashley, Christine Horting-Jones and Marc Hudson. Commissioner present via Zoom: Lore Christopher, Vice Chair Schmidling. Staff present: Tanya Saltzman, Senior Planner and Will Groves, Planning Manager.

#### II. Approval of Minutes

Commissioner Syphers motioned to approve the minutes from August 5, 2024, Commissioner Ashley seconded. Minutes approved unanimously.

#### IV. Action Items

## 1. State Historic Preservation Office (SHPO) Presentation

- Presenter: Kuri Gill, SHPO Grants and Outreach Coordinator
- Summary: Kuri Gill Provided an overview of Oregon's historic preservation program and the Certified Local Government (CLG) program, emphasizing funding opportunities for surveys, public education, and rehabilitation of historic properties
- Commissioners inquired about the alignment of CLG projects with Deschutes County's priorities, and Gill confirmed that projects focusing on local preservation goals would be strongly supported by SHPO funding.

## 2. Guidelines and Recommendations for Wildfire Resiliency in Sisters

- Presenter: Emelia Shoup, Associate Planner, City of Sisters
- Summary: Shoup presented findings from the report, *Guidelines & Recommendations for Wildfire Resiliency of Historic Resources in Sisters*. The report, funded through a CLG grant, addressed the challenges of balancing wildfire mitigation measures with the preservation of historic architecture. Key recommendations included:

- Using fire-resistant materials such as fiber cement siding or masonry while retaining the Western Design Theme.
- Implementing defensible space standards by removing flammable vegetation and ensuring adequate building setbacks.
- Exploring innovative solutions like "shou sugi ban" (charred wood) for wooden cladding to maintain aesthetic integrity while improving fire resistance.
- Commissioners discussed potential applications of the guidelines to historic properties throughout Deschutes County and suggested a follow-up meeting to consider broader implementation.

## 3. Goal 5 Cultural Areas Rulemaking Update

- Presenter: Tanya Saltzman
- Summary: Saltzman provided an update on the Department of Land Conservation and Development (DLCD) Goal 5 rulemaking process, which aims to improve the identification and protection of culturally significant areas.
  - The draft rules outline processes for inventorying archaeological resources and cultural landscapes.
  - Public hearings were held in September and October 2024, with final hearing scheduled for December 2024.
- Commissioners expressed interest in how the rule changes would impact local historic preservation and discussed potential partnerships with tribal organizations to enhance resource inventories.

## 4. Subcommittee Roundup

- Reports:
  - **Cultural Resources Subcommittee**: Commissioner Hudson shared progress on identifying new sites for potential historic designation.
  - Wildfire and Preservation Subcommittee: Commissioners Ashley and Syphers discussed ways to disseminate information concerning wildfire resiliency and risk to the public, including potential property reviews by either staff or volunteers.
  - Public Awareness Subcommittee: Commissioner Syphers proposed a public education subcommittee for Preservation Month 2025. Potentially in place of the General Public Awareness subcommittee. This will be undertaken by Commissioners Stemach, Ashley and Syphers.

## 5. 2025-26 CLG Grant Discussion

- Facilitator: Tanya Saltzman, Senior Planner
- Summary: Staff initiated a brainstorming session for the upcoming CLG grant application cycle, including ideas such as:
  - Expanding the County's historic resources inventory.
  - Developing wildfire mitigation guidelines tailored to historic properties.
  - Hosting community workshops on preservation best practices.
  - Training opportunities for staff and commissioners.
- Commissioners will submit any CLG grant ideas to Tanya by December 18.
- A special HLC meeting is tentatively scheduled for January 6, 2025, to further discuss project ideas.
- The HLC will finalize the project list at their February 2025 meeting.
