7. PUBLIC HEARING: Dave Swisher Plan Amendment and Zone Change

Kyle Collins, Community Development Department Planner, presented the hearing outline and procedures. Hearing no conflicts of interest or bias, and no challenges or objections from the audience, Commissioner Adair opened the public hearing. Mr. Collins provided the staff report. Commissioner Adair opened the hearing for testimony.

Liz Fancher, via Zoom conference call, presented testimony as the applicant's (Dave Swisher) attorney. Presentation is attached to the record.

Carol MacBeth, staff attorney for Central Oregon Landwatch, presented via Zoom conference call. Ms. MacBeth commented on state law (OAR) regarding agricultural land.

Michael Mcomber, 63220 Silvis Road, via telephone on zoom conference call, presented a question and asked where the traffic would be routed for Silvis Road.

Ms. Fancher (rebuttal) provided clarification of identified concerns.

Mr. Collins presented the options for the Board to consider. Peter Gutowsky, Community Development Department Director commented on the urban growth boundary amendment process.

Upon no further testimony, Commissioner Adair closed the public hearing. Mr. Collins reviewed the next steps of the hearing process (Open record: 7-7-7). Commissioner Chang expressed interest in receiving water analysis data.

8. COVID19 Update

Health Services staff presented via Zoom conference call Nahad Sadr-Azodi, Dr. Rita Bacho, Emily Freeland, Crystal Sully, and St. Charles Health System Dr. Michael Johnson. Presentation is attached to the record. At this point in time, and pending further Board direction, the COVID19 update will be presented on a monthly basis.

Commissioner Chang recommended a strong public outreach regarding vaccinations and resources available to the community. Commissioner Adair stressed the importance of heart health with Valentine's Day approaching. Commissioner DeBone advocated for the culture of safety and considered whether to communicate to the Governor's office regarding dropping the face mask mandate. Commissioner Chang noted the range of protection with face masks and the Omicron variant and emphasized the value of wearing a face mask. Commissioner Chang return to his recommendation of having Deschutes County act as a role model to our county by providing incentives to employees to get vaccinated. Commissioner DeBone is not supportive; he prefers personal responsibility / decision making.

9. SD 391 / Rural ADU Update

10.FY 2022 Q3 Discretionary Grant Review

Administrative Analyst Laura Skundrick presented the Quarter 3 applications to the discretionary grant program. The Board approved various levels of support for the applications received.

11. Justice Court Discussion with Judge Fadely

Judge Charles Fadely presented the update for the Justice Court and reviewed case numbers. Handout is attached to the record. Commissioner Chang inquired on the impact of tourism on the justice court. Judge Fadely reported the file scanning project was completed. Commissioner DeBone commented on the service and value to the community.

OTHER ITEMS:

 Community Development Department Director Peter Gutowsky reported there is a vacancy on the Planning Commission. The recruitment period ended Friday and 12 applications were received. Commissioner DeBone would like to review the applications. Commissioner Chang offered to participate in the interview process. Commissioner Adair is interested as well. The applications will be shared with the Commissioners. Mr. Gutowsky and the chair of the Planning Commission will review the applicants, identify the top six candidates and arrange for interviews with two panels to

accommodate Commissioner Adair and Chang's interest in participation.

Mr. Gutowsky also reported that Jessica Kieras' position on the Planning
Commission has a term expiring June 30, 2022 and she has expressed
interest in a reappointment. Steve Swisher has completed his second term
for the Sisters County region with a term expiring June 30, 2022 and his
position will need to go through the recruitment process. Mr. Gutowsky will
provide the Commissioners contact information to Jessica Kieras for a
discussion on her request for reappointment. The Board supports a joint
Planning Commission/BOCC meeting in June. Discussion held on the CDD
work plan listing responsibilities and accomplishments of the Community
Development Department.
