## City Manager's Report.

**CITY MANAGER REPORT**

November 05, 2024

1. MDOT Projects –MDOT is working on the 4-way stop roundabout. The curbing is being installed. The West Bound acceleration lane has been completely removed and the contractor is currently working on the roadbed. Once complete, the area will be paved and reopened.
2. Park Ten Road – The contract is for 483 Calendar Days with a current end date of December 31<sup>st</sup>. The contractor has finished the sidewalk on the North side of the road. They will work on the south side next week and then be able to pave the roadway. Pavers, lights, and landscaping is also being completing.
3. Beaux Vue 2 – The contract end date for this project is December 4<sup>th</sup>. The contractor has completed the drain inlets and is currently completing the open ditch. The installation of the concrete mats will be completed this month.
4. Kaleki Way – The contractor is waiting on the updated plans from the engineer for the roadway repairs. I expect to present a change order for the total roadway repairs at the next meeting.
5. Noma Drive Phase 1b – The contract is for 180 Calendar Days with a current end date of January 7<sup>th</sup>. The change order on tonight's agenda is to add conduit and curbing around the parking lot area. This was not in the original contract as the city is building the parking area.
6. Turnberry Way – This project is for 120 days. The current end date is set for December 25, 2024. The contractor has completed the dredging of the detention pond. They have one final conflict box to install on the roadway. Once complete, the road can be reopened to traffic. The contractor expects to complete laying all pipe by the end of the week. The asphalt repair is scheduled within the next two weeks.
7. Kalae Street – The closeout walkthrough was conducted last week. A punch list was created, and the contractor is completing those items.
8. Hilo Master Drainage & Ahuli Place Drainage – The contractor has not started on these two projects.
9. Kome Drive & Kalipekona Pond – The project is out for bid.
10. Dog Park – We have sent the lease to Ochsner for their review. I received the legal description of the 1.32-acre property today. The existing design of the dog park will fit within the property.
11. Coon Branch – Additional survey work was needed to complete phase I of this project. The engineer will present the project at the December 17<sup>th</sup> council meeting and advertise the project in January.
12. Noma Drive Dredging – The bids are on the tonight's agenda for approval. Once approved, the notice to proceed will be issued.
13. Montjoy Creek – USACE needed additional information from the engineer. That has been provided to them and we are waiting for final permits to be issued. The project is being separated into three phases to ensure funding.
14. Canal Dredging –The engineer will request to advertise this project on the 19<sup>th</sup> of November. The project still has an expected start date of March/April 2025.



15. Jourdan River Boardwalk – DEQ wanted cross sections of the boardwalk to review. Once approved, the engineer will complete the final design. The engineer is working on the Tideland lease that is required and the final permits for this project.
16. Noma Drive Nature Trail – The engineer has determined the phase 1 site and will start the design and layout.
17. Detention Pond – The engineer will be completing the plans for this area by the end of the year. Public works will dredge this pond once plans are provided to the city.
18. Pelican Cove Drainage Project – Engineer has additional surveying to complete and will finalize the drawing for this project.
19. Unit Price Projects – Projects under the unit price contract are being designed by the city engineer. The Kiko Street design has been given to public works. The Kipapa Way project is still in the design phase. DH Drive East, Koko Court, Lanai Place, and Laa La Way, will utilize the unit price contract to complete. These projects are with the city engineer who is working on designs.

### Email Request Received

1. 7854 Maui Place – Councilmember contacted me about a sink hole forming and the ditch needing to be cleaned out to allow proper waterflow. A work order has been issued.
2. 698 / 6910 Aukai Place – Councilmember asked about the drainage ditch in this area needing to be addressed. A work order has been issued.
3. Bayou Circle – Councilmember asked for the median on Bayou Circle to be filled to prevent vehicles from receiving damage due to the drop off.
4. 579 Anoi Way – Resident is requesting front ditch to be cleaned as it is holding water. A work order has been issued.

6. Kaleki Way Drainage – Councilmember has asked several questions about the project. I will meet with the engineer to discuss each concern and have the issues addressed as needed.


