CITY MANAGER REPORT

September 03, 2024

- 1. <u>CRS</u> The City of Diamondhead has been accepted into the Community Rating System (CRS) Program. The preliminary results show that the city will improve from a Class 10 CRS rating to a Class 8 rating. This will allow residents to receive a 10% discount on qualified renewals and new flood insurance policies. The Class 8 rating will be effective April 1, 2025. I want to thank Beau King and the building department for all their hard work.
- 2. <u>MDOT Projects</u> –MDOT has started working on the 4-way stop roundabout. This will cause traffic delays and driver attention when traveling in this area. The ramp is currently scheduled to be completed by September 6th; weather depending.
- 3. <u>Park Ten Road</u> The contract is for 403 Calendar Days with a current end date of October 12th. The contractor is installing the curbing this week with the sidewalk, irrigation, and lighting being installed starting next week.
- 4. <u>Beaux Vue 2</u> The contract is for 60 Calendar Days with a current end date of September 5th. According to the engineer, the contractor has been having a problem getting the drain boxes for this project. The engineer has put forth a change order to add 90 days to this project. This will move the end date to December 5th. This is a no cost change order.
- 5. <u>Kaleki Way</u> The final inspection was conducted on Friday. A punch list was created for the contractor to complete. The substantial completion date for this project was to be September 10th.
- 6. Noma Drive Phase 1b The contract is for 180 Calendar Days with a current end date of January 7th. The contractor has installed the new boat ramp and has the pilings for the pier. The new bulkhead is being installed along the ramp to install the pier and sidewalk. The clearing for the comfort station and sidewalk will begin this month.
- 7. <u>Substation/Veterans Drainage Project</u> Project was started and completed by SCI. The closeout documents and payment will be on the next agenda.
- 8. <u>Kolo Court</u> Contractor has indicated they will begin this project. This project is for 60 days. The current end date is set for October 26, 2024. It will require Bayou Drive to be closed once again to replace the culvert near the OpLa Way intersection of Bayou Drive. The residents will have to use the Bayou Place/Kapalama access road while the road is closed. Notice was e-blasted to residents and signage is being installed.
- 9. <u>Turnberry Way</u> This project is for 120 days. The current end date is set for December 25, 2024. The contractor has indicated they will begin dredging the pond at #4 Cardinal. This will give them time to stage all the other needed materials. This project will require the entire roadway of Turnberry Drive to be removed to install the drainage culverts. Residents will receive notices as work proceeds.
- 10. <u>Hilo Master Drainage</u> This contract is for 150 days. The current end date for this project is January 24, 2025. There are 4 sub-projects included within this contract. The contractor has not indicated at which location they will start. The city is currently waiting on a schedule for this project.

- 11. <u>Ahuli Place Drainage</u> The contract for this project is for 120 days, with a current end date of December 25, 2024.
- 12. Kalae Street This project is for 90 days, with a current end date of November 25, 2024.
- 13. <u>Coon Branch</u> The engineer if developing the preliminary design for the project and will be sending me the first draft this month.
- 14. <u>Noma Drive Dredging</u> The bids for this project are due on October 1st. If within the approved budget, we will have it on the October 15th meeting for review and approval.
- 15. <u>Jourdan River Boardwalk</u> We have our monthly check in meeting scheduled for next week. The permitting phase is progressing with all applications submitted. The engineer is working on the final design of the project.
- 16. <u>Dog Park</u> The deed has been given to the chancery clerk to be recorded. I have a meeting scheduled for next week with Ochsner to discuss the property.
- 17. <u>Boy Scouts</u> I have been informed that the scouts will be using the East Hancock Library and the Hancock County Kiln Shelter.
- 18. <u>Montjoy Creek</u> No updated information this meeting. The engineer is waiting for the final permits to allow the project to go out for bid.
- 19. <u>Detention Ponds</u> No updated information this meeting. Engineer has completed design on this project and will provide them to public works to complete the dredging.
- 20. <u>Kome Drive</u> No updated information this meeting. This will be to address driveway and landscape culverts on Kome Drive.
- 21. <u>Kalipekona Pond</u> -- No updated information this meeting. This project will dredge the south end of the pond to remove sediment.
- 22. <u>Pelican Cove Drainage Project</u> No updated information this meeting. Engineer has been provided with the work assignment and will begin the surveying on this project.
- 23. <u>Noma Drive Nature Trail</u> No updated information this meeting. The engineer presented the project to the council tonight.
- 24. <u>Canal Dredging</u> No updated information this meeting. Contacted MDEQ regarding the grant agreement. They are still drafting the agreement but expect it to be delivered within two to three weeks. Once received, it will be placed on the agenda for approval. The construction schedule is set to start in March/April of 2025 provided the city receives funding as anticipated

- 1. <u>7854 Maui Place</u> Councilmember contacted me about a sink hole forming and the ditch needing to be cleaned out to allow proper waterflow. A work order has been issued.
- 2. <u>7816 Koko Ct</u> Councilmember asked about this address and the ditch erosion in the area. Public Works has been to the site. The city engineer is surveying the area to determine proper slope for public works to shape the drainage ditch.
- 3. <u>7446 Turnberry Drive</u> Councilmember asked to put rip rap to stabilize ditch bank and prevent the erosion. A work order has been issued.
- 4. <u>698 / 6910 Aukai Place</u> Councilmember asked about the drainage ditch in this area needing to be addressed. A work order has been issued.

- 5. <u>Road Delineators</u> Several road delineators have broken. Public works has been informed and will replace as needed.
- 6. <u>6926 Hilo Way</u> Compliance concern with vehicles and boat on property. Code enforcement has been informed.
- 7. <u>Bayou Circle</u> Councilmember asked for the median on Bayou Circle to be filled to prevent vehicles from receiving damage due to the drop off.
- 8. <u>Moanalua Way</u> Councilmember asked about tree debris left by Asplundh Tree Service. The city contacted the company, and they removed the debris the next day.
- 9. <u>84110 OpLa Way</u> Compliance concern of cars parked in the road and property not being kept. Code enforcement with the site, no evidence of cars in the road and grass was cut.
- 10. <u>The Oaks and Noma Drive Ditches</u> The Oaks HOA asked about ditches in the Oaks and along Noma Drive. Public works mowed the ditches as per their schedule. The director noted that the work the previous week was not adequate and he would address this with this crew.
