## CITY MANAGER REPORT

July 02, 2024

- 1. Park Ten Road The contract is for 309 Calendar Days with a current end date of July 10<sup>th</sup>. The change order on tonight's agenda is requesting an additional 94 days. This will extend the contract to 403 days with a new end date of October 12, 2024. This additional time is needed due to weather delays, but also due to utility conflicts that were beyond the contractor's control.
- 2. <u>Beaux Vue 2</u> The contractor's change order for this project is on the agenda tonight. A notice to proceed date of July 8<sup>th</sup> has been set.
- 3. <u>Kaleki Way</u> The contract is for 120 days with an end date of August 6<sup>th</sup>. The contractor is completing the work on this project. The contractor will be working on final grading and hydroseeding over the next few weeks.
- 4. <u>Bayou Drive</u> –The project is for 90 days with an end date of August 4<sup>th</sup>. The road work is complete. The final details of the project are being addressed by the contractor.
- 5. Noma Drive Phase 1b The notice to proceed date has been set for July 8th.
- 6. <u>Gex Drive Lighting</u> –The contractor is installing the base for the lighting and all underground wiring.
- 7. <u>Drainage Projects</u> All ARPA bids have been received. They are currently under review by the engineers.
- 8. <u>Canal Dredging</u> The engineer presented the project to the council tonight. We have a conference call with MDEQ to discuss the construction schedule this week.
- 9. Noma Drive Boardwalk The engineer presented the project to the council tonight.
- 10. Montjoy Creek The engineer presented the project to the council tonight.
- 11.  $\underline{\text{Coon Branch}}$  The engineer will present the initial design at the July  $2^{nd}$  council meeting for these four GOMESA projects.
- 12. Noma Drive Nature Trail The engineer presented the project to the council tonight.
- 13. <u>CRS</u> Beau has been collecting the documents needed, and we have added an information page to the city's website. We have our onsite meeting scheduled for July 17<sup>th</sup>.

- 16. <u>Fireworks Event</u> I want to thank everyone that attended the event. It was a great turn out. I also want to thank public works and my office staff for all their hard work. Lastly, I would like to thank the DH School of Fine Arts for their participation at the event; the Silver Slipper for donating the stage, as well as VFW Post 2880 and Boy Scout Troop 210 for presenting the colors.
- 17. P&Z Update Pat will provide an update from the P&Z department.
- 18. <u>Dog Park</u> No updated information this meeting. The county plans to have the survey finished in advance of the BOS's July meeting wherein approval to submit the subdivision application to the

- City of Diamondhead will be obtained. The subdivision application and supporting documentation will then come to the City for the various approvals.
- 19. <u>Detention Ponds</u> No updated information this meeting. Engineer has completed design on this project and will provide them to public works to complete the dredging.
- 20. <u>Kome Drive</u> No updated information this meeting. This will be to address driveway and landscape culverts on Kome Drive.
- 21. <u>Kalipekona Pond</u> -- No updated information this meeting. This project will dredge the south end of the pond to remove sediment.
- 22. <u>Pelican Cove Drainage Project</u> No updated information this meeting. Engineer has been provided with the work assignment and will begin the surveying on this project.
