#### **CITY MANAGER REPORT**

June 17, 2025

- Kome Drive & Kalipekona Pond The project is for 157 days with a current end date of July 17<sup>th</sup>. A walkthrough is scheduled for this week on the Kome Drive portion of the project. The contractor has one junction box that needed to be lowered. The dredging of Kalipekona Pond is continuing. If you see excessive mud/dirt on the roadway, please let me know. Due to the rain, the contractor is working weekends when the weather permits.
- 2. <u>MDOT Projects</u> The work on the final ramp has an updated completion date of June 27<sup>th</sup>. The contractor is currently paving the ramp and will start the South roundabout. Lane shifts and delays are expected in this area.

- 3. <u>Dog Park</u> The engineers have provided a drainage plan for the area. Public Works will start clearing the area to reroute the ditch as designed. The engineering firm is completing the updated drawings. Public works will continue clearing the site in preparation for construction.
- 4. <u>Paving 2025</u> The project has a start date of June 23<sup>rd</sup>. Project is 90 days with a current end date of September 21<sup>st</sup>. All required paperwork has been received from the contractor. Also, a road paving schedule was issued. Residents have been contacted.
- 5. <u>Canal Dredging</u> The updated bid documents have been provided to MDEQ for their review. I am asking for permission to advertise on tonight's agenda once we receive final approval.
- 6. <u>Jourdan River Boardwalk</u> MDEQ is waiting on the lighting portion of the plans to complete the review of the final drawings. Once approved, bid documents will be prepared.
- 7. <u>Montjoy Creek</u> The engineer has sent the revised plans to MS DMR/USACE with the sediment trap updates. They are also working on an updated OPC.
- 8. <u>HMGP</u> Hazard Mitigation Grant Program
  - a. The generator project has been approved by FEMA. It is on tonight's agenda for your approval along with permission to advertise. The state is currently requesting a Period of Performance extension to add time to the disaster declaration to allow enough time for the city to complete the project.
  - b. Rostan is contacting the residents to start the process of property acquisition. All expenses will be a passthrough for the city.
- 9. <u>Coon Branch</u> The project start date was Monday. The weather has delayed the contractor Project is 180 days with a current end date of December 13<sup>th</sup>.
- 10. <u>Bank Stabilization</u> No update on this meeting. The engineers are finalizing the analysis on the Phase 1 design. Phase one will cover the area from Diamondhead Drive North to Kalipekona Pond. The rear ditch will require additional easement for access.





WHEREAS, the City Council of the City of Diamondhead further find, determine and adjudicate that advertisement for bids or obtaining quotes to clean the above referenced property should be made in the form and manner as provided by law; and

WHEREAS, the City Council further find, determine, and adjudicate that the cost of the lot cleanup shall not exceed the aggregate amount of \$20,000.00 per parcel per calendar year or the fair market value of the property subsequent to removal, whichever is less. Said amount including a penalty shall be assessed as a lien against said property as provided by law and shall be enrolled in the office of the Circuit Clerk of Hancock County, Mississippi, as other judgments are enrolled, and in the office of the Chancery Clerk of Hancock County, Mississippi; and

WHEREAS, the City Council of the City of Diamondhead further find, determine, and grant authority to the Building Department to re-enter the properties for a period of two (2) years without any further hearings if notice is posted on these properties and at City Hall, 5000 Diamondhead Circle, Diamondhead, Mississippi 39525, at least seven (7) days prior to re-entering the properties for resolution of the same type of violation.

**SECTION 5.** That the Council of the City of Diamondhead further find, determine, and hereby grant authority to the Building Department to re-enter the properties not more than five (5)
