City Manager's Report.

- 1. <u>Lily Pond and I-10 Pond</u> The contractor has completed the dredging and erosion control measures of Lily Pond. The I-10 pond dredging will continue until the end of the month. The current end date for the contract is July 17th.
- 2. <u>Noma Drive Ballfields</u> The POA has approved to lease the ballfields on Noma Drive to the city for the next ten years. I have asked the City Attorney to work with the POA attorney to draft a contract for approval.
- 3. <u>Yellow House</u> I have asked legal counsel to pursue what means the city can do to designate this home as blighted property.
- 4. <u>Park Ten Road</u> No change to this project. The city is still finalizing easements needed and MDEQ permits. Once everything is in order, the engineer will advertise the project.

- 5. <u>Phase 4 paving</u> The paving project is currently demobilized until the area around Bayou Circle is available to complete the project. The current end date of the project is June 30, 2023.
- 6. <u>Diamondhead Drive Paving</u> The engineering firm provided 100% drawings to the city last week. They have been sent to the City Engineer, Orion Planning and DWSD for review. As the city receives comments back, they will be passed along to the engineering firm for review and updates.
- 7. <u>Coon Branch/Koloa/Lots 7 & 8 Drainage Projects</u> The engineer has started survey work on these three projects in the area. GOMESA funds are being used for this project.
- 8. <u>Drainage Projects</u> At least 15 additional drainage projects have been funded with GOMESA and ARPA funds. The city is currently waiting for grant agreements for these funds to start these projects.
- 9. <u>Makiki Drive</u> The water line installation and debris removal has been completed by the Bottom 2 Top company. The City Engineer is developing the specifications. Once we have them and the OPC (Opinion of Probable Cost), we will proceed with securing a contractor to complete the job.

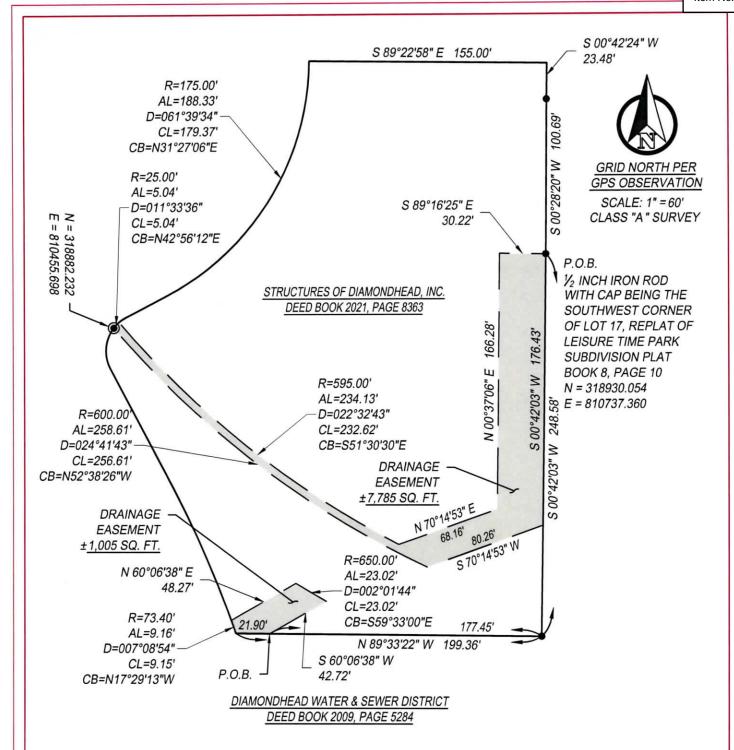

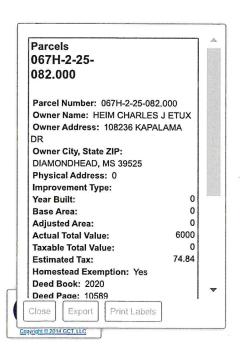

AMENDMENT FOR EMPLOYEE HANDBOOK

The following language is suggested as an amendment to <u>Section 113. Compensation</u>. <u>Public Works – On Call Policy:</u>

Public Works employees may be called out after hours (hours outside of the normal 8-hour, Monday-Friday daily schedule), for required inspection, service, and repairs.

The Public Works on-call employees shall be credited two (2) hours comp time, each weekday, for being on call, with a two (2) hour minimum for call out (at one and a half times their hourly rate, comp or paid, at employee's discretion).

The Public Works on-call employees shall be credited four (4) hours comp time, each weekend day, for being on call, with a two (2) hour minimum for call out (at one and a half times their hourly rate, comp or paid, at employee's discretion).

Time credited begins at the time the Public Works employee is on City property (building, vehicle, etc.), until leaving City property. The employee is required to record time on the employee's timesheet. Any and all after-hours time must be approved by the Public Works Director and detailed on the timesheet, including any and all backup documentation of the emergency call-out. It is the Public Works Director's responsibility to verify who and what after hour emergencies were made and that it is documented properly before turning timesheets in to the Payroll Department.
