CITY OF DILLINGHAM, ALASKA RESOLUTION NO. 2025-32

A RESOLUTION OF THE DILLINGHAM CITY COUNCIL AUTHORIZING THE MAYOR TO EXECUTE APPOINTMENT OF THE DEPUTY CITY MANAGER AS ACTING CITY MANAGER.

WHEREAS, under Dillingham Municipal Code (DMC) Chapter 2.21, the City Manager is appointed based on executive and administrative qualifications, with reference to education, training, and experience; and

WHEREAS, DMC 2.21.030 provides that the City Council may appoint a City Manager—or Acting City Manager—consistent with such qualifications; and

WHEREAS, at its regular meeting on August 7, 2025, the City Council terminated the previous City Manager's contract without cause; and

WHEREAS, the previous City Manager's last day was August 8, 2025; and

WHEREAS, the City Council appointed Deputy City Manager Jack Savo Jr. to serve as Acting City Manager until the next special meeting of the Council; and

WHEREAS, the Council now wishes to formally continue the appointment of Jack Savo Jr. as Acting City Manager until otherwise directed by the Council;

NOW, THEREFORE, BE IT RESOLVED by the Dillingham City Council:

- Appointment: Deputy City Manager Jack Savo Jr. is hereby appointed as Acting City Manager, with full authority and responsibilities of the office, pursuant to DMC Chapter 2.21.
- 2. Term: This appointment is temporary and may be modified or revoked by the City Council at any time.
- 3. Effective Date: This resolution is effective immediately upon adoption.
