CANVASSING COMMITTEE MEETING MINUTES

A meeting of the Canvassing Committee was held on Thursday, October 7, 2021, in the City Council Chambers.

1. CALL TO ORDER

Precinct Chair Pat Walsh called the meeting to order at 12:19 p.m.

2. ROLL CALL

3. APPROVAL OF AGENDA

MOTION:

Denise Lisac moved, and Curt Armstrong seconded the motion to approve the

agenda.

VOTE:

The motion passed unanimously by consent.

4. SPECIAL BUSINESS

DMC 3.70.030, Record of canvass, states the minutes shall indicate the disposition of all questioned, absentee, write-in and voided ballots.

(Clerk Note: All valid/accepted ballot types are set to the side and opened at the same time. The ballots are shuffled before they are counted.)

a. Review Mismarked Ballot

There were no mismarked ballots:

Review Questioned Ballots

Pat Walsh referred to the Question Verification Voter form with comments provided by the State of Alaska, Division of Elections, and Region IV office. A review was made on each of the eleven questioned ballots received. After the review, seven ballots were determined to be eligible having met the Dillingham Municipal Code voter qualifications as outlined in DMC 3.10.020.

MOTION:

Curt Armstrong moved, and Denis Lisac seconded the motion to accept ballots 1, 3, 7, 8, 10, 11, and 12, and reject ballots 2, 4, 5, and 9 on the questioned ballot register.

It was noted line 6 on the Questioned Ballot Register has no voter information.

VOTE: The motion passed unanimously by consent.

c. Review Absentee Ballots

1) Absentee Voting In-Person Ballots

Fifty absentee in-person ballots were submitted. The City Clerk reviewed the Absentee In-Person Register List, verified all were registered voters with residence listed in Dillingham. The committee members were asked to comment on whether or not they questioned the residency of any one individual, no comments were received.

MOTION:

Denise Lisac moved, and Curt Armstrong seconded the motion to accept all

fifty of the absentee voting in-person ballots.

VOTE:

The motion passed unanimously by consent.

Absentee Voting by Personal Representative Ballots / Special Needs 2)

Nine Special Needs ballots were submitted. The City Clerk reviewed the Special Needs Register List, verified all were registered voters with residence listed in Dillingham. The committee members were asked to comment on whether or not they questioned voter qualification of any one individual, no comments were received.

MOTION:

Curt Armstrong moved, and Denise Lisac seconded the motion to accept all nine of the voting by Personal Representative / Special Needs Ballots.

VOTE:

The motion passed unanimously by consent.

3) Absentee Voting By Mail Ballots

Four Absentee By-Mail Ballots were sent by certified mail. Two Absentee By-Mail Ballots were received on or before the October 5, 2021 election. The City Clerk reviewed the Absentee by-Mail List, verified all were registered voters with residence listed in Dillingham. Further requirement per Dillingham Municipal Code 3.70.020 B:

B. Questioned and absentee ballots shall be counted as follows: No ballot shall be counted if the voter has failed to properly execute the certificate or if the witness, officer or other person authorized by law to administer the oath fails to affix his/her signature.

After a review, two ballots were determined to be eligible as they met all Dillingham Municipal Code election qualifications.

MOTION:

Denise Lisac moved, and Curt Armstrong seconded the motion to accept the

two absentee by-mail ballots that met all qualifications.

VOTE:

The motion passed unanimously by consent.

d. Review Write-in and Voided Ballots

Write In ballots:

There was one letters of intent received prior to the election for write-in candidates.

Voided (spoiled) ballots:

There were no voided (spoiled) ballots.

e. Tally Accepted Ballots

The Canvass Committee identified a total of 68 accepted absentee / special needs / questioned ballots. Pat Walsh oversaw the opening of the accepted ballot envelopes that were set aside, the privacy sleeves removed, and the ballots placed on the table and verified a count of 68. The ballots were removed from the privacy sleeve, and a recount was made to verify there were a total of 68 ballots.

The Committee determined to make a hand count of the absentee, personal representative, and questioned ballots, with one member reading the ballot, one watching while the ballot was read, two member tallying the votes.

The ballot results were read aloud by Pat Walsh, confirmed by the Canvass Committee, and entered on the Certification of the Canvassing Committee Report/Official Tally Report.

f. Approve the Official Tally Report (Clerk Note: The Official Tally Report and the minutes of the Oct. 7, 2021 Canvassing Committee meeting will be presented at a Special Council Meeting, October 14, 2021 to certify the election.)

MOTION: Denise Lisac moved and Pat Walsh seconded the motion to approve the Official Tally Report.
