CITY OF DILLINGHAM, ALASKA Resolution No. 2024-21

A RESOLUTION OF THE CITY COUNCIL OF DILLINGHAM, ALASKA APPROVAL OF APPOINTMENT OF TRACY O'MALLY AS CHIEF OF POLICE

WHEREAS, the City of Dillingham Alaska operates under the provisions of DMC 2.44.010, which mandates the establishment of a public safety department with public safety responsibilities, the head of which may be the chief of police, appointed by the City Manager, with the concurrence of the City Council, for an indefinite term and removable by the City Manager; and

WHEREAS, Tracy O'Malley has been nominated by the City Manager for the position of Chief of Police, subject to the approval of the City Council, based on the recommendation of the hiring committee;

NOW, THEREFORE, BE IT RESOLVED by the City Council of Dillingham, Alaska, as follows:

Section 1: Appointment Approval

The City Council hereby approves the appointment of Tracy O'Malley as the Chief of Police for the City of Dillingham, Alaska.

Section 2: Compliance with DMC 2.44.010

This appointment is made in accordance with the provisions of DMC 2.44.010, which authorize the City Manager, with the concurrence of the City Council, to appoint the chief of police as the head of the public safety department.

Section 3: Hiring Committee Recommendation

The City Council acknowledges and accepts the recommendation of the hiring committee, consisting of representatives from SAFE, Bristol Bay Area Health Corporation, the Fire Department, the Dillingham City Council, and an At Large Community Member, in selecting Tracy O'Malley for the position of Chief of Police.
