Purpose of submittal: Request Design Review Board approval for a prefabricated accessory storage shed to provide secure storage for Chamber equipment, event supplies, seasonal decorations, signage, and related materials.

1. Project Narrative

The Dodgeville Area Chamber of Commerce requests Design Review Board approval to install one prefabricated outdoor storage shed at 338 N Iowa Street. The shed will be used for accessory storage only and will not include plumbing, living space, public occupancy, or new signage.

The proposed structure is a Lifetime Resin Outdoor 8' x 17.5' Storage Shed, model 60352. The product is a factory-manufactured resin storage shed with a neutral gray exterior, darker roof, double doors, screened vents, skylights, and steel-reinforced framing.

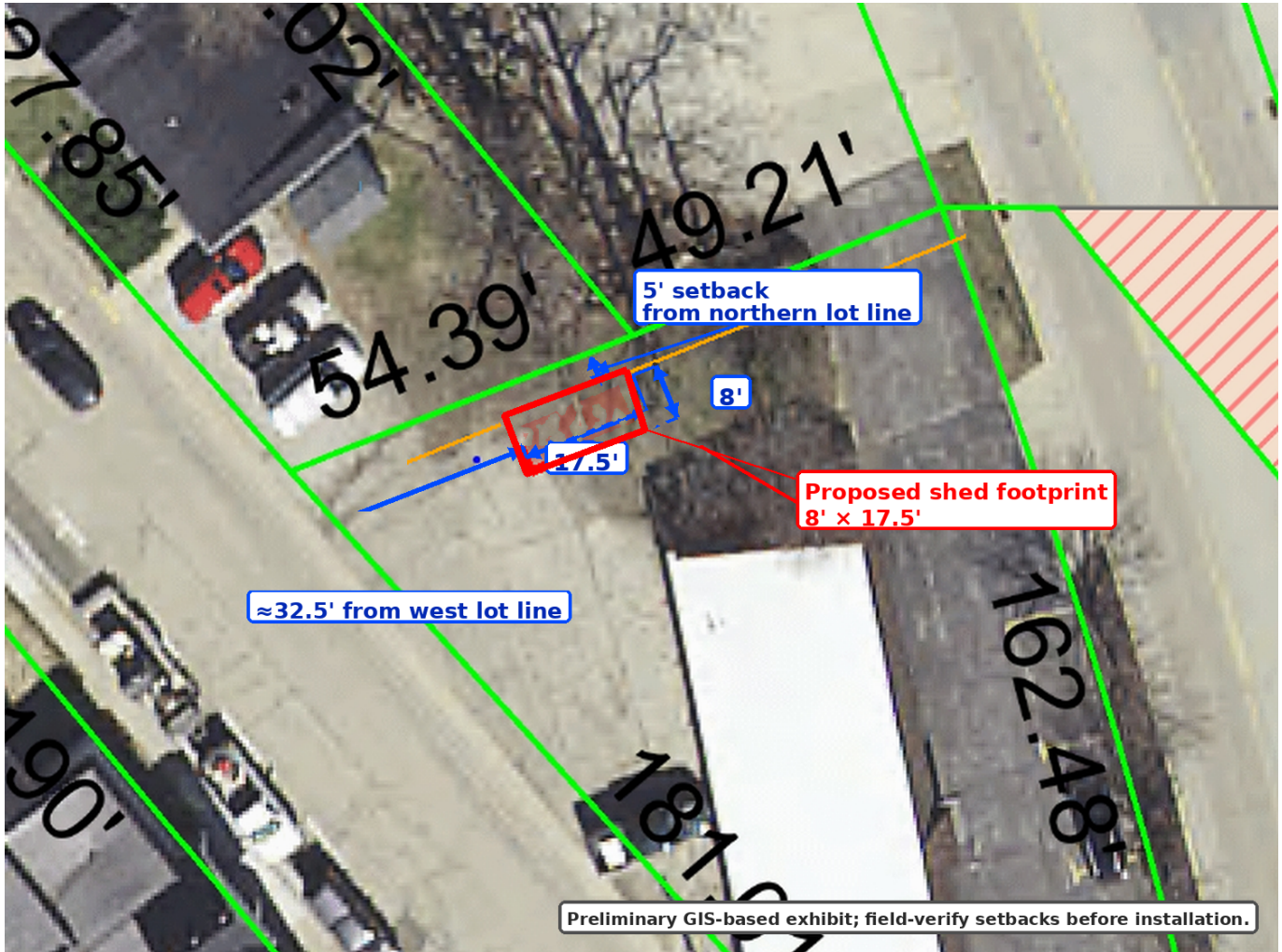
3. Proposed Shed Placement

The proposed shed is shown in the site exhibits that follow. The footprint is depicted as an 8' x 17.5' rectangle placed parallel to the northern lot line. The long 17.5' side runs parallel to the northern parcel line while maintaining a 5' setback. The northeast shed corner is located approximately 50' from the northwest parcel corner when measured along the northern parcel line, producing an approximate 32.5' distance from the northwest parcel corner to the west edge of the shed footprint.

Distance along northern lot line	Approx. 50' from NW parcel corner to NE shed corner
Distance to west edge of shed	Approx. 32.5' from NW parcel corner to west/front edge of shed
Footprint	8' x 17.5'
Orientation	Long side parallel to northern lot line
Verification	Final placement and setbacks to be field-verified before installation

The northern lot-line distance used for placement is approximately 103.6' based on the GIS aerial measurements shown as 54.39' + 49.21' on the neighboring parcel line labels.

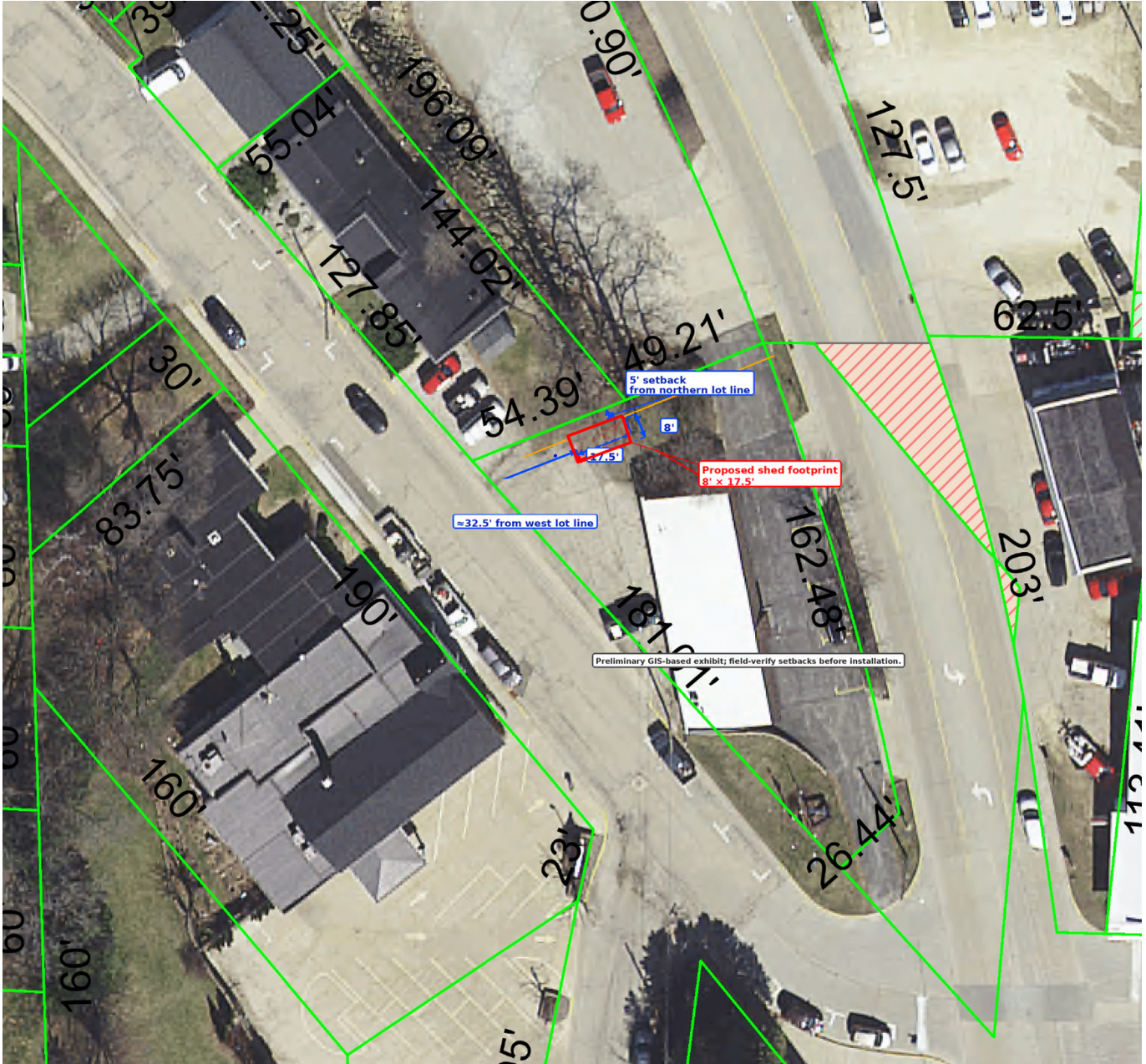
Exhibit A - Proposed Shed Placement with Dimensions

The manufacturer instructions specify a level platform before assembly. For concrete platforms, the instructions state that concrete should be approximately 4" thick and that the actual shed dimensions at the widest and longest points are 96" x 210". The floor/platform dimensions are smaller than the roof, with a level surface of 93 1/2" x 208" identified in the instructions.

6. Installation, Maintenance, and Review Notes

Installation: The shed will be installed on a level base/platform using PT Ground Contact lumber in accordance with manufacturer instructions and applicable City requirements.

Maintenance: The polyethylene panels are stain and solvent resistant. Most stains can be removed with mild soap and soft-bristled brush, and abrasive cleaning materials are not recommended.

Design review note: The proposed shed is intended to improve site organization by consolidating Chamber materials in an enclosed accessory structure. No new signage, exterior lighting, or occupancy is proposed as part of this request.

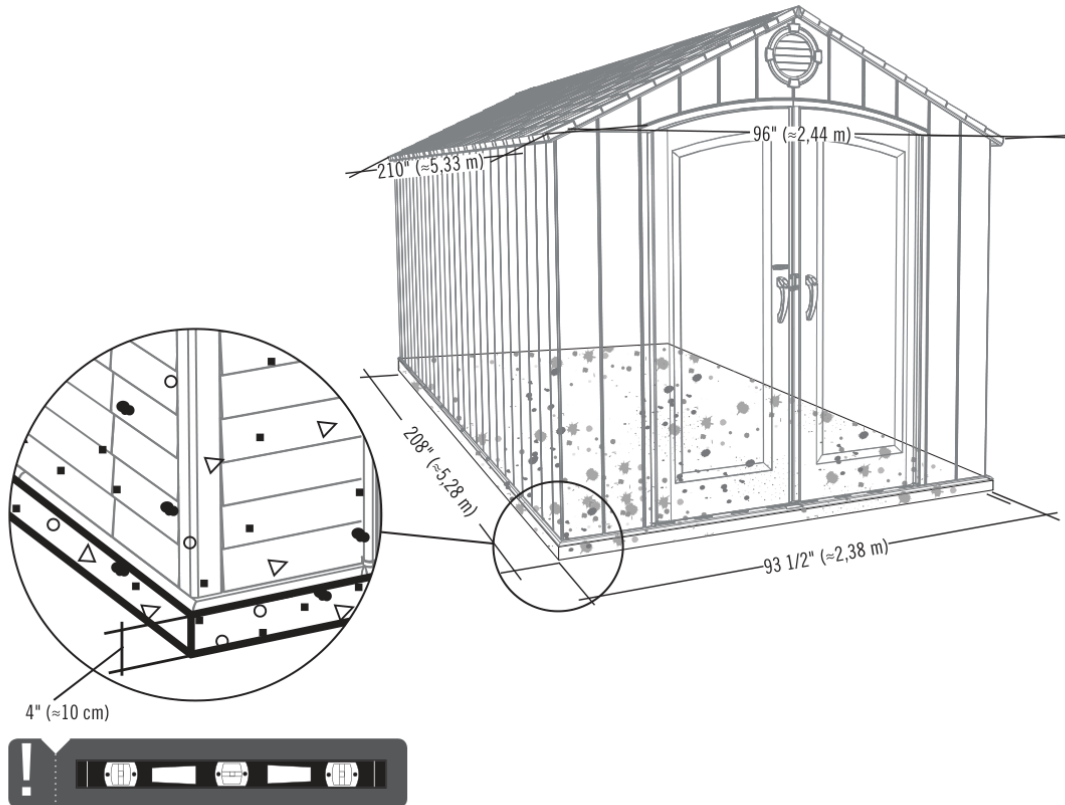

- The concrete should be approximately 4" (≈10 cm) thick. The actual dimensions of the shed, at its widest and longest points, are 96" x 210" (≈2,44 m x 5,33 m). Ensure you select a site that will accommodate these measurements. **The floor dimensions are a bit smaller than those of the roof; therefore, you will need to build a level surface of 93 1/2" x 208" (≈2,38 m x 5,28 m).**

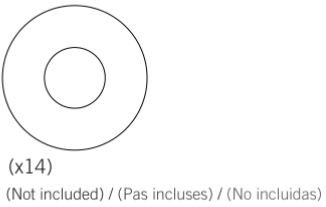
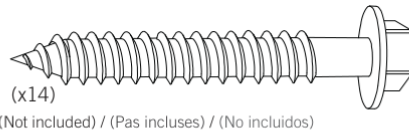
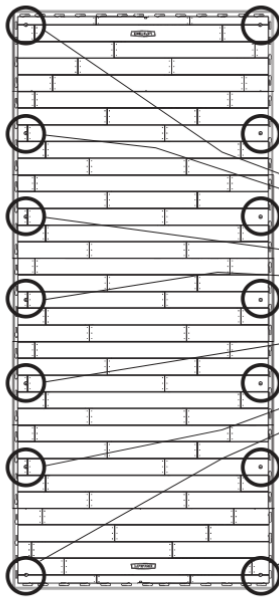

- To anchor your shed, you must purchase the correct anchoring hardware. **For a concrete platform**, we recommend using a hammer drill, 5/16" (8 mm) masonry bit, fourteen (14) 3/8" x 2" (10 mm x 5 cm) Concrete Screws and fourteen (14) 3/8" x 1" (10 mm x (2,5 cm) Fender Washers. **Do not exceed a 3/8" diameter screw. Refer to your local hardware store for this hardware.**
