### I. CALL TO ORDER AND ROLL CALL

The meeting was called to order by Mayor Hottmann at 9:05am. Members Present: Barry Hottmann, Julie Johnson-Solberg, Jeremy Mulder (Maintenance), Grace Gervasi (Finance/HR), Danielle Reddell (Utility clerk) Megan James (Rec Director), Emily Wolfe (Deputy Clerk/Treasurer). Members absent: Tom DeVoss, Jeff "Potsie" Weber, Dylan Wadzinski (DPW).

2. Discussion of additional costs related to the project

He also provided information on bids from TC Networks for completing the installation of cameras, etc, and from Vierbicher for the construction of new parking lot, landscaping, etc at the new City Hall location. At this time, Mayor Hottmann stated that he is still waiting a quote from Pieper Electric on the installation of electric and network wiring.

A couple of committee members asked Mayor Hottmann if the drive-thru originally planned for residents to drop of utility bills, absentee ballots, etc. could be put on the back burner for now, to allow that money to maybe put forward and used to help cover furniture costs, etc.

Mayor Hottmann also suggested to the committee that maybe city staff could use what furniture is already in existence at the current city hall to be placed in offices at the new admin building, with new furniture being added at a later date.

Another topic brought forth for discussion was signage out front of the new admin building. A couple of suggestions passed around were maybe using an illuminated sign, where the city would not only post their hours, etc, but also use it to post meeting dates, etc.

During this meeting, Danielle Reddell, who has been having the start up conversations to gather bids from movers stated that there is another moving company (owner former Dodgeville resident) that she had not yet heard of regarding a bid for moving, but would be interested in helping the city move locations, due to being from Dodgeville originally.
