The meeting was called to order by Mayor Hottmann at 5:30pm. Members present: Shaun Sersch, Roxanne Reynolds-Lair, Tom DeVoss, Jeff “Potsie” Weber, Mike Olson, Jerry Johnson, Julie Johnson-Solberg, Larry Tremelling.

6. Police Report

Chief Wilhelm reports there were 138 service calls in June.

Since the Cybersecurity incident at Iowa County in April 2025, the Dodgeville Police Department’s systems are slowly starting to get back in sync with the county information, but there is still a long ways to go.

Several events are happening within the City. One of those events include the Mineral Point 4th of July celebration, in which 2 of Dodgeville Police Department’s officers will be assisting for this event, and in turn, Mineral Point will send 2 of their officers to help cover for Farmers Appreciation.

Chief Wilhelm notes that there may be some road construction on exit 47 for the Farmer’s Appreciation parade and other events, however, Chief Wilhelm had not

heard for sure on how this would affect the City. He will update with more information as he learns more.

8. Mayor Report

Mayor Hottmann reports that the groundbreaking for the Dodgeville Public Library was held on Thursday, June 26th. Several compliments during this groundbreaking by the project manager at Daniels Construction.

Mayor Hottmann reports that in a recent conversation he had with Library Director Carrie Portz, there has been an increase of foot traffic at the Annex since the closure of the library.

Mayor Hottmann reports that Ryan Lindsey (Building Inspector) has been very busy with projects.

9. Discussion and possible action on 2025 Utilities FMP, presentation by Ehlers.

Brian Raemer, representative from Ehlers, gave a presentation surrounding the 2025 Utilities Financial Management Plan. During this presentation, Raemer gave suggestions to the council on the best ways to increase funding in both the water and sewer funds. Raemer's suggested proposal to the council included biennial Simplified Rates Cases for water, and also included biennial inflationary adjustments for sewer. A packet of information from Ehlers was attached to the 7/1/25 agenda, which detailed how these biennial Simplified Rate Case scenarios would affect utility customer rates for utility bills.

Mayor Hottmann gave an update on the 2025 Insurance renewal through the League of WI Municipalities. In addition to the original policy, Mayor Hottmann added a \$1million cybersecurity policy, which yielded at \$5,000 deductible. Motion by DeVoss, Second by Sersch to approve the 2025 League of WI Municipalities Insurance Renewal Proposal. Roll call vote 8-0.

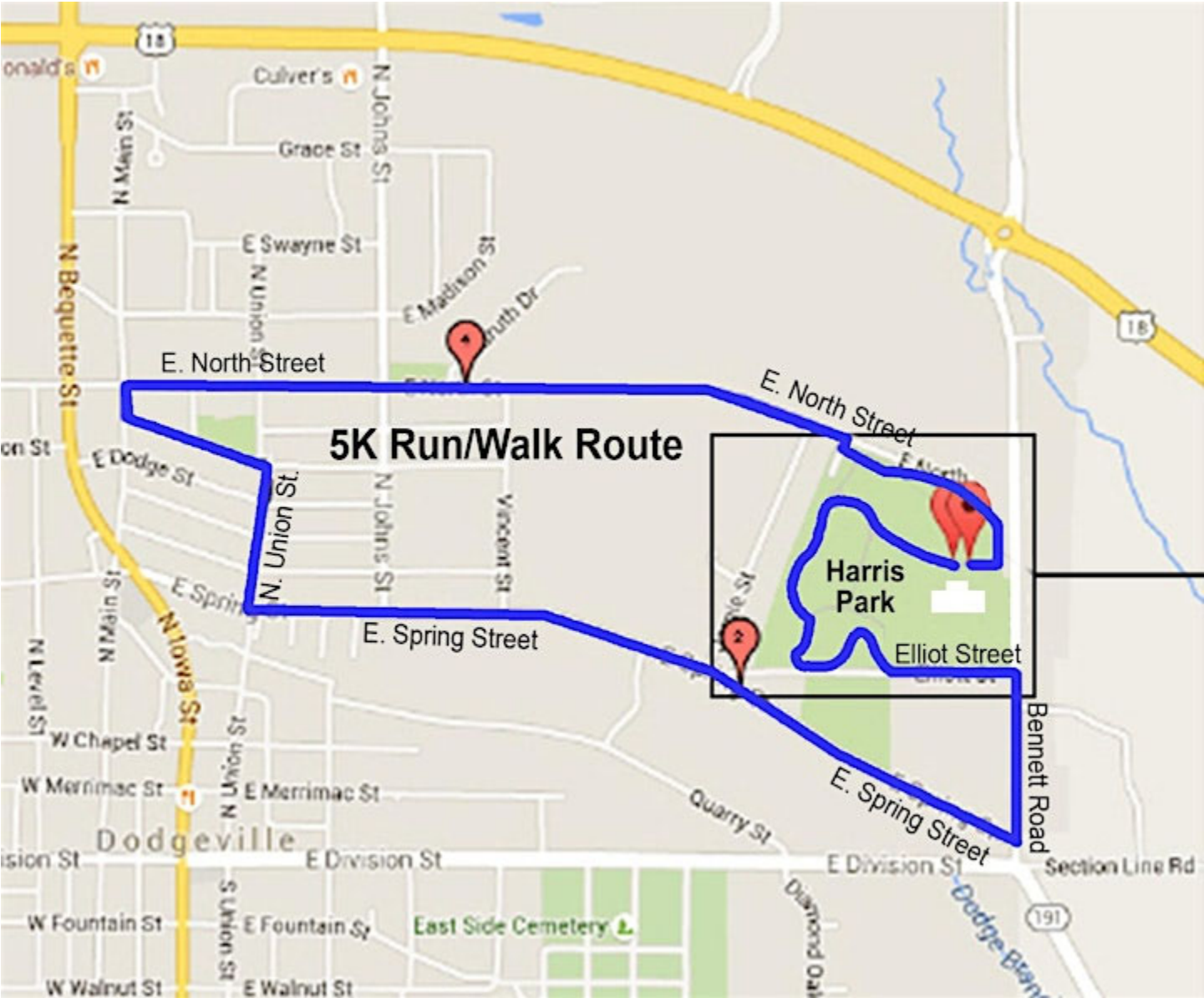

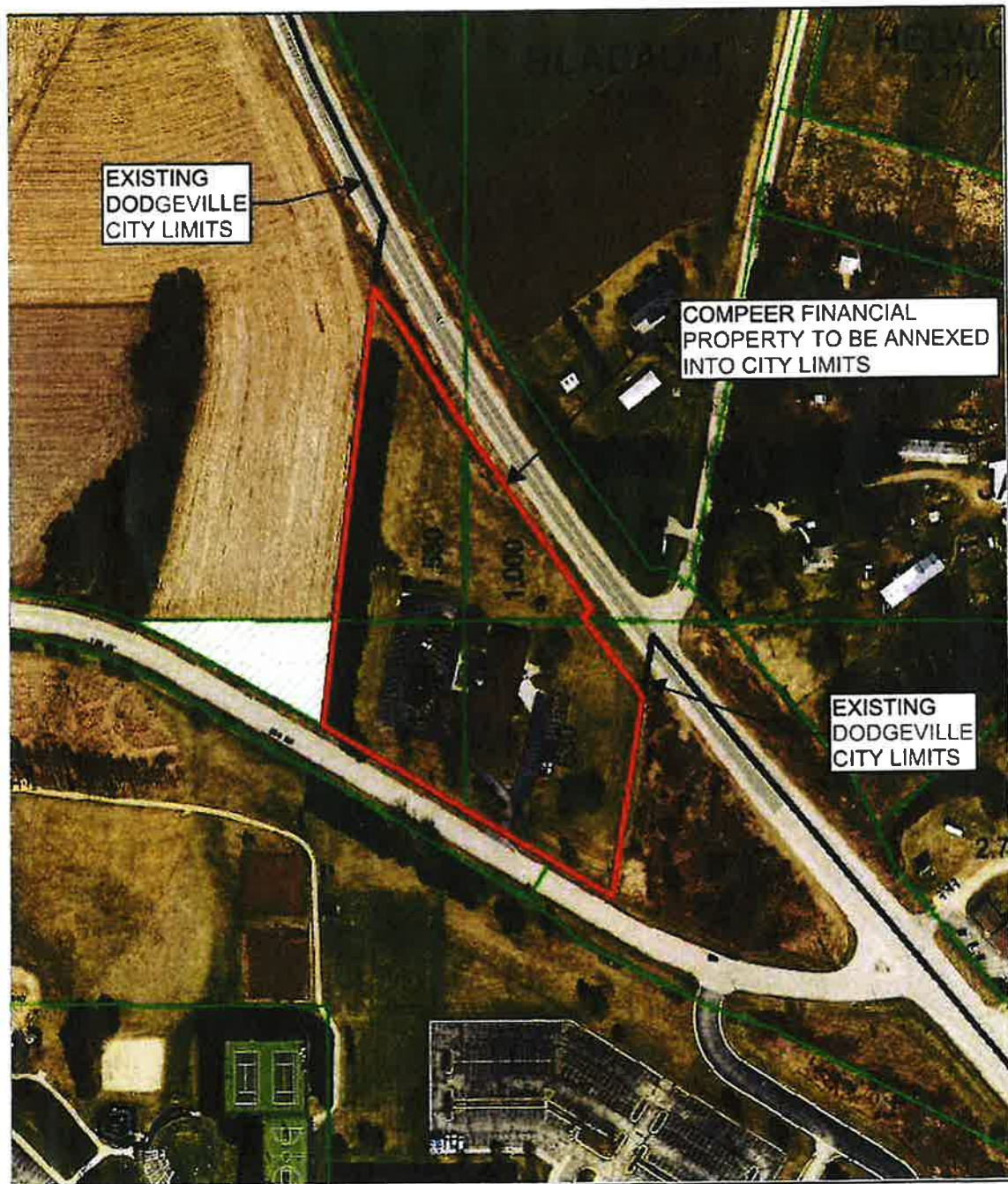

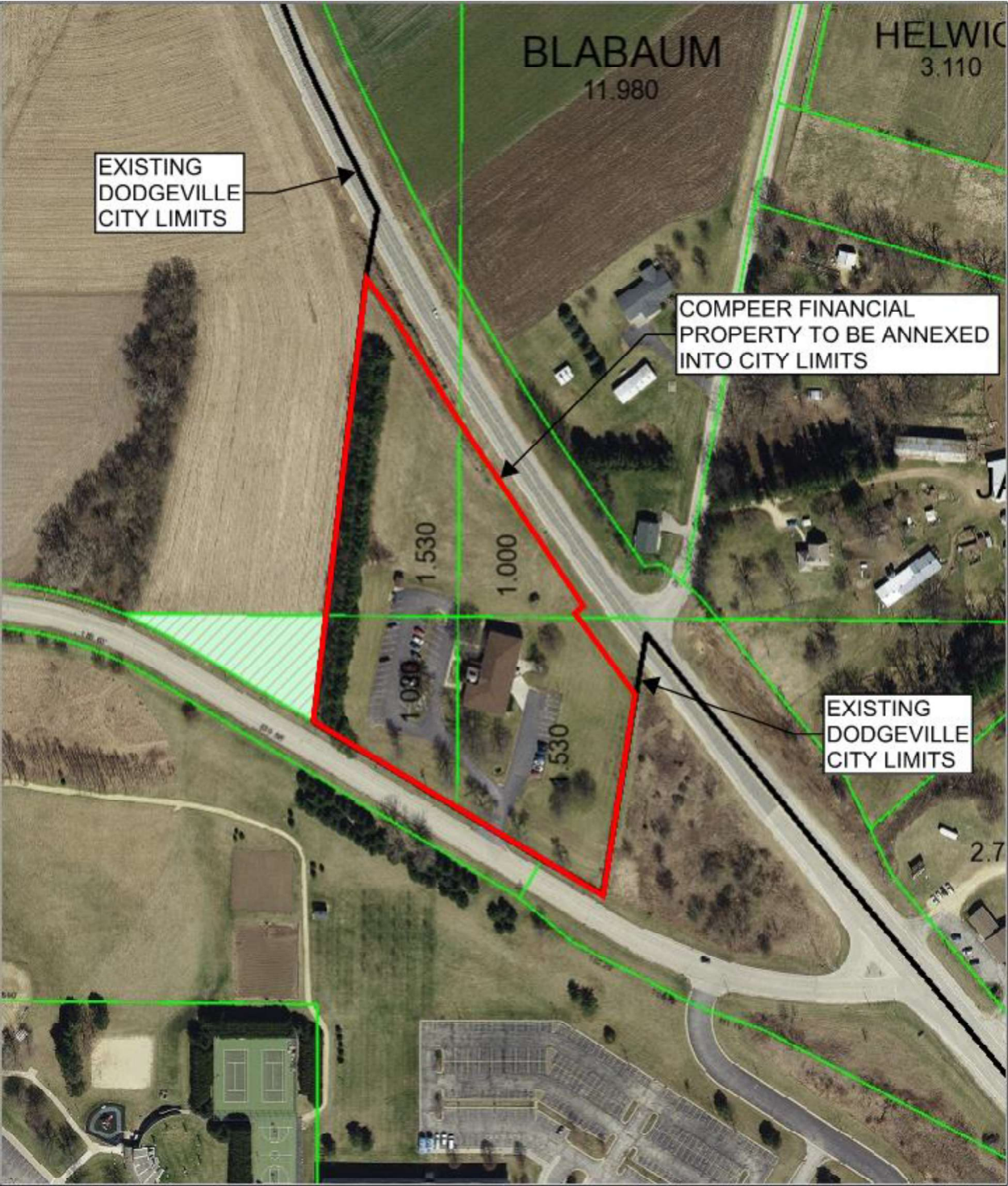
Compeer Annexation Map

AN ORDINANCE ANNEXING TERRITORY TO THE CITY OF DODGEVILLE, IOWA COUNTY, WISCONSIN

WHEREAS, a petition was filed with the City Clerk for direct annexation, in accordance with Section 66.0217(2), Wis. Stats.; of the Town of Dodgeville territory described herein; and

WHEREAS, a copy of the Petition for Direct Annexation and a scale map and legal description of the territory proposed to be annexed were mailed to the Clerk of the Town of Dodgeville as required by subsection 66.0217(2), Wis. Stats.; and

WHEREAS, said Petition is signed by all the owners of the territory to be annexed and there are no residents residing therein; and

WHEREAS, said territory is adjacent to the boundaries of the City of Dodgeville; and

WHEREAS, said territory is adjacent to the boundaries of the existing Tenth Ward of the City of Dodgeville;

WHEREAS, the Plan Commission made a recommendation that the territory to be annexed should be temporarily classified as being zoned as part of the **Business Highway (B-H)** Zoning District;

SECTION V. TAX PAYMENTS TO TOWN

If any part of this ordinance is invalid or unconstitutional, or if the application of this ordinance to any person or circumstance is valid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or applications of this ordinance which can be given effect without the invalid or unconstitutional provision or application.

SECTION VIII. EFFECTIVE DATE

That the annexation shall be effective upon the enactment of this Annexation Ordinance by a two-thirds (2/3) vote of the members of the Common Council and the publication of this Ordinance.
