TEMP B Permit Application -LANDS END JAM

07-16-2024 from 4:00 p.m. to 7:00 p.m.

Information revealed that the application or renewal application for an operator's license is in compliance with regulations, ordinances and applicable laws. The application does not contain a description of the location of sales and consumption as has been provided in like or similar events. This reporting Officer is, however, familiar with the previous locations of these activities and will be meeting, in person, with the applicant on 07-10-2024 to discuss the event and sales locations. Should any additional concerns arise during this meeting a supplemental report will be issued with subsequent recommendations.

Chief of Police report with recommendation

The approval of the application should be contingent upon the suspension of necessary ordinances that conflict with this event. Additionally, plans should be submitted/discussed on 07-10-2024 for actions to address underage alcohol violations, licensed server requirements.

Also of note is the event date and time (07-16-2024 beginning at 1600 hours). As this approval is scheduled for 07-16-2024 at 17:30 hours, there is concern that the issuance of a temp B license is contingent on Council approval.

Outside of this concern the recommendation would be for approval on the behalf of the Dodgeville Police Department pending the allowance of the TEMP B license to go into effect at 1600 hours. This report will be sent to the City Attorney for review to determine if that is acceptable and if any additional requirements need to be met or special council meeting(s) held.
