Continue bids for refurbishment of 1996 Peterbilt Engine 5 and will seek bids on 2007 Pierce Engine 1 for rust repair. Continue comparison of quotes for UTV Can-Am with 6 foot box.

Completed one controlled burn. Scheduled 200 acre burn, primarily at Bloomfield Manor Property, delayed due to weather conditions. Income source for Fire Department.

Annual elections were held at the April 7, 2023 meeting. All officers are returning from 2022.
