a. (FYI) Range Resources - Donegal 30 Tank Pad Site - 106 Grimes Road

Applying to modify its coverage under the General Permit WMGR123. They want to increase compacity with one 22,000 bbl nominal capacity open-air storage tank and associated equipment to act as a water

Reuse Water Storage Facility.

- b. (FYI) Pennsylvania Fish and Boat Commission Dutch Fork Temporary Stream Crossing. They are applying for a Water Obstruction Permit through DEP to remove debris.
- c. (FYI) West Penn Power is applying for coverage with the DEP for a Waiver 3 associated with stream and wetland crossings for replacement and expansion of overhead electric transmission line.

Site Location - Beginning near the intersection of Pogue Road and Dry Ridge Road following south along Dry Ridge Road until the intersection of Ealy Road. Ealy Road to the east until it intersects with Lake Road. This is all within West Penn Powers existing right of way.

Once to Lake Road, West Penn Power is proposing a new ROW and structures following Lake Road south from Ealy Road to Hicks Road.
