BOARD OF ADJUSTMENT AGENDA

2. **Public hearing, discussion, and consideration of approval of VAR2025-002: a variance request to allow a commercial building associated with the Dripping Springs Sports Club to be larger than the 100,000 square feet limit in the Planned Development District No. 6 zoning district for a property located at the northwest intersection of Canyonwood Drive and US 290.** *Applicant: Drew Rose, DSSC Equity, LLC*

- a. Applicant Presentation

Applicant Drew Rose presented and remained in the audience to answer questions.

- b. Staff Report

Planning Director Tory Carpenter presented the staff report and recommended that if the board acts on the variance request, that it be approved with the following conditions:

1. The applicant must provide 8-foot wood or masonry screening along the eastern and northern property boundaries consistent with Section 5.10.1 of the Zoning Ordinance.
2. The applicant shall submit an Alternative Exterior Design application for review and approval prior to submitting a site development application.
3. The gross floor area of the building shall not exceed 150,000 square feet.
4. The building footprint shall not exceed 65,000 square feet.
5. The applicant shall install a six-foot wood fence or masonry wall with supplemental screening along the northern and eastern boundaries of the outdoor sports courts.

6. The applicant shall install timers and blackout shades on mezzanine level windows facing residential areas to shield from sunset to sunrise and shall use fully shielded, downward facing parking lot fixtures with motion sensors and timers.
7. Prior to obtaining a Certificate of Occupancy, the applicant shall establish a Neighborhood Advisory Board with representatives from Headwaters and Sunset Canyon, meeting at least twice annually during construction and first year of operation.
8. A site development permit shall be approved and construction commence on the site within two years of approval of this variance request.

c. Public Hearing

Theodore Crawford spoke concerning sound mitigation.

d. Variance

A motion was made by Council Member Tahuahua and seconded by Council Member King to approve the variance with the conditions identified by staff in the presentation which should reflect the 8 ft. wood or masonry screening as well as the addition of the sound mitigation on the outdoor sports courts for pickleball & basketball. The motion carried unanimously 6 to 0.

PRESENTATION OF CITIZENS

By law no action shall be taken during Presentation of Citizens; however, the Mayor may provide a statement of specific factual information, recitation of existing policy, or direction or referral to staff.

Applicant: Shane Bauerle, BPI Partners, Inc.**

- a. Applicant Presentation

Director of Business Development Robert McClelland presented and remained in audience to answer possible questions.

- b. Staff Report

Building Official Shane Pevehouse presented the staff report and recommended denial of the sign variance.

c. Public Hearing

No one spoke during the Public Hearing.

d. Variance Request to allow additional wall signs

A motion was made by Council Member King and seconded by Council Member Tahuahua, to treat this as two (2) signs with the applicable dues and grant the variance for two (2) years. The motion to approve carried 3 to 2, with Mayor Pro Tem Manassian and Council Member Crow voting nay.

This motion addressed both the additional signs and the fees.

e. Request to reduce Sign Permit Application Fees

Same motion.

A motion was made by Council Member King and seconded by Council Member Tahuahua, to treat this as two (2) signs with the applicable dues and grant the variance for two (2) years. The motion to approve carried 3 to 2, with Mayor Pro Tem Manassian and Council Member Crow voting nay.

9. Discuss and consider approval of an Ordinance Repealing and Replacing Appendix A: Article A100 (General Provisions) of the Dripping Springs Code of Ordinances; Amending Fees and Updating Fee Schedule Formats. Sponsor: Mayor Bill Foulds, Jr.

A motion was made by Council Member Tahuahua and seconded by Council Member Parks, to approve the fire section of the fee schedule with amendment under new fees to add unauthorized burning during burn ban and unauthorized burning and to have these fees increase with each subsequent offence. The motion carried 3 to 2, with Mayor Pro Tem Manassian and Council Member Crow voting nay.

10. Public hearing, discussion, and consideration of approval of proposed amendments to an Ordinance of the City of Dripping Springs, Chapter 20, implementing the enforcement provisions of the City's Drought Contingency Plan. Sponsor: Mayor Bill Foulds, Jr.

This item was postponed.

11. Discuss and consider the selection of a bidder for the Stephenson Building and Parking Lot Improvement Project and authorize staff and the Mayor to finalize agreement with selected bidder. Sponsor: Mayor Bill Foulds, Jr.

A motion was made by Council Member Crow and seconded by Council Member Parks, to accept QA Construction for \$4,281,000 for the Stephenson Building and Parking Lot Improvement Project and authorize staff and Mayor to finalize the agreement. The motion to approve the carried 4 to 1, with Council Member Tahuahua voting nay.

12. **Public Hearing regarding the Proposed 2025 Ad Valorem Tax and Levy of Two Thousand Two Hundred and Sixty-Seven Ten-Thousands Cents (\$0.2267) per one hundred (\$100.00) of assessed valuation of all taxable property within the Corporate City Limits.**

No one spoke during the Public Hearing and there was no action taken.

13. **Public hearing and consideration of approval regarding an Ordinance of the City of Dripping Springs, Texas, adopting the 2025-2026 Fiscal Year Municipal Budget; funding municipal services and authorizing expenditures.**
