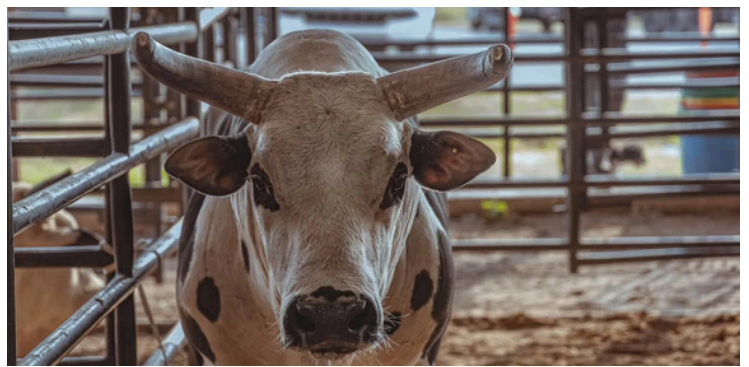
MAY 2025
