Update on Reclaimed Water:

Founders Park reclaimed water usage was 273,511 gallons for the month of December with a daily average of 8,822 gallons per day. Sports Park reclaimed water usage was 1,113,511 gallons for the month of November with a daily average of 35,919 gallons per day. Total usage was 1,387,022 gallons with a daily average of 44,742 gallons used.
