Summary/Background: Cecilia Delasancha has reached out to staff to request rental of the Main Event Room on May 30th, 2026, for a private party of around 300-400 people.

Section 16.02.057 of the Parks Ordinance provides that it is an offense for any person to sell or consume alcoholic beverages in a city-owned park unless authorized by the city in writing. Currently, DSRP only authorizes events other than private parties with more than 50 people to serve or sell alcohol.

Cecilia is asking for a one-time request to host her event with the ability to have alcohol at their event. Staff has notified them of our current agreement with

Peak Beverage for onsite alcohol sales.

served through Peak Beverage and appropriate security to be hired by

Delasancha Family.

- (a) It is an offense for any person to:
 - (1) Sell, possess with the intent to sell or, consume alcoholic beverages in a city-owned park, unless authorized by the cityin writing.
 - (3) Smoke or use any tobacco products, including electronic cigarettes and vaping, in any city-owned park.
- (b) A person who engages in conduct prohibited by this section commits an offense which, upon conviction is punishable by a fine not to exceed \$500.00.
