CALL TO ORDER – Chair Gardner called the meeting to order at 6:30 p.m.

ROLL CALL – Quorum was established through roll call by the Town Clerk

PRESENT: (6) Chair Angie Gardner, Vice Chair Rodney Daniels, Director Wanda Randolph, Director Ruthie Critton, Director Theo Washington. Director Marlin Daniels **STAFF**: (3) Nicole Bonds, **CRA Executive Director**, Veronica King, **Town Clerk**, Patrick Brackins, **Attorney**, Joseph Jenkins, **Deputy Chief**. (**Not In Attendance:** Director Leviticus Henderson)

INVOCATION AND PLEDGE OF ALLEGIANCE

Chair Gardner led the invocation through a Moment of Silence followed by the Pledge of Allegiance

PUBLIC PARTICIPATION - (The Three-minute rule was strictly enforced)

Angela Johnson – Inquired about the agenda item pertaining to the Paint, Plan, and Pave Program; Would like information on the amount allocated, date of implementation, advertisement efforts, and if opportunity will be available to residents who received prior funding or the eligible time a former recipient would have to wait for reapplication.

APPROVAL CONSENT AGENDA – Chair Gardner Motions to approve Consent Agenda for approval of TOECRA Meeting Minutes for 3-16-2023; Moved by Director Washington; Second by Director Randolph; **AYE: ALL, MOTION PASSES.**

BOARD DISCUSSION

To Discuss the Paint, Plant and Pave Program – Discussed budget allocations (Currently there are no funds allocated on current budget), seeking direction from the board for the possible budget transfer; need to look at unused budget line items as a possibility source for transfer). The former program had a \$30,000 budget: up to \$5,000 per applicant. Consider if there will be an income level eligibility criterion, ensure that every applicant benefit from the program (consider setting a cycle of funding with deadline for submission), In the description section, there is a discrepancy of \$2500; it should read up to \$5,000, the program is a reimbursable program, request to clearly define the term "priority basis" (can create a scale to determine priority); who determines the priority (the approving authority); In maintaining the improvements, consider adding a time period and determining an inspection team, consider adding a criteria for requesting for "forgiveness" to the board as there is a need, and provide clarity to judgments or encumbrances (whether a request for "forgiveness" will be allowed on a lien). Need to establish a clear vetting process to ensure a fair system (consider a lottery system). Ensure that contractors are vetted 1 of 3 04202023CRAMeetingMinutes

(future legislation could lead to a felony if contractors are not certified and vetted), emphasized une need to established eligibility limits for former applicants who have received money (prevent double dipping), should not be investment and rental properties; need to be a homestead property not in risk of foreclosure (providing proof of good standing), will there be a requirement for insurance. Recommend establishing criteria for identifying a list of priority projects to consider and whether a former recipient can apply again if the maximum benefit of \$5,000 was not used. Consider the town vetting contractors through an RFP process and utilizing local town contractors. Consider the income average in the town when determining income eligibility criterion to prevent discriminatory actions towards qualifying/disqualifying factors. Consider the program being homeownership based rather income based. (Angela Thomas asked to podium by Mayor Gardner) Served as chair to the affordable housing program for three years; the minor rehab and a similar program being discussed today; suggest partnering with the affordable housing as a referral partner if applicant meet the eligibility requirements (there is lots of money that Eatonville does not use through the affordable housing.).

To Discuss the Residential Demolition Grant Program – Program will assist homeowners who do not have funds for a demolition of their home (Several possible homes were shown through PowerPoint); will address blighted areas and concerns related to health and crime. If the town pays for demolition, a lien should be placed on the property as a way of repayment to the town. (Historical Homes) Funding for historical restoration can be used towards historical homes; should not be demolished. Need to look at the purpose and function of Code Enforcement, demolishing homes can affect property value and appraisal. Consider a down payment assistance program. Request for list and research on the homes to see if there are existing liens; including any liens with the town for further action (town can foreclose on a lien after 3 months). Need address drug invested vacant homes; individuals have been escorted from the properties. Owners should be contacted to board the homes.

<u>To Discuss Neighborhood Stabilization</u> No Discussion; Presenter cancelled. Director Randolph will have Help CDC (Nicole Oriol) come to the next meeting to present their Help CDC program. Recommend coming to the Neighborhood Stabilization Program website to learn more about the eligible activities; there are funds available. HUDS Neighborhood Stabilization Program, no new funding had come in since 2010; need to determine what is actually available. Research also if there are available funds from the county for neighborhood stabilization.

- 4. <u>Director M. Daniels</u> Consider budget adjustment for the programs discussed, recommend seeking funding to improve the landscaping front/main street. Consider calling a meeting with the front/main street business owners to discuss a uniformed painting of commercial buildings, look at adding a different lighting appeal and uniformed signs, bring food trucks and live bands onto main street on

Fri/Sat to increase visitor to Eatonville. Recommend reaching out to Orange County for avanable funding. The state funding for the CBDG is held up due to a special session; the funding limit has been reached according to statue limits. They will be holding a special session. Requesting to establish an interlocal agreement with Orange County to receive funding for certain projects. Mr. Pressley is already in contact with companies pertaining to the irrigation.

<u>SUMMARY:</u> On December 6, 2022, a special CRA meeting from the majority Board of Directors by a 4/2 voted to request a special investigation pertaining to Resolution #CRA-R-2022-24 authorizing General Counsel to engage and retain outside legal counsel for special investigation and render opinions and guidance as the matters related to the former TOECRA Executive Director.

The Town of Eatonville Community Redevelopment Agency ("TOECRA") is seeking to retain the professional legal services from a private law firm or firms to conduct a special investigation related to certain actions taken by or on behalf of the TOECRA. Specifically, the TOECRA seeking special investigation into the following:

A review of any and all documentation and/or pertinent information related to the use of TOECRA funds submitting compensation to the former TOECRA Executive Director in the amount of \$71,677.69 as severance pay, after the former Executive Director was terminated for cause. A review of any and all documentation and/or pertinent information related to the TOECRA financial transactions to determine the appropriateness of a single signer executing financial instruments on behalf of the TOECRA. A review of any and all documentation and/or pertinent information related to the TOECRA financial transactions to determine the appropriateness of allowing non-TOECRA Board Members to be listed as signers on the TOECRA accounts with any financial institution.

The TOECRA recognizes that the special investigation may result in other related areas being reviewed to complete a thorough special investigation. The TOECRA is thus requesting proposals for the possible establishment of a contract in this context.

Proposals should identify the firm's experience with similar issues or cases; the individuals within the firm who would be authorized to work on the matter; whether those individuals are members of the Florida Bar; the firm's experience with municipal and government matters, to include procurement policies and employment issues.

REQUEST: Request is for the Town of Eatonville Council to seek information pertaining to the Val Demings announcement of \$18 Million in Federal Funds from Omnibus (Central Florida District) available through appropriations of \$2,000,000; New Senior and Affordable Housing; \$1,000,000 for the Eatonville Community Policing Innovation Program.

<u>SUMMARY:</u> An announcement by Mayor Angela Gardner was stated on local news from about December 2022 - January 2023, that the Town of Eatonville was considering purchasing the Hotel-Motel in the Town of Eatonville. This was very shocking and unknown to The Town of Eatonville Council members and residents and the public; not discussed before the council. Then, on March 31, 2023, communication was sent from Lee Perry, Florida Rising to connect with community leaders from within Eatonville to submit a letter of support for the filing of the Omnibus Bill/Grant of \$2.5 million dollars for affordable housing apartments within the Town of Eatonville. According to Florida Rising, the project will be to buy vacant properties in Eatonville and grant them to the Town of Eatonville for affordable refurbished and rental housing. The Town of Eatonville will be in charge of refurbishing and renting the identified properties with federal oversight.

RECOMMENDATION: To discuss and provide all information to the Town Council regarding the Federal Funds from Omnibus through appropriations of \$2,000,000 available to the Town of Eatonville.

The Pine Hills Transfer Center is a critical upgrade for the LYNX network and will facilitate more efficient operation and transit access to the major job, education and health centers of the Orlando region. LYNX serves approximately 2,500 square miles with a residential population of 2.1 million people in Orange, Osceola, and Seminole Counties. The new center has been in the design phase for the last four years, with the input of Orange County, the **Florida Department of Transportation**, **Duke Energy**, and local residents and businesses. It will include a portion of the larger Pine Hills Trail, a building to house customer.

The COVID-19 pandemic has severely reduced the YMCA of Central Florida's annual revenue a drop of roughly 50 percent and the Y is unable to finish the project gymnasium without federal support.
- \$1,408,412 for the **City of Ocoee** to expand its wastewater collection and treatment system, which currently does not cover the southern section of downtown, forcing commercial and residential properties to maintain their own septic tank systems and prevents further development. This project will construct gravity wastewater collection sewers, allowing Ocoee to develop economically, grow their tax base. It will also provide upgraded potable water mains to provide capacity for water supply and firefighting.
- \$1,000,000 for the **Town of Eatonville** to fund their Community Policing Innovation program and combat an increase drug trafficking and crime during the COVID-19 pandemic. The Eatonville Police Department will use this funding to support public partnership and outreach programs including the Citizens Police Academy, National Night Out, Coffee with a Cop, Youth Police Academy, Explorer Program, Vacation Watch, RU-OK? (a senior citizen welfare check program), and virtual neighborhood watch programs.

\$985,000 for the **City of Orlando Police Department** to improve department and community safety and accountability through the new in-car camera program. The program will record traffic stops, suspected DUI incidents, vehicle pursuits, and other activity, including the rear-seat of the patrol vehicle. The project objective is to outfit all Patrol vehicles with in-car camera systems, approximately 456 patrol vehicles. A 2019 federal police grant (the Byrne JAG program) funded the first 17 camera systems. This grant will fund an additional 100, bringing the total to 117, with the remainder funded by local funds.

\$500,000 for Orange County to expand solar power capacity through the new **Floating Solar PV Project**, which will protect Central Florida air quality, combat climate change, and benefit Orange County Utilities' customers by reducing operational expenses by 20 percent. By placing floating solar generation in existing stormwater ponds the county can move quickly to place the new solar panels, with plans to execute the Floating Solar PV project by January 2023.

\$395,500 for **Shepherd's Hope Health Center**, a free clinic in Winter Garden for underinsured and uninsured individuals in need of health services. Increased demand of services by the community due to the pandemic has caused the current operations and equipment of the facility to be overtaxed. This funding will support in-person and telehealth services through capital investments including: a new hydraulic chair for the dental unit; teledoc equipment to support telehealth; a mobile medical clinic bus (which will allow volunteer medical professionals to respond dynamically, as well as establishing second-location services as needed to expand geographic access); a colposcope for OB-GYN services; a new Automated External Defibrillator for emergency cardiac arrest; and an autoclave to sterilize medical equipment. The clinic also plans to acquire important equipment for telehealth and health record management, including a video conferencing system, laptops and digital devices, a security system, website development, and electronic health record software. Shepherd's Hope is a 501(c)(3) non-profit charitable organization and can acquire equipment practically and efficiently.

\$200,000 for **Hispanic Federation** to fund their **Pathways College Prep** program, which works with Latino parents to prepare their children for college through information on the importance of Advanced Placement (AP) classes, extracurricular activities, and college entrance exams; the critical nature of the junior year; and finding information on financial aid and scholarships.

\$184,500 for the **Orange County Sheriff's Office** (OCSO) to fund Crisis Intervention Team (CIT) trainings, which are a proven tool in the Office's goal to reduce the use of force, reduce the number of involuntary commitments to mental health facilities (Baker Act), and reduce the number of arrests of mentally ill citizens. According to the National Alliance on Mental Illness approximately 1 in 4 fatal police shootings between 2015 and 2020 involved a person with a mental illness. OCSO currently has 1,633 sworn deputy sheriffs and 145 non-sworn personnel, of which Only 538 have attended CIT training. In 2021 the OCSO, in partnership with Aspire Health, created a 40-hour Memphis Model-approved course. CIT training includes intensive verbal de-escalation skills with consistent attention to officer safety. All participants are required to complete scenarios with trained role-players. Also in 2021, the Orange County Sheriff's Office started the Behavioral Response Unit (BRU). The BRU uses CIT-trained deputies teamed with Clinicians or Clinician Interns who are Clinical Social Workers and/or mental health therapists. Working as a team, the sworn deputy sheriff and BRU Clinician respond to high-risk, potentially dangerous, and suicidal individuals who may have a mental

illness, PTSD, and/or substance abuse problem and may be experiencing m distress, with the goal of improving their quality of life, reducing their exposure to the criminal justice system, lessening the frequency of negative contact with law enforcement, and referring them to appropriate community services.

\$100,000 for **Orlando Community & Youth Trust, Inc.** to repair relationships between law enforcement officers and youth in underserved communities. The Dueling Dragons Program, in partnership with the Orlando Department of Families, Parks and Recreation and Orlando Police Department, pairs law enforcement officers with teens from Orlando's most underserved neighborhoods to become a year-round dragon boat team. The program works with youth from Orlando Kidz Zones – designated areas in the city with high rates of poverty and low educational attainment rates. To remain in the program, the teen participants must sign a Code of Conduct and pledge to stay in school, avoid truancy and behaviors in school that could result in suspension, and avoid any activity that could cause them to be arrested. Since it began, the Dueling Dragons has served 162 youth: 0 have been arrested while in the program, 100 percent have stayed in school, maintaining at least a 2.0 grade point average, and many have gone on to attend college – often earning scholarships.

\$48,972 for the Orange County Sheriff's Office (OCSO) to solve cold murder cases through new genetic sequencing methods. The OCSO Homicide Cold Case Team has four full time cold case detectives currently investigating the murder of 12 unidentified murder victims. Of these 12 victims, three are in various stages of identification through genetic genealogy. The remaining nine victims require genetic genealogy for identification. New technology is available that may yield positive IDs. OCSO is currently working with the University of South Florida's "Left For Dead" project and the National Missing and Unidentified Persons System. The cold case process requires extensive knowledge and hours of detective work, which this funding will support.

REQUEST: To discuss updates on the Tommy Dixon (deceased) property located at 225 West Kennedy Blvd. Eatonville, Florida, and unauthorized persons to vacate from the property Investigation.

SUMMARY: Tommy Dixon passed away on December 3, 2022. In the case involving Mr. Dixon at property at 225 West Kennedy Blvd. based upon the legal opinion of the current TOECRA General Counsel, the board members questioning the mental capacity during the TOECRA Meeting on or about November 4, 2020, there was clearly a concern that Mr. Dixon lacked the mental capacity to understand the contract for the purchase of his property. The former TOECRA General Counsel took on the representation of Mr. Dixon in an administrative matter to place Mr. Dixon on the property deed for the purpose of allowing Mr. Dixon to sell the subject property to the TOECRA per the vote of the 3-member independent board. Based upon the opinion of the current TOECRA General Counsel and applying the standard to determine incompetency, that Mr. Dixon was incompetent since he was "unable to understand in a reasonable manner the nature and consequences of the transaction." This matter has been discussed several times among the board. With this understanding, the legality of ownership of the property can be returned to the estate of Mr. Dixon. Therefore, this matter is in the hands of family members under legal counsel for return of the property.

RECOMMENDATION: Recommendation is being made to discuss the appropriateness of Legal Counsel to finalize and take action to protect and secure the property from unauthorized persons to vacate without further delay until a decision is rendered of the property of Tommy Dixon, (Deceased) Life Estate and The Town of Eatonville.

REQUEST: Lavonda Wilder, property owner of 213 West Kennedy Blvd, has requested a lien to be removed from her property placed by the Town of Eatonville Community Redevelopment Agency by the former Executive Director Michael Johnson and Attorney Jaimon H. Perry, TOECRA Legal Counsel. An application was submitted for a Facade Grant. She had applied for improvements to her property for \$30,000.00. Ms. Wilder was awarded the funds, but she alleges she did not receive the funds. Therefore, Ms. Wilder is requesting a refund of \$30,000 for out-of-pocket expenses for damages and to complete the building. Michael Johnson appointed himself as the executor of the funds.

<u>SUMMARY:</u> Ms. Wilder contends that when property improvements began, it was inadequate due to unlicensed subcontractors and she did not receive the funds, therefore, requesting a refund for her out-of-pocket personal expenses for improvements to her property structure and property improvements. On May 4, 2021, a lien was filed in Orange County Public records, Doc# 20210268868 on property listed as 213 West Kennedy Blvd., Orlando, Florida 32810 - (Parcel ID 35-21-29-0000-00-086). A Notice of deferred payment loan lien in the amount of \$30,000 for a Facade Grant Performance Program to improve building structure improvements. The lien states that it shall remain in effect for a period of five (5) years from the last disbursement date of the loan proceeds from TOECRA to Lavonda Wilder.

<u>RECOMMENDATION</u>: Recommendation To resolve and remove lien off property as listed and refund for out-of-pocket expenses.
