**REQUEST:** Administration introducing the Town Council to the FEMA approved group, that can assist the town in multi-coordination services for attaining funds for projects in Eatonville.

**SUMMARY:** The Interagency Recovery Coordination group (IRC) was established by the Federal Disaster Recovery Coordinator to meet challenges presented by Hurricane Irma and ensure interagency coordination for disaster recovery. Under the guidance of the [National Disaster Recovery Framework](#), there are six Recovery Support Functions (RSF), each led by a designated federal agency. The IRC developed a Mission Scoping Assessment that is a summary of findings and issues identified by the six federal Recovery Support Functions supporting the NDRF mission in Florida. Staff is working the IRC group to identify area to use the assistance they provide. The IRC group will present the potential areas they may can provide funding coordination service for the Town.
