1. CALL TO ORDER AND ROLL CALL

4. WORKSHOP

A. Public Works – David Hutchings

We conducted meter readings and daily residual checks at the sewer and water plants. Our team is responsible for meter readings and service cut-offs. Additionally, we have completed several projects based on work orders created by the office staff.

We are pumping sludge into dewatering containers and have pulled pumps at the sewer plant due to trash and cleaned lift stations.

We have continued to install sprinklers on the fairways and tee boxes. Recently, we patched holes behind Joe T. Smith and addressed water leaks on Highway 87, Highway 83, and Moss Street. We dealt with a sewer backup at the City Office as well.

We received numerous animal control calls and used crushed rock to fill in washouts on Daniels Street and Jay Street. We also sent out water samples for lead and copper testing.

Additionally, we ran a new service line for the south side of the housing area and completed the kill-out at Dail and Highway 87. Our team put up Christmas lights around town and took care of mowing and weed-eating at city-owned properties, assisting with golf course mowing as well.

We have repaired several leaks on the golf course and replaced a couple of valves. We have to open watering station for people to get water.

Open Projects

- **USDA Water Project** – All American has been onsite to complete the water project. Unfortunately, there have been issues with the pumps, we are in the process of troubleshooting. Ronnie and I have met with Trac-n-trol we are waiting for the transfer pump to be completed and then we will have them scheduled to install the SCADA.
- **USDA Sewer Project**- SCADA needs to be installed we are awaiting scheduling from TracNtrol. Jimmy with Enprotec Hibbs & Todd has created a punch list for this project we are currently waiting on response from DIGG.
- **TXDOT HWY 83/87 Project** – Harris Road Company has completed the bore on 83 & Bryan Street.
- **Concho Springs Golf Course** –We continue to follow the established mowing and watering schedule. We continue to fix sprinklers as needed. Frankie has completed painting the picnic tables and placing them throughout the course. Maria's Creations is still operating at Concho Springs and reports she is doing well. We have created gift certificates for Concho Springs, please spread the

word, they are available for purchase. Katie Moerbe and Alessandra Knapick are new hires for the clubhouse.

- **Streets** – Ronnie has coordinated with TXDOT to assist with the speed limit change to the 87/83 entrances to Eden. We are awaiting approval for the change.
- **Animal Control** – There have been several animal control calls this month. We are working on organizing another rabies clinic, we will keep the community informed, the veterinarian is deciding on a date and rate.
- **Administration** – We have gathered required data to close FY2024-2025. Our auditor has suggested we begin transitioning data to our new software and begin operating in gWorks. Victoria Sanchez (Ramirez) was hired for the Court Clerk position.
- **Code Enforcement** – We have had several permit requests for building fences, carports, roof replacement, accessory buildings etc. We have sent out several courtesy letters to property owners regarding grass overgrowth and other violations of the Health and Sanitation Ordinance.
- **Water Plant** – Public works continues replacing necessary meters with new Sonata ultrasonic Z-Flow Water meters. These meters have flow sensitivity starting as low as 0.001GPM. Well 3 is having electrical issues.
- **Wastewater Plant** – We are waiting for parts to arrive for the decant unit. They are scheduled to ship at the end of December.

The playground equipment and seating/tables need replacing at the Pfluger Park, and the seating/tables need to be updated at Earl Rudder Park. These 2 parks are used quite often for community events, so replacement of these would be beneficial and would help prevent any liability issues from unsafe equipment. The request also includes a new nativity scene for Earl Rudder Park.

E. Spirit of Eden Grant Request for City of Eden Cemetery Committee

Priscilla reminded Council that a new pole and 2 solar powered LED lights were installed at the Cemetery in June of 2024, but unfortunately, the LED lights are not holding up as well as expected. A quote was received from Texas Live Wire to run electrical services to the north and south entrances, service upgrade on existing meter and panel increasing capacity from 100 to 200 amps and installing a

sub-panel with breakers. She stated that another vendor will be bidding as well, so the amounts could change once the quote is received.

They provided 3 different plans: a Silver Plan with Blue Cross instead of the current Gold Plan, Scott & White and Texas Health Benefits. She is suggesting accepting the Texas Health Benefits Plan because it is within the budgeted amount and has similar coverage to the current Blue Cross Plan; however, for staff members who have insurance on their dependents, they will see a significant increase that is not very affordable. To assist these employees, Zesch and Pickett is providing quotes from the Market for their dependents.
