

BACKGROUND

Mr. Arnold filed for an Industrial Disability Retirement in February 2025, as a 52-year-old Fire Captain. He was employed by the City for twenty-four years. Mr. Arnold was hired on October 23, 2000 and separated employment on April 1, 2025. The basis for the denial of Mr. Arnold's Industrial Disability Retirement application is confirmed by a medical report from Dr. Tomer Anbar.

Under State Law, the City Council is required to adopt a Resolution determining that competent medical evidence supports the granting or denial of an Industrial Disability Retirement. Based on medical evidence, staff recommends the City Council adopt Resolution No. 2026-05, denying the CalPERS Industrial Disability Retirement for Christopher Arnold.

WHEREAS, the City of Escondido ("City") is a contracting agency of the California Public Employees' Retirement System ("CalPERS"); and

WHEREAS, the California Public Employees' Retirement Law (Govt. Code § 20000 et seq.) ("California law") requires that the City determine whether an employee classified as a local safety member is disabled for purpose of the California law and whether such disability is "industrial" within the meaning of such law; and

WHEREAS, an application for an Industrial Disability Retirement for psychological disability from Christopher Arnold ("Employee") employed by the City of Escondido in the position of Fire Captain has been filed with CalPERS; and

WHEREAS, the City Council of the City of Escondido has reviewed the medical and other evidence relevant to this industrial disability.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Escondido, California, as follows:

1. That the above recitations are true.
2. That the City Council does hereby find and determine that Employee was not and is not substantially incapacitated within the meaning of the California Public Employees' Retirement Law for performance of his duties in the position of Fire Captain for psychological injury.

3. That the City Council certifies Resolution No. 2026-05 in accordance with Govt. Code § 21156, that this determination was made on the basis of competent medical opinion, and was not used as a substitute for the disciplinary process.

4. That based on information and belief, and on the information provided by City staff, the City Council certifies under penalty of perjury that all statements in this Resolution are true and correct.

On March 2, 2022, the City Council approved Resolution No. 2022-32 authorizing the Deputy City Manager / Director of Communications & Community Services to submit an application to the California State Library for \$10 million in funding through the Building Forward Library Infrastructure Program Grant and complete all necessary documentation to receive and spend funds should they be awarded.

On September 12, 2022, the City was notified that the application was successful, and that the Escondido Public Library was awarded the maximum amount of \$10 million and removal of a matching funds requirement.

BACKGROUND

The \$10 million grant for the Building Forward Library Infrastructure Program has a clearly defined scope with limitations on allowable items. In general, grant funds may only be used for items permanently affixed to the building, including fixed shelves, built in desks, and infrastructure equipment. Items such as

furniture, mobile shelving, and other non-affixed equipment items are specifically excluded from the grant. Given these limitations, furniture, fixtures, and equipment ("FF&E") items require an alternative source of funding.

The Library Board of Trustees held four workshops on October 25, 2024; May 8, 2025; August 14, 2025; and September 24, 2025 to discuss various funding options with the community. Various library support groups attended these meetings in an effort to understand the FF&E needs once the main library reopens. The Friends of the Escondido Public Library expressed an interest in supporting the Library Infrastructure Project by funding specific items not covered by other organizations.

The Friends of the Escondido Public Library has committed to purchasing and donating two-person study pods valued at \$60,484 to the library. The donation of these study pods includes tax, shipping, and installation and will be delivered following the completion of the library construction project.





FISCAL ANALYSIS

The total contract price of the Second Amendment is \$159,610, which includes technical support for one (1) year at a cost of \$118,560 and the remaining training services contract price at a cost of \$41,050. The contract is funded by the Water and Wastewater Funds FY2025/26 operating budget and will be included in the FY2026/27 operating budgets for each fund.

PREVIOUS ACTION

On August 12, 2015, the City Council adopted Resolution No. 2015-139 approving the Oracle bundled package for software, licensing, and implementation service costs to upgrade the existing Utility Billing/CIS software to Oracle's Customer Care and Billing product and authorized the Director of Utilities to execute necessary contracts to initiate the upgrade. This included a contract with Blue Heron Consulting to provide system integration services for the implementation of the software.

BACKGROUND

In 2015, Oracle offered the City a one-time incentive package to upgrade to Oracle's Customer Care and Billing ("CC&B"), their premiere billing and CIS product. The bundled package included reduced software and licensing costs from Oracle along with discounted implementation services from Blue Heron, a certified Oracle Gold Partner who specializes in installation, maintenance, and implementation of Customer Information and Billing systems for small and mid-sized businesses. Blue Heron was the only Oracle-certified partner in North America who responded to the city's Request for Qualifications that met our qualifications. With the assistance of Blue Heron Consulting, the City went live successfully with the upgrade to Oracle's Customer Care and Billing software in August 2016.

Since then, Blue Heron Consulting has continued to support the City's utility billing software and staff for special projects and required configuration changes. In January 2024, with the retirement of a Systems Analyst that was primarily responsible for supporting the CC&B software system, the City approved a Consulting Agreement utilizing Blue Heron for technical support of the City's Utility Billing software and not filling the vacant position. Blue Heron Consulting was selected for these services because of their direct experience in building the current software and they were able start immediately with little to no resources needed from current city staff. This ensured that the Utility billing software is sustained and that Utility Administration and Utility billing staff are provided the support needed from the system.

Staff are recommending extending the technical support contract for an additional year (January 2026 to December 2026) while City staff begin the process for evaluating a replacement utility billing software system which is identified as a project in the FY2026/27 City Council Priority Work Plan.

A. General

Blue Heron Consulting Corporation, a New York corporation ("Consultant") will provide the City of Escondido, a California municipal corporation ("City") with consulting services related to the City's Customer Care & Billings ("CC&B") production system and technical support.

B. Location

Consultant to provide services remotely or at City Hall located at 201 N. Broadway, Escondido, CA 92025.

C. Services

In addition to those services described in the Agreement, Consultant shall provide services as detailed in Exhibit 1 to this Scope of Work, which is attached hereto and incorporated herein by this reference. In the event of a conflict between this Second Amendment (including this Scope of Work) and Exhibit 1, the terms of this Second Amendment shall prevail. Services provided under this Second Amendment shall generally include:

CC&B Production System Support

- Provide a dedicated resource (i.e. full-time, 40 hours per week) to act as a point of contact for all City staff to log, track and work on any CC&B related tasks.
- Assist staff when they have questions, concerns or problems related to CC&B.
- Provide recommended approach/options and assist with problem resolution.
- Coordinate resolution of all CC&B related issues.

CC&B Production System Technical Support

- Provide a monthly allocation of hours (i.e., 24 hours per month) to support complex or technical tasks related to environments, infrastructure support, design, development, packaging and deployment of code, etc.

D. Scheduling

E. Contract Price and Payment Terms

The total contract price of this Second Amendment is **\$159,610**. The contract price of this Second Amendment (\$159,610) shall bring the cumulate agreement price to **\$290,120**. The contract price of this First Amendment includes all labor, materials, equipment, and transportation required to perform the work.

The cost for remaining training services shall not exceed \$41,050. Total annual cost for a dedicated BHC FTE plus 40 hours of technical support is \$118,560. Consultant shall submit invoices at a rate of \$9,880 per month. Additional service rates and limitations as detailed in Exhibit 1 shall remain firm throughout the term of this Second Amendment.

EXTENDED SCOPE PARAMETERS

Travel Costs and On-Site Sessions

To account for the possibility of on-site delivery for all eight training sessions, we are including a travel allowance of \$8,000 in the not-to-exceed (NTE) amount. This assumes up to eight two-day trips, at an average of \$1,000 per trip, which covers flights, hotel, and per diem expenses.

Session Duration and Scheduling Flexibility

While sessions are planned for up to three hours, we recognize that City Hall's monthly closures and other scheduling constraints may occasionally require adjustments. To accommodate this, the proposed structure includes an eighth session intended to address spillover topics and emerging priorities. We are fully flexible in selecting alternative dates (such as Fridays) when needed and will coordinate with City staff in advance of each session to assess progress and make any necessary scheduling adjustments.

SOP Documentation Support

Initial development of SOP and training support documentation will be handled by our team for the first two sessions, in collaboration with City staff. We propose an optional allocation of 40 hours (approximately \$5,000) for this work to streamline content and align with existing documentation standards. Any ongoing SOP development following this initial period may be transitioned to internal staff support, led by King.

Training Cost & Prioritization

Each session is estimated at \$5,000, which includes preparation, delivery, and follow-up. If any sessions are held onsite, travel costs would be additional.

For all eight sessions, the total estimated cost is \$40,000 plus travel (if applicable). We understand that funding may drive prioritization, so if you decide to narrow the scope or reduce the number of sessions, we're happy to adjust accordingly.

RECOMMENDATION

Request the City Council adopt Resolution No. 2026-07 approving a budget adjustment to an annual allotment of \$200,000 to the Transportation and Community Safety Commission for implementing projects within the Traffic Management Project List.

ESSENTIAL SERVICE – Yes, Public Works/Infrastructure

COUNCIL PRIORITY – Improve Public Safety

FISCAL ANALYSIS

Increases the annual budget item to the Transportation and Community Safety Commission (“TCSC”) from \$50,000 to \$200,000. These funds are a set-aside from Fund 108 Gas Tax account.

PREVIOUS ACTION

Recommendation by the TCSC on August 7, 2025 to increase annual funding amount from \$50,000 per year to \$200,000 to initiate Safe Routes to School improvements. Previous action by Council was to approve the creation of the Traffic Management Project List program in 2014 at the annual funding level of \$50,000.

BACKGROUND

Since 2014, the Transportation and Community Safety Commission (TCSC) has prioritized and funded traffic safety projects as part of the Traffic Management Project List (TMPL). The annual TMPL budget has been \$50,000 since its inception. This funding has generally been identified for projects focused on pedestrian and school safety.

Since 2014, about 30 projects have been completed around the City at about 50 locations (some 'projects' consisted of improvements like pedestrian countdown signals at multiple intersections).

Each year, the list is initiated by the School Zone Safety Committee, made up the school districts, COMPACT, Escondido Police Department and Traffic Engineering. As examples, over the last three years, 11 projects have been proposed at seven (7) schools, consisting mostly of high-visibility crosswalks, ADA curb ramps and flashing beacons. Another 4 projects were selected to implement speed reduction treatments on Vista Ave, Felicita Ave, Khayyam Rd and Golden Circle Rd. The project selection has always been tailored to meet the \$50,000 annual budget, often with some projects left unfunded.

For the 2025/26 program, the committee discussed the prospects of utilizing a prioritized list of projects generated from the extensive school outreach efforts as part of CATS (Comprehensive Active Transportation Strategy). As part of the Safe Routes to School (SRTS) task from the CATS, a series of school safety audits were completed at 33 schools (public + charter schools) in the City. During these audits, school administrators and parents were invited to meet with the CATS team and discuss safety concerns at each of the schools. The results of those audits generated a very comprehensive list of improvements for the future TMPL program to choose from.

As further background, the Comprehensive Active Transportation Strategy (CATS) project began in 2023, with the intent to perform an intensive look at active transportation deficiencies, as well as opportunities. Staff reported on the intent of the CATS effort in a Traffic Safety Update workshop to Council in August 2023.

One component of the scope of work for CATS was a Safe Routes to School focus. In particular, the CATS team collaborated with the public schools in the City in 2024 and met with administrators and parents to identify problem areas and deficiencies in the vicinity of each of the individual schools. In all, 33 public schools were examined. The team assembled individual plans for each school with suggested improvements that were tuned toward addressing the concerns that were expressed during those individual 'Listening Sessions.' The total cost of Near-Term improvements was estimated at \$1.9 million.

DISCUSSION AND PURPOSE

It was the original intent of the CATS and Safe Routes to School component to utilize the resulting list as an opportunity to identify projects that would be candidates for the TMPL program. With these individual plans now available, staff is recommending that this project list be utilized for the TMPL program moving forward.

For the 2025/26 program discussion at the August 2025 Commission meeting, staff recommended an approach to focus on the highest value improvements: to improve pedestrian crossings on high volume

arterial roadways adjacent to schools. The CATS team had selected certain criteria that were representative of the Safe Routes focus. These criteria included vehicle collisions, pedestrian volumes, and functional classification of the roadway. These criteria identified improvements around the City that exceeded, as expected, the available annual funding. With knowledge of this condition, staff presented the Commission with two options:

- 1) Request City Council approve a temporary increase in the Transportation and Community Safety Commission budget for FY25/26 to \$85,000 to allow for the completion of these high-importance TMPL projects.
- 2) Alternatively, given the breadth of the Safe Routes to School project list, the TCSC could recommend an annual program amount of \$100,000-\$200,000 in order to address a greater number of deficiencies each year.

The commission voted to extend a request to Council to increase the annual appropriation to \$200,000.

WHEREAS, the TCSC recognized the current allotted funding for the TMPL would not be sufficient to make meaningful progress with accomplishing the substantial list of improvements needed at all City schools; and

WHEREAS, the TCSC recommended staff to seek Council approval to increase the annual appropriation from \$50,000 to \$200,000 in order to make meaningful progress to construct school safety improvements; and

WHEREAS, TCSC annual allocations are funded by the Gas Tax fund; and

WHEREAS, sufficient funds are available within the Gas Tax fund to allow the increase in annual allocations to the TCSC; and

WHEREAS, staff recommends Council increase the annual TCSC allocation to \$200,000 for Citywide school safety projects.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Escondido, California, as follows:

1. That the above recitations are true.
2. That the City Council approves a budget adjustment to an annual allotment of \$200,000 to the Transportation and Community Safety Commission for implementing projects within the Traffic Management Project List.



SUBJECT:

COMPREHENSIVE ACTIVE TRANSPORTATION STRATEGY (CATS) PROJECT UPDATE AND TMPL PROPOSAL

LOCATION:

Various Locations Citywide

BACKGROUND:

The Comprehensive Active Transportation Strategy (CATS) project began in 2023, with the intent to perform an intensive look at active transportation deficiencies as well as opportunities. Staff have reported on various stages of the CATS effort over the last year and a half.

One component of the initial scope of work was a Safe Routes to School focus. In particular, the CATS team collaborated with the public schools in the City in 2024 and met with administrators and parents to identify problem areas and deficiencies in the vicinity of each of the individual schools. In all, 33 public schools were examined. The team assembled individual plans for each school with suggested improvements that were tuned toward addressing the concerns that were expressed during those individual 'Listening Sessions.' The total cost of Near-Term improvements was estimated at \$1.9 million.

As further background, the commission is aware that starting back in 2014, City Council has set aside a \$50,000 budget for traffic safety related projects under the Traffic Management Program List (TMPL). This list and this process have resulted in an impressive list of improvements around the City.

DISCUSSION AND PURPOSE:

It was the original intent of the CATS and Safe Routes to School component to utilize the resulting list as an opportunity to identify projects that would be candidates for the TMPL program. With these individual plans now complete, staff is recommending that this project list be utilized for the TMPL program moving forward.

For the 2025/26 program, staff is recommending an approach to focus on the highest value improvements: to improve pedestrian crossings on high volume arterial roadways adjacent to schools. The CATS team has selected certain criteria that are representative of the Safe Routes focus. These criteria include vehicle collisions, pedestrian volumes, and functional classification of the roadway.

Pedestrian crossing projects were selected in each of four quadrants of the city.

- District One (North Ash St and Lincoln Ave crossing improvements benefit these schools):

- Farr Elementary School
- Pioneer Elementary School
- Mission Middle School
- District 2 (El Norte Pkwy and Valley Parkway):
 - Valley High School
- District 3 (S Broadway and E 4th Ave):
 - Central Elementary School
- District 4 (W Valley Pkwy and 9th):
 - Del Dios Academy

Total cost of these improvements is \$85,000, which exceeds the \$50,000 annual allotment for the TMPL program.

RECOMMENDATION:

Request City Council approve a temporary increase in the Transportation and Community Safety Commission budget for FY25/26 to \$85,000 to allow for the completion of these high-importance TMPL projects.

Alternatively, given the breadth of the Safe Routes to School project list, the TCSC could recommend an annual program amount of \$100,000-\$200,000 in order to address a greater number of deficiencies each year.
