Vice Chair Ashcraft asked why they need another workshop and why it needs to be deferred.

Chairman Hawkins explained that CRA funds were used to purchase the downtown property.

Discussion was held regarding the CRA downtown master plan and what it is used for.

Sasha Garcia, City Attorney, explained that the CRA does own the lots and this would be a recommendation to the Commission for incorporation of the downtown master plan into the redevelopment plan. She explained that would be necessary to allow the use of CRA funds.

Chairman Hawkins agreed that they need to be more informed prior to considering the plan.

Tanya Wilder, CRA East Town Representative, agreed with the need to obtain more information.

Al Latimer, Economic Development Director, explained the master plan, once approved, would be adopted into the redevelopment plan. He stated the redevelopment plan is what governs how the CRA may spend its money.

Chairman Hawkins opened the floor to public comment. No one came forward at that time.

Plan Developed by MIG, Inc.

#### Overview

The 2025 Downtown Master Plan provides a conceptual context to guide future growth and development. It outlines future land uses, building projects, and community improvements and enhancements. The proposed development options included in the Master Plan are based on the City's uniqueness. The plan was derived from public input, analysis of planning initiatives, existing development, physical characteristics, and social and economic conditions.

# **Background**

An RFQ was issued on July 8, 2022 to find a developer for the 4.58 acres the former Waterman Hospital Site in downtown Eustis. Two companies responded to the solicitation and a City Staff Review Committee selected G3C2 as the top choice. The members of the City staff review committee were: Tom Carrino, City Manager, Rick Gierok, Public Works Director, Mike Lane Development Services Director, Al Latimer, Economic Development Director, and Mike Sheppard, Finance Director with Purchasing Director Tracy Jeanes as facilitator.

In order to develop a market-based, shared vision for the Waterman site and downtown, it was agreed that a master plan process was necessary. To help create a cohesive guide for future development projects G3C2 and City staff interviewed two firms to develop the Eustis Downtown Master Plan. MIG was the firm selected for the project.

#### **Duration**

The development of the Master Plan was projected to take nine-months to complete, beginning in June 2023 and ending in February 2024. However, due to a number of unanticipated scheduling conflicts, changes in personnel, illnesses and weather events the project took 18 months to complete.

The Eustis Downtown Master Plan marks a pivotal step toward revitalizing the city center while preserving our unique charm. With a clear vision in place, once the plan has been approved, the CRA Board can focus on the implementation phase, addressing infrastructure needs, development projects, and funding strategies. Ongoing community input will continue to help guide details and ensure alignment with our community values. As projects move closer to construction, collaboration between all stakeholders

will be key to transforming the Downtown Master Plan vision into a vibrant, sustainable downtown for Eustis.

# **Community Feedback**

MIG's presentation of the final draft of the master plan at a November 14, 2024 community meeting was very favorably reviewed by over 100 residents.

#### Introduction:

With the completion of the Master Plan and the beginning of the implementation phase, which includes entering into a development agreement with G3C2, a workshop was held on Monday, January 13 for Commissioners to hear a presentation from a development and redevelopment real estate consultant. Mike Goman of Goman & York spoke about the diverse range of specialized expertise needed to ensure that development projects meet commission goals and community needs and expectations.

After the presentation, Commission agreed that hiring a development and redevelopment real estate consultant would be in the best interest of the City and its development efforts.

Following up on the Commission's wishes, staff posted a bid solicitation for development and redevelopment real estate consultants. Five companies responded to the solicitation. Goman & York was selected by a staff review committee as the firm to provide the range of services listed on Attachment A.

Staff estimates that \$80,000 will be needed through the end of the fiscal year. Currently, there is only \$15,000 available in the CRA budget for Professional Services. Therefore, another \$65,000 needs to be transferred from CRA Reserves for Future Projects. As of September 30, 2024, the CRA Reserves for Future Projects was \$3,604,127.

### **Recommended Action:**

Staff recommends Commission approve the budget transfer as part of CRA Resolution Number 25-01.

# **Attachment A**

Real Estate Consultant Services may include, but not be limited to, the following:

- 1. Analysis & assistance in implementing and executing various plans to include:
  - Downtown Master Plan
  - CRA Redevelopment Plan
  - City's Comprehensive Plan
- 2. Evaluate LDR's, regulations, design guidelines, etc., to determine impact on development and redevelopment.
- 3. Examining market conditions for real estate development in Eustis, Florida, focusing on the residential, retail, office, and industrial uses that exist in the City and market trends such as changes in rents, sale prices, vacancy, and the rate of absorption.
- 4. Identifying and assessing potential deal structures and valuations for redevelopment properties, potential incentives, including an evaluation of any applicable statutory provisions that would impact the ability of the City to participate in them.
- 5. Assist the City with any current and future development proposals, including evaluating the value, financial implications, and project pro-forma statements from any current and potential development partners, ground lessees, or other stakeholders. Upon consultant's selection, should the City have existing contractual obligations with a developer(s) falling within the scope of the consultant's services, the consultant shall work with the City's chosen developer(s) in good faith, ensuring the City's compliance with its duties and commitments to said developer(s).
- 6. Analyzing the implications of exercising different public policy levers on development, including the impact of affordable housing, changes to tax abatement programs, and alternative financing structures.
- 7. Developing narratives to support engagement and negotiations with key stakeholders and attending and participating in meetings with key stakeholders.
- 8. Supporting the City in the negotiation of key business terms and agreements in its real estate transactions.
- 9. Evaluating assessed valuations, incentives/tax abatements, and tax rates for residential and commercial properties.
- 10. Preparing revenue forecast reports in connection with financing activities and making presentations of such reports.
- 11. Preparing, or causing to be prepared, feasibility reports, appraisals, market analyses, or any other real estate related reports.
- 12. Attend meetings (internal and external) and telephone conferences as necessary.

#### **CRA RESOLUTION NUMBER 25-01**

A RESOLUTION OF THE COMMUNITY REDEVELOPMENT AGENCY OF THE CITY OF EUSTIS KNOWN AS THE DOWNTOWN AND EAST TOWN REDEVELOPMENT AGENCY, LAKE COUNTY, FLORIDA, APPROVING A RESOLUTION AMENDING THE CRA BUDGET FOR FISCAL YEAR 2024/25 FOR THE CRA TRUST FUND AND ESTABLISHING A BUDGET FOR DEVELOPMENT AND REDEVELOPMENT RELATED REAL ESTATE CONSULTING SERVICES; AND PROVIDING FOR AN EFFECTIVE DATE.

**WHEREAS**, the Downtown and East Town Redevelopment Agency (Agency) has identified the need for Development & Redevelopment Related Real Estate Consulting Services; and

**WHEREAS**, the City Commission did authorize the City Manager to hire a Development & Redevelopment Related Real Estate Consultant; and

**WHEREAS**, a Development & Redevelopment Related Real Estate Consultant will provide services, expert advice and guidance in analyzing & assisting the implementation and execution of various plans, including the Downtown Master Plan and the CRA Redevelopment Plan; and

**WHEREAS**, on January 24, 2025 the Purchasing Department posted a bid solicitation for Development & Redevelopment Related Real Estate Consultant, and five (5) companies responded; and

WHEREAS, Goman & York was selected as the firm to provide the services; and

**WHEREAS**, staff estimates that the amount needed to pay for needed services is \$80,000; and

**WHEREAS**, only \$15,000 is available within existing budgeted funds for Professional Services: 014-1230-516-30-31, and there is a remaining need for \$65,000; and

**WHEREAS**, it is in the best interest of the City and the Agency to allocate these funds to support the work of the Development & Redevelopment Related Real Estate Consulting Services; and

**WHEREAS**, the funds will be transferred from CRA Reserves For Future Projects; and

**WHEREAS**, the FY 2024/25 adopted budget for the CRA Trust Fund Fund (014) will be amended as follows:

# **Expenditures:**

014-1230-516-30-31 - Operations Expense - Professional Services - \$65,000

**NOW, THEREFORE, BE IT RESOLVED,** by the Downtown and East Town Redevelopment Agency as follows:

#### Section 1

That the FY 2024/25 Adopted Budget for the CRA Trust Fund is amended to reflect a transfer of \$65,000 from one operations line item in the Fund to another within the Fund.

#### Section 2

That the Finance Director of the City of Eustis is hereby authorized to amend the FY 2024/25 adopted budget for the CRA Trust Fund.

#### Section 3

That this Resolution shall take effect immediately upon its adoption.
