#### **BACKGROUND INFORMATION:**

The Everman Police Department is currently being faced with an unprecedented staffing shortage that has had a significant negative impact on the department and operations. This fiscal year, the Everman ISD approved three additional School Resource Officers. This created three vacancies within the department that we have not been able to fill. Additionally, one patrol officer has accepted a position with the Parker County Sheriff's Office. Another patrol officer is currently in the hiring phase with the Fort Worth Police Department, and a third has submitted notice that he is also applying with another agency. Nearly all law enforcement agencies in the DFW area are hiring right now, which makes the competition for recruitment that much more difficult. Administrative Staff is working diligently on this issue, however, in the meantime, the current patrol officers and supervisors have been carrying the burden.

Currently, we have several officers who are working 7-10 days straight before having a complete day off. We are spreading the workload as evenly as possible, however, this increased workload is detrimental to the morale of the department. Department morale is of paramount importance in the recruitment and retention of employees.

Staff is proposing the implementation of a one-time retention pay event for the Police Department. The purpose of these funds is to provide additional compensation to police department employees for their incredibly hard work during these difficult times. Staff believes that this proposal will assist with showing current employees that their efforts during this time are truly appreciated.

#### THE PROPOSAL:

Everman Police Department employees at the rank of Sergeant and below will receive a Retention Pay Compensation in the amount of \$3,000.00. This bonus will be paid in two equal payments occurring on November 15<sup>th</sup>, 2022 and December 15<sup>th</sup>, 2022. In order to qualify for the additional compensation, employees must meet the following criteria:

- A) Employed Full-Time by the City of Everman at the time the payments are distributed
- B) Not be under disciplinary suspension or disciplinary probation

- C) Have not submitted a written notice of termination of employment
- D) Employed prior to November 2, 2022 for payment #1
- E) Employed prior to November 30, 2022 for payment #2

The total fiscal impact for this proposal is estimated to be \$43,500, however, this amount will be offset due to extensive salary savings that exist from the currently vacant positions.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF EVERMAN, TEXAS, AUTHORIZING THE IMPLEMENTATION OF A RETENTION COMPENSATION POLICY FOR THE EVERMAN POLICE DEPARTMENT TO REDUCE EMPLOYEE ATTRITION BY PROVIDING A BONUS TO QUALIFIED POLICE OFFICERS; PROVIDING FOR THE REPEAL OF ANY AND ALL RESOLUTIONS IN CONFLICT; PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING FOR AN EFFECTIVE DATE.

**WHEREAS**, it is in the best interest of the citizens of the City of Everman to have a fully staffed Police Department; and

WHEREAS, the Police Department is experiencing a chronic and significant staffing shortage which is placing great demands upon the current Everman Police Department personnel; and

**WHEREAS**, the Police Department seeks to be more competitive by offering a retention and stability bonus to qualified police officers; and

**WHEREAS,** in an effort to hire and retain qualified, dedicated, and dependable police personnel, the City Manager recommends implementing a Retention Compensation Policy that would provide a retention bonus under the terms set forth in the policy, attached hereto as Exhibit A; and

**WHEREAS,** the City Council finds it is in the best interest of the citizens of the City of Everman that a Retention Compensation Policy be implemented under the terms and conditions of the Policy attached hereto as Exhibit A;

## NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF EVERMAN, TEXAS, THAT:

**SECTION 1.** The City Council hereby approves and authorizes the immediate implementation of the Retention Compensation Policy for the Everman Police Department attached hereto and incorporated herein by this reference as Exhibit "A" and specifically authorizes the City Manager to implement said policy by providing to the Police Department personnel identified in Exhibit "A" the November 15, 2022 and December 1`5, 2022 retention compensation payments) for which they qualify based on the following criteria:

- 1. Must be continuously employed full-time by the City of Everman, for the November 15, 2022 payment, since November 2, 2022 and, for the December 15, 2022 payment, since November 30, 2022;
- 2. Must not be under any disciplinary suspension or probation, for the November 15, 2022 payment, at any time from November 2, 2022 to November 15, 2022 and, for the December 15, 2022 payment, at any time from December 1, 2022 to December 15, 2022; and

3. Must not have submitted a written notice of termination of employment at any time prior to date of payment.

**SECTION 2.** All resolutions of the City of Everman heretofore adopted which are in conflict with the provisions of this resolution are hereby repealed and all resolutions of the City not in conflict with the provisions hereof shall remain in full force and effect.

**SECTION 3.** If any article, paragraph, subdivision, clause or provision of this resolution be adjudged invalid or held unconstitutional for any reason, such judgment or holding shall not affect the validity of this resolution as a whole or any part or provision thereof other than the part so declared to be invalid or unconstitutional.

**SECTION 4.** This resolution shall take effect immediately from and after its passage.

## EXHIBIT "A" [Retention Compensation Policy]

### AN ORDINANCE OF THE CITY OF EVERMAN, TEXAS ORDINANCE NO. 792

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF EVERMAN, TEXAS, AMENDING THE CODE OF ORDINANCES OF THE CITY OF EVERMAN, TEXAS BY ADDING A NEW SECTION 2-72 "SENIOR CITIZENS ADVISORY BOARD" TO ARTICLE V "BOARDS AND COMMISSIONS" OF CHAPTER 2 "ADMINISTRATION"; PROVIDING A SEVERABILITY CLAUSE, PROVIDING A REPEALING CLAUSE; AND PROVIDING FOR AN EFFECTIVE DATE.

**WHEREAS,** the City Council determines that the City's government functions in a manner that best serves the needs of the community when interested citizens participate and assist in advising the Council; and

**WHEREAS**, the City Council desires to seek the input of its senior citizens on municipal government issues; and

**WHEREAS,** the City Council has determined that a Senior Citizens Advisory Board should be created to serve the City Council in an advisory capacity and to perform the duties set forth herein;

## NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EVERMAN, TEXAS, THAT:

**SECTION 1**. The Code of Ordinances of the City of Everman, Texas is hereby amended by adding a new Section 2-72 "Senior Citizens Advisory Board" to Article V "Boards and Commissions" of Chapter 2 "Administration", to read in its entirety as follows:

"

#### "Section 2-72 Everman Senior Citizens Advisory Board

- (a) Creation and purpose. There is hereby created a Senior Citizens Advisory Board for the City of Everman, Texas. The purposes of the Senior Citizens Advisory Board shall be:
  - (1) To act in an advisory capacity to the City Council in matters pertaining to the City's senior citizens;
  - (2) To help identify the needs of senior citizens and enhance their quality of life within the City;
  - (3) To use all available resources to inform senior citizens of community services; and

(4) To coordinate and plan community events for senior citizens of the City.

#### (b) Membership.

- (1) Members of the Board shall be appointed by a majority vote of the City Council. The Board shall consist of seven (7) regular members. Initially, three members shall be appointed to serve a one-year term and four members shall be appointed to serve a two-year term. Thereafter, all appointments shall be made for two-year terms. Members may be reappointed to successive two- year terms. Members serve at the pleasure of the City Council and may be removed by majority vote of the City Council with or without cause. The City Council shall, by majority vote, appoint a replacement to fill any vacancy for the unexpired term of a member whose position on the Board becomes vacant.
- (2) Members of the Board must meet the following qualifications:
  - (i) Be a qualified voter of the City;
  - (ii) Shall have resided in the corporate limits of the City for at least one (1) year prior to appointment;
  - (iii) Continue residency in the City during the term of office;
  - (iv) Shall not be delinquent in payment of City taxes or financially delinquent to the City; and
  - (v) Shall achieve compliance with all city codes prior to appointment and maintain such compliance for the duration of the appointment..
- (c) Organization, rules and requirements.
  - (1) On or before January 9 of each year, the membership of the Board shall determine, by majority vote, a chair and a vice chair. The terms of the chair and vice chair shall be one (1) year. It will be the duty of the chair to preside over meetings and to assist in setting meeting agendas. If the chair is absent or unable to perform the duties of the chair, the vice chair shall assume the duties of that office.

- (2) Members of the Board shall meet at least one (1) time per month, on a regular day and time selected by majority vote of the members. The chair may call special meetings as necessary.
- (3) The Board shall conduct meetings and govern its proceedings according to the City Council's adopted rules of order, abide by the Texas Open Meetings Law, and shall keep a record of its proceedings, including votes and attendance, and shall submit these records to the City Secretary's Office.
- (4) Members of the Board shall not take any action unless a quorum is present. A quorum shall consist of four (4) members. Each member, including the chair, is entitled to one(1) vote, and action of the Board shall require an affirmative vote of a majority of those members present.
- (5) The City Manager shall designate a City employee to serve as staff liaison to the Board.
- (6) Members of the Board may receive reimbursement of authorized expenses attendant to the performance of their duties.
- (d) Powers and Duties.
  - (1) The Board is advisory only and shall not have any decision-making authority.
  - (2) The Board shall have the following duties:
    - To study and identify the needs of senior citizens with the aim of enhancing their quality of life within the City and to advise the City Council thereon;
    - (ii) To recommend to the City Council city/community events and programs designed to meet the needs of senior citizens;
    - (iii) To originate, plan, and coordinate City Council approved programs and events for the senior citizen segment of the population. Efforts should be made by the Board to assure that all recommendations will utilize existing facilities and organizations within the city in order to provide recreational, leisure, educational, community, and other community events and programs to the senior citizen residents of the City. If the Board determines that using facilities or organizations outside of the Everman city limits is necessary, it shall include in its

recommendation to the City Council an explanation as to the reasons for such necessity;

- (iv) To act with and assist other municipal boards, staff, or regional associations and the City Council in formulating proper plans for community programs and events to meet the needs of senior citizens;
- (v) To aid and assist in informing senior citizens of community services, events and programs; and
- (vi) As may be necessary to accomplish these duties, the Board may establish subcommittees. Any subcommittee shall be chaired by a Senior Citizens Advisory Board member. An unspecified number of community volunteers may be chosen by the Board as working subcommittee members."

**SECTION 2.** Should any word, sentence, paragraph, subdivision, clause, phrase or section of this ordinance, be adjudged or held to be void or unconstitutional, the same shall not affect the validity of the remaining portions of said ordinance which shall remain in full force and effect.

**SECTION 3.** All ordinances of the City of Everman, Texas, in conflict with the provisions of this ordinance be, and the same are hereby, repealed; provided, however, that all other provisions of said ordinances not in conflict with the provisions of this ordinance shall remain in full force and effect.

**SECTION 4.** This ordinance shall take effect immediately from and after its passage, as the law and charter in such cases provide.
