BACKGROUND INFORMATION:

In recent weeks, the Tarrant County Regional Communications Dispatch Center has experienced some server failures and delays. The server failures and delays significantly impact the operations and call taking procedures of the center. The servers that are utilized are dated and no longer servicable because they have reached their "end-of-life" according to manufacturers.

Beverly Patton, the Director of Communications, has worked with our contracted I.T. company which services these servers. The company is NetGenius and the City has previously engaged in a professional services agreement with this company. They have provided a quote for replacement servers that are upgraded from the current versions. These servers will actually combine existing servers, limiting future costs. It is being requested that we purchase two servers, in order for us to maintain redundancy and stability. These servers will support one another. We do this so that in the event one of these servers was to fail, there is a secondary server to maintain emergency operations and call-taking and dispatching capability. The quote for the hardware and software on attached. The City of Everman is already paying for professional services that will include the installation and future maintenance of these machines.

FISCAL IMPACT:

The cost for these servers, to include software and licensing, is \$65,447.99. There is funding available within the Dispatch Capital Improvement Fund, which is a city-designated restricted fund solely dedicated for the purposes of these upgrades. Staff is proposing that this allocation come from that fund. If approved, a budget amendment would later follow reflecting such.

WHEREAS, the immediate procurement of goods and services related to replacement of the failed dispatch server is necessary for (i) the preservation of the public health and safety of the City's residents and (ii) the repair of unforeseen damage to public machinery, equipment, or other property, and, pursuant to Texas Local Government Code §§252.022(a)(2) and (3), such procurement shall be exempt from the bidding requirements set forth in Chapter 252 of the Texas Local Government Code; and

WHEREAS, the City Manager has negotiated an agreement on behalf of the City with Net Genius, Inc. in the amount of \$65,447.99 for the needed server replacement and related and necessary software; and

WHEREAS the City Council of the City of Everman, Texas, finds it to be in the public interest to approve said agreement with Net Genius, Inc. and to authorize the City Manager to execute said agreement and any necessary additional agreements and change orders relating to the repair.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF EVERMAN, TEXAS, THAT:

SECTION 1. An emergency exists under Texas Local Government Code §§ 252.022(a)(2) and (3) with regard to the urgent need for immediate replacement of the City's dispatch server;

SECTION 2. The Proposal and Cost Schedule with Net Genius, Inc. in the amount of \$65,447.99, attached hereto and incorporated herein by this reference as Exhibit "A", is hereby approved and execution by the City Manager of the Proposal and Cost Schedule which shall become part of the City's existing Managed Services Agreement with Net Genius, Inc., is hereby approved and ratified along with his execution of any other necessary and related documents. Payment for the goods and services in an amount not to exceed \$65,447.99 by the City Manager on behalf of the City is further authorized and ratified, such to be paid from current funds available for such purposes

SECTION 3. This Resolution shall be effective immediately upon passage.



BACKGROUND INFORMATION:

The City of Everman is currently engaged in a professional service agreement with Nichols Jackson Law Firm for legal services. Victoria Thomas currently serves as our primary City Attorney and is also a partner with the firm. AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF EVERMAN, TEXAS, CHAPTER 2 "ADMINISTRATION", ARTICLE II "COUNCIL", BY AMENDING SECTION 2-21 "MEETINGS", SUBSECTION (a); PROVIDING FOR THE REPEAL OF ALL ORDINANCES IN CONFLICT; PROVIDING A SEVERABILITY CLAUSE; PROVIDING A SAVINGS CLAUSE; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Section 3.08 of the Home Rule Charter provides that the City Council shall hold at least one regular meeting each month with the time and place of that meeting to be established by ordinance or resolution; and

WHEREAS, in accordance with the Charter, the City Council previously adopted an ordinance, codified at section 2-21 which was subsequently amended by Ordinance 776 on December 14, 2021 to provide that the Council shall hold its regular monthly meeting on the first and third Tuesdays of each month at 6:30 p.m.; and; and

WHEREAS, the City Council of the City of Everman, Texas, has determined that it is in the best interest of the City and serves the general welfare of the citizens to amend the Code of Ordinances to change the date and time that regular Council meetings shall be held;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EVERMAN, TEXAS:

SECTION 1: That the Code of Ordinances of the City of Everman, Texas is hereby amended at Chapter 2 "Administration", Article II "Council", by amending Section 2-21 "Meetings" .02.001 "Meetings", Subsection (a) to read as follows:

"CHAPTER 2 ADMINISTRATION

. . .

ARTICLE II COUNCIL

Sec. 2-21 - Meetings.

(a) The city council shall hold regular meetings on the _____ and _____ of each month at 6:30 p.m. and may hold as many additional meetings and workshops as it deems necessary to transact business.

. . . ."

SECTION 2: All ordinances, orders, or resolutions heretofore pass and adopted by the City Council of the City of Everman, Tarrant County, Texas are hereby repealed to the extent that said ordinances, orders, or resolutions, or parts thereof, are in conflict herewith.

SECTION 3: Should any word, sentence, paragraph, subdivision, clause, phrase or section of this ordinance be adjudged or held to be void or unconstitutional, the same shall not affect the validity of the remaining portions of said ordinance, which shall remain in full force and effect.

SECTION 5. This ordinance shall be effective from and after its passage.
