#### 1. Staff Report - Fire Service Operations - Fire Chief Landon Whatley

Chief Landon Whatley came today to talk about the Fire Operations for the city. Landon had a PowerPoint showing them how they can become a firefighter. The commission agrees that this should be talked about more at the school so that this Program could possibly come to the school for any students looking into these types of professions.
