 - a. What organization received the money? Johnnie Allen asked if it went to the FUMC Hanging Out; will check on that.

- D. 35th Anniversary
 - a. Library opened in 1987
 - b. Plan to hold city anniversary Oct. 1st; will showcase the books, movies, magazines, etc. available in the library to citizens
- E. Library Hours
