## **Chapter 5: Subdivision Design Standards**

- a) P&Z Chairperson, Bobbe Barnes, opened the public hearing at 6:36 PM.
- b) Consultant, Lata Krishnarao, provided a presentation of the proposed amendments to Chapters 4-5 of the UDC.
- c) P&Z Commission received citizen testimony from the following against the proposed amendments:
  - Tim Taylor, resident, spoke against the proposed amendments to Chapter 4 regarding horse boarding and how the proposed amendments exclude the ability for residents to receive payment for housing another person's horse on their property. Mr. Taylor was granted a special use permit that allows him to do so.
  - Wayne McEwen, resident, spoke against the proposed amendments and doesn't believe that the state should have any say on Spring Creek Church's property. He also agreed with the comments made by Mr. Taylor.
  - John McCune, resident, spoke against the proposed amendments as it prohibits a resident to use their property commercially although he currently does not use it for that purpose.
  - Jesus Rodriguez, resident, spoke against the proposed amendments and agreed with the previous speakers and hopes that the Commission considers their comments.
  - Carlos Castillo, resident, spoke against the proposed amendments as they relate to mixed use developments and the impact they would have on the crime rate.

- e) P&Z Commissioners discussed the amendments, inclusive of questions of the legal counsel, Cynthia Trevino, and consultant, Lata Krishnarao.
