AGENDA TOPIC: Consideration and possible action approving a Heritage Tree Plan for the Fox

Falls Off-Site Gravity Sewer Project.

DATE: October 5, 2023

#### **INTRODUCTION/BACKGROUND:**

The Fox Falls Off-site Gravity Sewer project is a San Antonio Water System (SAWS) utility project consisting of over two miles of sewer line upgrades between Fair Oaks Village (IH-10 Frontage Road and Fair Oaks Parkway) and Old Fredericksburg Road. The upgrades will cross through Fair Oaks Parkway, Frost Bank, Leslie Pfeiffer Drive and The Woods at Fair Oaks neighborhood and will require tree removal to accommodate the larger sewer line. This project is being completed within existing SAWS utility easements, originally dedicated in 2008 within The Woods at Fair Oaks.

On May 5, 2023, a Tree Preservation Plan and Heritage Plan for the Fox Falls Off-Site Gravity Sewer was submitted to the Public Works Department by M.W. Cude Engineers, LLC **(Attachment A)** on behalf of the applicant Meritage Homes of Texas, L.P.

As outlined in UDC Section 8.8, tree mitigation shall be at a 1:1 ratio for Tree Circumference (TC) inches to be removed. In cases where soil, slope, lot size, or other natural constraints make replacing the same number of Tree Circumference (TC) inches unfeasible, the City Manager (or designee), may allow some or all the mitigation to take place on a separate, public site within the City, or on lands owned by an association that operates and maintains trails, open space, or parkland within the City. In addition, the City Manager (or designee) may allow mitigation by payment of fee for some or all the trees to be removed, if the City's fee schedule includes a provision for Fee-In-Lieu of Replacement Trees.

The applicant has voiced concerns regarding the replanting of mitigation trees within the utility easements since they may interfere with future maintenance requirements or cause damage to the underground sewer line. Additionally, the applicant stated they attempted to find an alternate location for replanting but no resolution with The Woods HOA or FORHA was reached.

On August 17, 2023, Cude Engineers requested to move forward with the plans with the intention that mitigation shall be met through a Fee-In-Lieu of Replacement Trees.

This plan submission is subject to the City's UDC adopted in 2019. Section 8.8 contains an exemption for preservation requirements for trees in utility easements but states the following requirements: "A Heritage Plan is required to be reviewed and approved by the Planning and Zoning Commission and City Council prior to any construction activity that is likely to endanger a Heritage Tree, TC 75 inches or larger...A Heritage Plan must be submitted to the City, reviewed by City Staff, and voted on by the Planning and Zoning Commission before a Preliminary Plat or Site

Development Permit is forwarded to City Council." The submitted Heritage Plan shows the following Heritage Trees:

To mitigate, the applicant has requested to pay a fee-in-lieu. Based on the below fee-in-lieu schedule, the payment for removing heritage trees is estimated to be \$82,400.

#### **Applicable UDC Sections**

Section 8.8 (6)(b) states:

"b. A Heritage Plan must be submitted to the City, reviewed by City Staff, and voted on by the Planning and Zoning Commission before a Preliminary Plat or Site Development Permit is forwarded to City Council. It must be approved by City Council before a Final Plat is approved."

Section 8.8(2)(b) states:

- "Preservation Exemptions. The following areas are exempt from the preservation requirements of this section:
  - i. <u>Right-of-way.</u> Trees located within a right-of-way to be dedicated to and maintained by the City; and
  - ii. <u>Easements.</u> Trees located within any utility easement"

Section 8.8 (7) states:

"a. Removal by Right. Protected Trees, including Heritage Trees, located within 10 feet of the perimeter of the proposed building footprint, the area over an OSSF, areas necessary for site access, or within areas designated for the construction or installation of public facilities

### such as streets or utilities may be removed at the discretion of the applicant, provided that the terms of Sections 8.8(7)b-c. (below) are satisfied;

b. Removal and Mitigation of Protected Trees. Developers of land are encouraged to preserve protected trees whenever possible. An applicant may remove Protected Trees if approved mitigation is provided. Generally speaking, mitigation shall be at a 1:1 ratio for TC inches to be removed. The applicant may plant smaller trees to replace Protected Trees, provided that no tree smaller than TC 8 inches is generally allowed, and that the total tree coverage on the lot (as measured in TC inches) is approximately the same as pre-development conditions. In cases where soil, slope, lot size, or other natural constraints make replacing the same number of TC inches unfeasible, the City Manager (or his designee), may, at their sole discretion, allow some or all of the mitigation to take place on a separate, public site within the City, or on lands owned by an association that operates and maintains trails, open space, or parkland within the City and that are usable by residents of the general area where the applicant's land is located. In addition, the City Manager (or designee) may allow mitigation by payment of fee for some or all of the Protected Trees to be moved, if the City's fee schedule includes a provision for Fee In Lieu of Replacement Trees.

- c. Removal and Mitigation of Heritage Trees.
- i. Heritage Trees may not be removed during construction, except under certain specific circumstances:
  - 1. If the tree is sick or diseased and meets the criteria laid out in Section 8.8(4); or
  - 2. If the tree is within the footprint as described in Section 8.8(7)a; or
  - 3. If the removal is approved by the City Council after consideration by the P&Z, with a formal recommendation from the P&Z to the Council on whether to approve the removal.

ii. If any Heritage Trees are planned for removal, they must be identified and clearly marked on the Heritage Plan. The Heritage Plan must also identify any Heritage Trees that are likely to be endangered by construction activity which might sever or compress the root zone, or otherwise threaten the health and life of the tree, as determined by a reasonable person. The City Council may grant removals under Section 8.8(7)c.i-3 (above) at its sole discretion. In considering whether to allow the removal of Heritage Trees, the City Council shall consider whether removal is absolutely necessary to allow the applicant to meet reasonable, investment-backed expectations for use of the property, and whether such use can be accomplished while preserving Heritage Trees.

# iii. If any Heritage Tree removals are granted, the applicant shall meet all the mitigation and replacement conditions outlined in 8.8(7)b. (above), except that any decisions delegated to the City Manager in that paragraph shall be made by the City Council."

On September 14, 2023, the Planning and Zoning Commission recommended approval of the Heritage Plan with the condition that mitigation be met by payment of the fee-in-lieu once adopted by City Council. The ordinance amending the City of Fair Oaks Ranch Code of Ordinances Appendix A "Fee Schedule," Article A8.000 "Subdivision/Land Development Regulation Fees," to include establishment of a fee-in-lieu, was approved and adopted at the September 21, 2023 City Council meeting.

#### **POLICY ANALYSIS/BENEFIT(S) TO CITIZENS:**

The applicant has met the requirements of the Heritage Plan as stated in section 8.8. As a utility, the applicant is exempt from Preservation requirements. However, the applicant is still subject to mitigation requirements. Replacing trees is not practical because the parcel is in a utility (sewer) easement and public land is not available for replanting. Therefore, a Fee-In-Lieu of Replacement Trees is the most viable option.

The Planning and Zoning Commission recommended approval at its meeting of September 14, 2023.

#### **LONGTERM FINANCIAL & BUDGETARY IMPACT:**

An estimated \$82,400 would be available for the City Council to initiate a tree preservation program for such activities including, but not limited to, right-of-way tree maintenance, brush removal, oak wilt remediation, and citywide tree planting. A workshop to discuss potential options is planned later this month.

#### INTRODUCTION/BACKGROUND:

The City Council reviewed the FY 2024-28 Proposed Capital Improvements Plan (CIP) during a budget workshop on July 20, 2023. The City Council also reviewed financing scenarios and a draft timeline for approving the plan and issuing debt to finance the plan. The Capital Improvements Advisory Committee ("CIAC") reviewed a similar plan at its semiannual meeting on September 7, 2023. CIAC expressed its desire at that meeting to serve as a bond advisory committee to include review of impact fee and non-impact fee eligible projects.

The CIP contains about \$34 million in planned projects, of which nearly \$14 million would be supported by the General Fund. General Fund-supported projects include roadways, drainage, and buildings. The CIP identifies about \$20 million for Water and Wastewater projects.

The proposed resolution designates members of CIAC to serve as the ad hoc Bond Advisory Committee to the Council. If the City Council adopts the resolution, members will meet multiple times over the next several months to review the proposed CIP projects for scope and need.

The resolution also directs the City Manager to develop financing options by February 2024. Staff and committee members will review potential options including General Obligation (GO) Bonds, Certificates of Obligation (CO's), and Revenue Bonds. GO Bonds require voter approval prior to issuing debt. GO Bonds are **not** required. The City can issue CO's at virtually identical terms to GO Bonds without an election (although CO's are subject to petition of referendum). However, if the City Council chooses to use GO Bonds, the City must call an election by February 2024 to meet the May 2024 election date. This would allow the City to incorporate debt service into its FY 2024-25 Adopted Budget. If the City Council opts for CO's or other forms of financing, the timeline is less stringent.

#### **POLICY ANALYSIS/BENEFIT(S) TO CITIZENS:**

A long-term CIP provides specific direction and financing to maintain the City's *existing* infrastructure with stable financing. A Bond Advisory Committee, while optional, can provide neutral recommendations to the City Council on project needs, scope, timing, and financing. The resolution also furthers the following elements of the Strategic Action Plan.

- Project 1.2.3 of the Strategic Action Plan to Develop 5 Year CIP Projections
- Project 1.4.11 of the Strategic Action to Develop a long-term capital and debt financing plan
- Pillar 3 of the Strategic Action Plan for Reliable and Sustainable Infrastructure

#### LONG-TERM FINANCIAL & BUDGETARY IMPACT:

The proposed CIP includes 35 projects estimated at a total of \$34 million. Coupled with conservative cash funding, this would require estimated annual debt payments of \$1 million in the General Fund and \$1.5 million in the Utility Fund once the plan is fully implemented. The City would appropriate debt service annually in the adopted budget.

#### **LEGAL ANALYSIS:**

The City Attorney approved the resolution to form.

#### **RECOMMENDATION/PROPOSED MOTION:**

#### **A RESOLUTION**

**WHEREAS,** the City Council adopted the Water, Wastewater, and Reuse Capital Improvement Plan at the Council meeting of October 21, 2021, the Roadway Capital Improvement Plan at the Council meeting of November 4, 2021, and the Drainage Capital Improvement Plan at the meeting of January 20, 2022; and

**WHEREAS,** the adopted Capital Improvements Plan (CIP) include an estimated \$34 million in various projects over five years; and

**WHEREAS**, the City Council supports the development of financing alternatives to support the Capital Improvements (CIP) including a combination of operating and debt service expenses to support the plan; and

**WHEREAS,** CIAC expressed its intent to serve as a bond advisory committee at its meeting of September 7, 2023, to include review of impact fee eligible and non-impact fee eligible projects; and

**WHEREAS**, the City Council finds it appropriate to designate members of CIAC as the ad hoc Bond Advisory Committee; and

**WHEREAS,** the City Council expects to consider a CIP financing plan by February 2024.

### NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FAIR OAKS RANCH, TEXAS THAT:

**Section 1.** The City Council designates the following members to the Bond Advisory Committee for the Council.



#### **INTRODUCTION/BACKGROUND:**

Council Member Bliss submitted a letter of resignation of her Place 3 seat on City Council. Her resignation was accepted by the Mayor on September 22, 2023.

As per Article X1, Section 11 of the Texas Constitution

- b. A municipality so providing a term exceeding two (2) years but not exceeding four (4) for any of its non-civil service officers must elect all the members of its governing body by the majority vote of the qualified voters in such municipality.
- c. Any vacancy or vacancies occurring on such governing body shall not be filled by appointment but must be filled by majority vote of the qualified voters at a special election called for such purpose within one hundred and twenty (120) days after such vacancy or vacancies occur except that the municipality may provide by charter or charter amendment the procedure for filing a vacancy occurring on its governing body for an unexpired term of 12 months or less.

Section 3.09 D of the City Charter Filling Vacancies states: "In the event of a vacancy in the City Council, if there are 365 days or more remaining on the term of the vacated City Council office, the City Council shall call a special election to fill such vacancy.

This agenda item is to review the statutory requirements and deadlines of holding a special election and to consider approving a resolution to select a date and county to run said election.

#### **POLICY ANALYSIS/BENEFIT(S) TO CITIZENS:**

Affords the citizens the opportunity to elect their local government officials and complies with State Election Code and City Charter.

#### LONGTERM FINANCIAL & BUDGETARY IMPACT:

This special election has not been budgeted. At this time, estimated costs are unknown. Staff is currently working with county officials and intends to provide more details at the City Council meeting.




### What modes of transportation do you use?




















## Should the City consider the use of Traffic Calming Devices on public roadways? (choose all devices to consider)



















On Dietz Elkhorn Road, where do you think golf carts should travel?





## Should the 30 mph Dietz Elkhorn Road Speed Limit Change?













#### What configuration would you prefer for Dietz Elkhorn Road?

"Combined Use Path" and "Shared Use Path" ranked as the two highest selected features for consideration within the Dietz Elkhorn Road Project.

#### Capital Improvements Advisory Committee Semiannual Progress Report September 7, 2023 Meeting

#### Overview:

A Capital Improvements Plan is required by LGC § 395, Financing Capital Improvements Required by New Development in Municipalities, Counties and Certain other Local Governments. The plan is to identify capital improvements or facility expansions required by new service units projected; and to include a description of the service area and projection of changes in land uses, densities, intensities, and populations in the service area over a 10-year period. Since the City imposes an impact fee, a periodic review shall be performed at least every five years to determine the need of updating the plans and/or impact fees.

To partially pay for the extension of its Water and Wastewater systems attributable to new development, the City of Fair Oaks Ranch has opted to charge impact fees as allowed under Texas Local Government Code Title 12. Subtitle C. Chapter 395 (Code).

The Code requires the governing body (City) to appoint a Capital Improvements Advisory Committee (CIAC). The CIAC serves in an advisory capacity and is established to:

- 1. advise and assist the City in adopting land use assumptions;
- 2. review the capital improvements plan and file written comments;
- 3. monitor and evaluate implementation of the capital improvements plan;
- 4. file semiannual reports with respect to the progress of the capital improvements plan and report to the City any perceived inequities in implementing the plan or imposing the impact fee; and
- 5. advise the City of the need to update or revise the land use assumptions, capital improvements plan, and impact fee.

#### **Progress Report:**

Chairperson Mebane called the semi-annual CIAC meeting to order at 9:00 AM, Thursday, September 7, 2023. Below are the members present along with their designation and term expiration:

Following introductions, staff provided updates on Capital Improvement Plans and Impact Fee Capital Projects. Staff also provided an update on Land Use Assumptions and answered questions of the members.

#### COMMITTEE RECOMMENDATIONS:

- 1. While there have been no significant changes to the Capital Improvement Plan or Land Use Assumptions, it is recognized that costs continue to rise and home building continues to slow which will affect future Impact Fees. The current Impact Fees were approved by Council in early 2020 and are to be updated every five years.
- 2. It is recommended that the Water, Wastewater and Reuse Master Plan be updated in FY2023-24 in order to present new Impact Fee recommendations to Council in 2025. This will allow us to have an updated Capital Improvement Plan and Land Use Assumptions as a basis for the new Impact Fees.
- 3. Scott Huizenga presented the City's five-year Capital Improvement Plans for utilities, roadways, drainage, and facilities to the CIAC and mentioned that a citizen advisory group may be requested to review and recommend projects for debt financing. The CIAC is open to supporting additional duties as assigned by the Council.

The next Semi Annual CIAC meeting will take place on March 21, 2024.
