



#### **INTRODUCTION/BACKGROUND:**

The Texas Election Code requires City Council to order the election no later than the 78<sup>th</sup> day (February 17, 2023) before Election Day, May 6, 2023. This year Council Places 2 and 6 are up for reelection. The City Secretary presented to Council at the January 5, 2023 council meeting staff's plans to hold the city election in the Public Safety Training Room and to contract with Kendall County. Council accepted staff's recommendation and directed staff to proceed as planned and to contract with Kendall County to run our city elections.

#### **POLICY ANALYSIS/BENEFIT(S) TO CITIZENS:**

Affords the citizens the opportunity to elect their local government officials and complies with State Election Code and City Charter.

#### **LONGTERM FINANCIAL & BUDGETARY IMPACT:**

The total election cost (\$49,146.20) will be divided among three entities: City of Fair Oaks Ranch, City of Boerne, and Boerne ISD. Should any entity cancel their election the remaining entities will pick up those costs. The estimated cost provided by Kendall County for the City's share of the election is \$16,577.87. The FY 2022-23 Adopted Budget for Elections is \$7,000.00. This estimate was derived from the 2022 election estimate provided by Kendall County. The 2022 election was shared by 8 entities, including Kendall County. The difference of approximately \$10,000 will be absorbed through identified savings in the General Fund or through a future budget amendment if savings are not identified.

#### **A RESOLUTION**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FAIR OAKS RANCH, TEXAS, CALLING FOR A GENERAL ELECTION TO BE HELD ON MAY 06, 2023 FOR THE ELECTION OF CERTAIN CITY OFFICERS; PROVIDING PROCEDURES AND DEADLINES FOR THE FILING OF CANDIDATE APPLICATIONS TO BE PLACED ON THE BALLOT; FOR THE LOCATION AND TIME FOR EARLY VOTING; AUTHORIZING CONTRACTS WITH THE ELECTION ADMINISTRATOR OF KENDALL COUNTY, TEXAS TO CONDUCT THE ELECTIONS; AUTHORIZING THE ELECTIONS TO BE HELD AS A JOINT ELECTION; AND AUTHORIZING THE CITY MANAGER TO EXECUTE ALL DOCUMENTS IN CONNECTION THEREWITH ON BEHALF OF THE CITY OF FAIR OAKS RANCH; AND FOR NOTICE OF SAID ELECTIONS TO THE PUBLIC AS REQUIRED BY LAW.

**WHEREAS**, the laws of the State of Texas provide that on May 6, 2023, there shall be a general election for municipal officers; and,

**WHEREAS**, the City of Fair Oaks Ranch is a Home Rule municipality located in Bexar County, Comal County and Kendall County, adopted as authorized by Article XI, Section 5, of the Texas Constitution; and

**WHEREAS**, Section 4.01 of the City's Charter requires the City of Fair Oaks Ranch to conduct an election for city officers annually on an authorized uniform election date; and

**WHEREAS**, pursuant to Chapter 3 of the Texas Election Code, the City Council of the City of Fair Oaks Ranch, Texas hereby calls for the above general election for municipal officers and hereby sets forth the procedures and requirements for the conduct of said election as prescribed by the Texas Election Code; and

**WHEREAS**, pursuant to Chapter 271 of the Texas Election Code, the City will contract with the Kendall County Elections Administrator to conduct this election.

### NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FAIR OAKS RANCH, TEXAS:

- **SECTION 1.** The City of Fair Oaks Ranch hereby orders a Municipal General Election to be held on May 6, 2023, an authorized uniform election date, for the purpose of:
  - a. Electing Council Members for Places 2 and 6.
    - i. The Council Member elected to Places 2 and 6, shall serve a term of 3 years, with their terms terminating in 2026, or when their successors are duly elected;
    - ii. That at said election each of the aforementioned named City Council positions shall be voted upon separately and that the candidate receiving the majority votes for each said City Council position shall be elected to that office;
    - iii. That qualified persons desiring to be candidates in the aforementioned City Council Places shall file applications for candidacy with the City Secretary beginning at 8 AM on the 18th day of January and not later than 5:00 PM on the 17th day of February, 2023.

- **SECTION 2.** All qualified voters of the City of Fair Oaks Ranch shall be entitled to vote in said election.
- **SECTION 3.** Early voting in said elections shall be conducted during the early voting period designated as April 24 through May 2, 2023. The Kendall County Election Administrator is hereby charged with the duty of conducting early voting in said election, as required by law. Applications for ballot by mail shall be mailed to:

**SECTION 4.** The main early polling place for the holding of said election shall be at the Kendall County Courthouse Annex, 221 Fawn Valley, Boerne, Texas 78006 on the following dates and times; and the entire City of Fair Oaks Ranch, Texas, for the purpose of holding said election shall be and constitute one Municipal election precinct.

- **SECTION 5.** The polling place on Election Day shall be open from 7:00 AM to 7:00 PM. The election day polling place by personal appearance shall be at the Kendall County Courthouse Annex, 221 Fawn Valley, Boerne, Texas 78006 and the City of Fair Oaks Ranch Police Station, Public Safety Training Room, 7286 Dietz Elkhorn, Fair Oaks Ranch, TX 78015.
- Pursuant to Section 61.012, Texas Election Code, as amended, the City shall SECTION 6. provide at least one accessible voting system in each polling place used in the Such voting system shall comply with Texas and federal laws election. establishing the requirement for voting systems that permit voters with physical disabilities to cast a secret ballot. Touch screen machines may be used for early voting and Election Day voting by personal appearance. Certain early voting may be conducted by mail. The Elections Administrator shall also utilize a Central Counting Station (the "Station") as provided by Section 127.001, et seq., Texas Election Code, as amended. Kendall County Election Administrator Staci L. Decker, serving as the Elections Official Manager and Presiding Judge of the Stations, will appoint the Election Judges and Station Clerks for each Station location, and will establish a written plan for the orderly operation of the Station locations in accordance with the provisions of the Texas Election Code. The Elections Administrator will appoint the Tabulation Supervisors which will also serve as the Programmers for the Stations. Lastly, the Elections Administrator will publish notice and conduct testing on the automatic tabulation equipment

- relating to the Stations and conduct instruction for the officials and clerks for the Stations in accordance with the provisions of the Texas Election Code. Voting by Mail ballot and Provisional Voting shall be done on paper ballot.
- **SECTION 7.** The City Secretary shall serve as the election officer of the May 6, 2023, General Election of the City of Fair Oaks Ranch as required and authorized by law.
- **SECTION 8.** The City Secretary is hereby authorized and directed to post notice of said election, in both English and Spanish, on a bulletin board used for posting notices of the City Council meetings of the City of Fair Oaks Ranch at 7286 Dietz Elkhorn, City of Fair Oaks Ranch, Texas (the polling places for the holding of said election) not later than the twenty-first (21) day before Election Day. Said notice shall remain posted through the end of Election Day.
- **SECTION 9.** The City Secretary is further authorized and directed to cause notice of said election to be published in a newspaper of general circulation in the City of Fair Oaks Ranch at least once, not earlier than the thirtieth (30th) day nor later than the tenth (10th) day before Election Day.
- **SECTION 10**. The City Secretary shall send a copy of the notice of said election to the County Clerk and Voter Registrar of Bexar, Comal, and Kendall County no later than the 60<sup>th</sup> day before Election Day.
- **SECTION 11.** The Council authorizes the City Manager to negotiate and enter into one or more joint election agreements with other governmental organizations in accordance with the provisions of the Texas Election Code in such form as shall be approved by the City Manager, or his/her designee, and the City Attorney.
- **SECTION 12.** The Council authorizes the City Manager to negotiate and enter into contracts with the Elections Administrator to conduct the elections in accordance with the provisions of the Texas Election Code in such form as shall be approved by the City Manager and the City Attorney.
- **SECTION 13**. The foregoing recitals are hereby found to be true and correct and are hereby adopted by the City Council of the City of Fair Oaks Ranch, Texas and made a part of this Resolution for all purposes as findings of fact.
- **SECTION 14.** All resolutions, or parts thereof, which are in conflict or inconsistent with any provision of this Resolution are hereby repealed to the extent of such conflict, and the provisions of this Resolution shall be and remain controlling as to the matters resolved herein.
- **SECTION 15.** It is officially found, determined, and declared that the meeting at which this Resolution is adopted was open to the public and public notice of the time, place, and subject matter of the public business to be considered at such meeting, including this Resolution, was given, all as required by Chapter 551, Texas Government Code, as amended.

### **SECTION 16.** This Resolution shall be in force and effect from and after its final passage, and it is so resolved.

#### **INTRODUCTION/BACKGROUND:**

On January 23, 2023, the City Manager entered into a Building Inspector Services Agreement with James Earl IV, a state licensed plumbing inspector and International Code Council Certified Residential Building Inspector, to conduct plan reviews and inspect new and existing construction. The attached Agreement was executed under emergency conditions due to the following:

- 1. the City's on-staff building inspector is on unplanned medical leave; and,
- 2. the contracted building inspectors currently do not have a state plumbing inspection license; and,
- 3. the unfilled vacancy in the Building Official position.

The City Code of Ordinances and the attached Building Inspector Services Agreement are the governing documents that guide the functions of the contracted building inspector. The Inspector reports directly to the City's Building Official or designee. The agreement includes:

- 1. An effective period of January 23, 2023-September 30, 2023; and to be renewed, if deemed advisable, annually.
- 2. Either party with or without cause may terminate the Agreement with a 90-day notice.
- 3. Will be covered for General Liability through the City's insurance provider while serving in the capacity as a Building Inspector.

Executing said agreement with James Earl IV ensures continued effective operations of the building codes department. Accordingly, this agenda item is to ratify the City Manager's execution of the attached Building Inspector Services Agreement.

#### **POLICY ANALYSIS/BENEFIT(S) TO CITIZENS:**

- ➤ Receiving City Council approval by ratifying an executed agreement by the City Manager.
- > By maintaining an agreement with a state licensed plumbing inspector, the city can continue maintaining the general health, safety, and welfare of its citizens in a timely manner.

#### LONGTERM FINANCIAL & BUDGETARY IMPACT:

No budgetary impact as funding is in the Building Codes FY 2022-23 Professional Services line (01-641-300) budget.

#### **LEGAL ANALYSIS:**

The City's legal team has reviewed and approved the agreement.

#### **RECOMMENDATION/PROPOSED MOTION:**

I move to approve the ratification of the City Manager's execution of the Building Inspector Services Agreement with Jim Earl IV.

#### **BUILDING INSPECTOR SERVICES AGREEMENT**

This Services Agreement is made and entered into by and between <u>James Earl IV</u> ("BUILDING INSPECTOR"), and the City Fair Oaks Ranch ("CITY"). Building Inspector and City are each a "Party" and are together referred to as the "Parties"

WHEREAS, the CITY is responsible for enforcing applicable laws, regulations, ordinances and orders in the city limits of Fair Oaks Ranch to protect the public health, safety and welfare; and,

WHEREAS, the BUILDING INSPECTOR is agreeable to providing the services of a Professional Building Inspector to inspect construction for which building permits were issued within the city as needed and be responsible for enforcing applicable rules in accordance with the International Building Codes; and National Electric Code,

WHEREAS, the Parties agree that fair and reasonable compensation from the CITY for provision of such services will be given to the BUILDING INSPECTOR.

**NOW, THEREFORE**, in consideration of the mutual covenants and agreement stated herein, the parties agree as follows:

#### **ARTICLE I. PURPOSE**

1.01 The purpose of this Agreement is to acquire contracted personnel to provide building inspections within the incorporated area of the City of Fair Oaks Ranch.

#### ARTICLE II DEFINITIONS

- 2.01 For purposes of this agreement, the following terms shall have the meanings set forth below:
  - a) BUILDING INSPECTOR. The person who has been contracted by the City of Fair Oaks Ranch to perform building inspections.
  - b) BUILDING INSPECTION. The examination of any construction for which a permit is required to ensure the building complies with the requirements of the locally adopted Building Codes.
  - c) BUILDING CODE. The 2021 edition of the International Building Code as well as the 2020 National Electric Code as adopted by the city, and any future adopted editions of the afore mentioned Building Code.
  - d) INSPECTION REPORT. A handwritten or computer-generated document detailing any deficiencies found during a building inspection. The inspection report may also include corrective action information as well as building code violation references.
  - e) CITY BUILDING OFFICIAL. The officer or other designated authority charged with the administration and enforcement of the locally adopted codes, or a duly authorized representative of the City.
  - f) OWNER'S AGENT. The architect, engineer, contractor, manager, or other person who has the owner's consent to act on his/her behalf regarding the construction, maintenance and code compliance of a commercial establishment or public building.

- g) CERTIFICATE OF OCCUPANCY. A certificate or document issued by the City, indicating the building, structure, or occupied area within a structure, has been inspected and is found to be in compliance with locally adopted codes and state laws.
- h) BUILDING AND/OR CONSTRUCTION PLANS. A set of documents that defines the requirements and activities for a building and/or construction project.
- i) PLAN REVIEW. The analysis of submitted building and/or construction plans according to the City of Fair Oaks Ranch adopted ordinances.
- j) PLAN REVIEW REPORT. A handwritten or computer-generated document detailing any deficiencies found during a building and/or construction plan review. The plan review report may also include corrective action information as well as building code violation references.

#### ARTICLE III. TERM

- 3.01 The term of this Agreement shall be for the period beginning January 23, 2023, and ending September 30, 2023, unless earlier terminated.
- 3.02 TERMINATION: Either Party may terminate this Agreement, with or without cause, by giving the other Party 90 days written notice of its intention to do so. The Notice shall be delivered by mail or in person to the other Party. In such event, the Agreement will terminate 90 days following receipt of such notice with no further obligation on either Party, provided that all amounts due and owing to BUILDING INSPECTOR by CITY be timely paid.
- 3.03 RENEWAL, EXTENSION: On or before May 1 of ending agreement year, CITY shall notify BUILDING INSPECTOR whether CITY desires to continue this Agreement for one year or any term of less than one year. By written agreement executed at any time before the expiration date stated herein or such subsequent expiration date as agreed to by the Parties, the Parties may renew this Agreement for a one-year term or extend the term of the Agreement for any period of less than 12 months. On an annual basis it is the city's intent to execute a Building Inspector Services Agreement that coincides with the city's fiscal year beginning October 1 and ending September 30 each year.
- 3.04 The BUILDING INSPECTOR agrees and understands that the CITY is a governmental entity that has projected costs for this Agreement and the CITY expects to pay all obligations of this Agreement from projected revenue sources, but all obligations of the CITY are subject to annual appropriation by the CITY in future years. In the event the CITY does not appropriate funds in any fiscal year for payments due under this Agreement, then this Agreement shall terminate with the CITY providing written notice of any non-appropriation to the BUILDING INSPECTOR as soon as reasonably practical.

#### **ARTICLE IV. BUILDING INSPECTOR'S RESPONSIBILITIES**

- 4.01 Perform building inspections as requested to ensure compliance with all adopted Building Codes and building related ordinances. Although there is no guarantee minimum or maximum, it is estimated that up to 225 building inspections may be requested by the city each year.
- 4.02 Provide digital inspection copies of all Building Inspection reports to the city within 24 hours of inspection.
- 4.03 Provide and maintain own office space, furnishings, equipment, appropriate clothing (ex. hard hat, steel-toed shoes), and supplies, as necessary, to perform the applicable services at the cost to the individual and not the CITY.
- 4.04 Report to the Building Official in all matters regarding this agreement.

- 4.05 By the 10<sup>th</sup> of the following month services performed, submit to the building codes department monthly invoices of inspections performed. Invoices should include each inspection type, date of inspection, hours spent on inspection, and cost of inspection performed.
- 4.06 Perform plan reviews as requested to ensure compliance with all adopted Building Codes and building related ordinances.

#### ARTICLE IV. CITY'S RESPONSIBILITIES

- 5.01 Pay the BUILDING INSPECTOR the sum of:
  - a) \$200 per each first-time Final inspection
  - b) \$200 per each first-time Framing inspection (includes Electrical and Mechanical)
  - c) \$100 for all other building inspections including re-inspections.
  - d) \$75 per hour for plan review
- 5.02 CITY shall remit payment within 30 days of receipt of BUILDING INSPECTOR'S invoice.
- 5.03 The Building Official will be responsible for administering this agreement.
- 5.04 Provide BUILDING INSPECTOR with business cards as necessary.
- 5.05 Provide BUILDING INSPECTOR with identification badge.
- 5.6 Provide BUILDING INSPECTOR with removable magnetic city identification sign
- Provide BUILDING INSPECTOR with general liability insurance on a per occurrence basis with limits of liability not less than \$1,000,000 for each occurrence and for fire damage. For Bodily Injury and Property Damage, coverage shall be no less than \$1,000,000. As a minimum, coverage for Premises, Operations, Products and Completed Operations shall be \$2,000,000. This coverage shall protect the public or any person from injury or property damages sustained by reason of the BUILDING INSPECTOR. The general aggregate shall be no less than \$2,000,000. Current Certificate of Insurance shall be attached as Exhibit of this Agreement.

#### ARTICLE V. MISCELLANEOUS PROVISIONS

- 6.01 In the performance of service by the BUILDING INSPECTOR to the CITY under the terms of this Agreement, it is mutually understood and agreed that the BUILDING INSPECTOR at all times shall be an independent contractor. Nothing herein shall be construed as giving a degree of control on the part of the CITY that creates an employer-employee relationship between the CITY and the BUILDING INSPECTOR.
- 6.02 This Agreement does not create an employment relationship, partnership, or joint venture between the BUILDING INSPECTOR and the CITY.
- 6.03 This is the sole and only agreement between the Parties concerning the subject matter set out herein. No other agreement, statement or promise made by any party or any officer, agent, or employee of any Party, which is not set out herein, shall be binding or enforceable against either Party.
- 6.04 No amendment, modification or alteration to this Agreement shall be binding unless it is set out in writing, approved by the Parties and signed by the Parties or their duly authorized representative.

6.05 All notices by the Parties shall be deemed given when either delivered in person or deposited in the U.S. Mail, postage prepaid, certified mail, return receipt requested, addressed to the appropriate party at the following addresses:

- 6.06 If any provision of this Agreement is determined to be invalid or unenforceable by a court of competent jurisdiction, this Agreement shall be reformed to the extent necessary to make the offending provision valid and enforceable, or if the offending provision cannot be modified so as to be made valid and enforceable, the invalidity or unenforceability of such provision shall not affect the remaining terms of this Agreement.
- 6.07 This Agreement shall be construed in accordance with the laws of the State of Texas. Exclusive venue for any legal action arising from this Agreement shall be in Kendall County, Texas.

#### INTRODUCTION/BACKGROUND:

During the 84th Legislative Session, the Local Governments Disproportionately Affected by Property Tax Relief for Disabled Veterans program was created under HB 7 and became effective September 1, 2015. "To serve the state purpose of ensuring that the cost of providing ad valorem tax relief to disabled veterans is shared equitably among the residents of this state, a local government is entitled to a disabled veteran assistance payment from the state for each fiscal year that the local government is a qualified local government. A local government is a qualified local government for a fiscal year if the amount of lost ad valorem tax revenue calculated under Subsection (c) for that fiscal year is equal to or greater than two percent of the local government's general fund revenue for that fiscal year." (HB 7)

This program is managed by the Texas Comptroller's Office. Details on the program can be found at: <a href="https://comptroller.texas.gov/taxes/property-tax/exemptions/local-gov-relief.php">https://comptroller.texas.gov/taxes/property-tax/exemptions/local-gov-relief.php</a>

A city adjacent to a United States military installation or a county in which a United States military installation is wholly or partly located may be entitled to a disabled veteran assistance payment from the state under Local Government Code Section 140.011. In addition, a city or county must have lost property tax revenue from the 100 percent or totally disabled veteran residence homestead exemption under Tax Code Section 11.131 in an amount equal to or greater than 2 percent of the local government's general fund revenue for the fiscal year.

I believe our city may qualify for this assistance payment.

The urgency of this agenda item is driven by the 2023 deadline for submission for this past fiscal year. The completed application and supporting documentation must be received by the Comptroller's Property Tax Assistance Division no earlier than Feb. 1 and not later than April 1 of the year following the end of a fiscal year for which the applicant is seeking payment.

The purpose of this agenda item is to ask Council's consideration to approve pursuing this assistance payment from the State Comptroller's Office, including having city staff assess the City's eligibility and presenting an update to Council, and, if applicable and approved by Council, submitting an application to Texas Comptrollers office by the FY2022 submission deadline.

#### **POLICY ANALYSIS/BENEFIT(S) TO CITIZENS:**

- 1. Application and reception of these state funds will help the City support and provide services to the growing number of 100% disabled veterans and their surviving spouses who reside in our city due to its proximity to nearby military installations and do so without a disproportionate negative impact to the City's budget.
- 2. Supports Strategic Action Plan 1.4 Develop a Sustainable Financing Strategies Aligned with Service Delivery Expectations.

#### **LONG-TERM FINANCIAL & BUDGETARY IMPACT:**

If eligible, this assistance payment from the state will provide additional revenue to offset some of the loss of ad valorem tax revenue from 100% disabled veteran tax exemptions.

# Local Governments Disproportionately Affected by Disabled Veterans Exemption

GENERAL INSTRUCTIONS: A city adjacent to a United States military installation and a county in which a United States military installation is wholly or partly located may be entitled to a disabled veteran assistance payment from the state under Local Government Code Section 140.011 if the city or county is a qualified local government for a fiscal year. A local government is qualified for a fiscal year if lost property tax revenue from the 100 percent or totally disabled veteran residence homestead exemption under Tax Code Section 11.131 is equal to or greater than 2 percent of the local government's general fund revenue for that fiscal year. You must read and comply with Local Government Code Section 140.011 and Comptroller Rule 9.4321 through 9.4327, regarding Local Government Relief for Disabled Veterans Exemption.

APPLICATION DEADLINE: Applications are only accepted from Feb. 1 through April 1 each year. An application will be rejected if it is submitted before Feb. 1 of the first year following the end of a fiscal year for which the applicant is seeking a payment pursuant to Comptroller Rule 9.4325. A qualified local government must submit a completed application for a fiscal year not later than April 1 of the first year following the end of a fiscal year. A local government is not entitled to a payment if a completed application is not submitted by the April 1 deadline. If a completed application is submitted electronically, PTAD must receive it no later than 11:59 p.m. on April 1. If a completed application is submitted by certified mail, the application must be postmarked no later than April 1. An application will be rejected if a completed application is not submitted by the April 1 deadline pursuant to Comptroller Rule 9.4325.

COMPLETED APPLICATIONS: An applicant must submit a completed application by the application deadline of April 1. An application is not considered complete until: 1) all documentation listed below is submitted, and 2) any required information requested by the Comptroller's Office after the initial submission of the application is provided by the applicant within 14 calendar days of the Comptroller's Office request.

**REQUIRED DOCUMENTATION:** Each application must include the following:

- Documentation certified by a city, county or independent auditor that substantiates the amount of each allowable revenue source deposited in the dedicated general operating fund for the fiscal year for which the local government is applying for the disabled veteran assistance payment;
- Documentation that substantiates the adopted property tax rate for the tax year in which the applicable fiscal year begins;
- Documentation that substantiates the exemption amount which is the total appraised value of all property located in the local government that is granted an exemption under Tax Code Section 11.131 for the tax year in which the applicable fiscal year begins;
- Independent audit or a comprehensive annual financial report covering the applicable fiscal year;
- If a city applicant, a map showing that the applicant city is adjacent to a United States military installation; and
- If a county applicant, a map showing that a United States military installation is located wholly or partly in the applicant county.

Submitted documentation must be highlighted for easy identification of the specific general fund revenue sources, the adopted property tax rate and the exemption amount.



#### INTRODUCTION/BACKGROUND:

In November 2022, a resident voiced concerns regarding tree removal on a neighboring property. Currently, there is no city ordinance that disallows the removal of trees on existing residential lots. To further explore this topic, a future agenda item was requested by Council. This workshop presentation was developed in response to that request and to gauge Council's interest in changing or expanding our current tree maintenance and preservation ordinances.

The goal of this workshop is to review the city's current tree regulations, understand what other municipalities have adopted and discuss potential updates to our ordinances and the associated impacts of implementation that could further protect existing trees within Fair Oaks Ranch.

Additionally, updating our ordinances to formally place the ownership and maintenance of public trees on the city is one step towards being designated as a Tree City. Tree City USA® is an Arbor Day Foundation program that recognizes cities and towns across the U.S. that are committed to maintaining and protecting our urban forests.

Staff is seeking Council guidance in a future tree ordinance update, if any. However, no Council action is requested as part of this workshop.

#### **POLICY ANALYSIS/BENEFIT(S) TO CITIZENS:**

- Protects mature trees within Fair Oaks Ranch and helps maintain the rural hill country aesthetic the city is known for.
- Helps obtain Tree City USA® designation for the city from the Arbor Day Foundation.



# **Unified Development Code:**

### 8.8 Tree and Habitat Protection

<u>Purpose:</u> Conserve, protect and enhance trees to preserve the overall quality and environment of Fair Oaks Ranch.

Applies to: New residential and nonresidential development or redevelopment.

Does not apply to private property

<u>Permitting:</u> Trees located within 10 ft of building footprint; locations for onsite sewage facilities; areas required for site access

Preservation Exemptions: Trees located in the Right-of-Way, Trees located in easements

**Tree Plans/ Heritage Plans** 

Tree Plans are required for new construction which identifies location, species, and size of trees with a **trunk circumference of ~28 inches** or larger on site. It shall designate all trees proposed for removal and describe protection measures for remaining trees.

Diameter: ~9 inches or more

Heritage Plans are required for all trees on site that have a **trunk** circumference of ~75 inches or more

# **Unified Development Code:**

### 8.8 Tree and Habitat Protection

It is unlawful to remove or destroy any trees with a **Trunk Circumference** (**TC**) of 28 inches or more located on property pursuing new development, a plat, or infrastructure improvements within the city limits or ETJ without submitting a **Tree Plan** to City Staff.

### Removal/Mitigation for Protected Trees:

Developers are encouraged to preserve trees wherever possible.

Protected trees (circumference of 28 in. or more) must be mitigated as a 1:1 TC

example: Two 30 TC trees are to be removed; site total = 60 TC inches removed.

Six trees with a TC of 10 inches

each must be planted.

A Heritage Plan is required to be reviewed and approved by the Planning and Zoning Commission and City Council prior to any construction activity that is likely to endanger a Heritage Tree, TC 75 inches or larger.

#### **Removal/Mitigation for Protected Trees**

Heritage trees may not be removed unless:

Tree is sick/diseased; Tree is within the footprint of exempted areas; or if removal is approved by City Council after P&Z Consideration

Heritage Tree mitigation must additionally follow 1:1 TC ratio

# **Public & Private Property**

### Article 1.07 Div. 2: Tree

- Maintenance
  Oak Tree trimming is disallowed
  between February 1st thru June 31st
- All wounds shall be painted after trimming, cutting, or pruning
- Any oak wilt treatment performed in the city limits must be reported to the City
- Red Oaks are prohibited as new plantings

- All contractors performing tree maintenance within the city limits must register
- Registration is good for 1 year after issuance
- All contractors must abide by the Oak Wilt Ordinance

#### **Public**

Maintenance and Ownership, and inventory responsibility of trees in public spaces is the Forestry Department

Funds donated to the West University Tree Fund is used to plant trees within the city limits

#### **Application for Tree Removal**

For <u>pre-development or</u> construction activities:

Trees with a diameter of 10 inches or more.

#### For *all other instances:*

- Trees with a diameter of 12 inches or more
- Trees located in a front yard, side street yard (of corner lots), or in a ROW that is 10 inches or larger

**Replacement Trees** must be at least 2 diameter inches. If 10 diameter inches removed, at least one 4-inch tree (or 100 gallon tree) is required to be planted

#### **Tree Replacement**

Tree inches removed from site shall be replaced with the same amount of tree diameter inches

If replacement cannot be reasonably planted on site, the new planting can be placed or maintained within 1,000 feet offsite *OR* a monetary donation can be made to the West University Tree Trust



Current Rate: \$250 per diameter inch and \$2,000 per 4-inch tree

# Suggested Tree Ordinance Updates

#### Public Propert

Any lands owned by the City'such as Parkways, Rights-of-Ways, City Campus, etc.

Adopt an ordinance that protects trees on Public Lands

The City is seeking Tree City USA acknowledgement from the Arbor Day Foundation

One of the 4 criteria needed to qualify is a Public Tree Ordinance

Ordinance Requirements:

- Assigns Authority over Public Trees
- Provides clear guidance for the planting, maintaining and/or removal of trees in public spaces
  - Must be effective 24/7 not triggered by landscaping or development processes

#### Private Propert

Residential or Commercial land of any acreage.

Adopt an ordinance that protects trees on already developed land

Require a Tree Preservation Plan for the removal of trees on private lands

## Penalties & Enforceme nt

For unauthorized removal / destruction of trees with a 9-inch diameter or above on public or private land

The City has the right of inspection for properties removing trees

Actions deemed as violations to Proposed Ordinance:

  - Violation by Act of Omission

#### Penalties:

Fine may be issued for the unauthorized removal of trees;

Property Owners may have the opportunity to remedy the fine cost by mitigating at a 1:1 TC ratio

## Other Topics for Discussion

#### **Create an Oak Wilt Fund**

- Property Owners with confirmed oak wilt on their property could receive a rebate from the city for treatment
  - Oak Wilt must be confirmed and treated by a Certified Arborist
  - Proof of Treatment must be provided to receive rebate
- Allows Property Owners to be proactive in treating Oak Wilt. Provides some financial relief if cost of treatment is out of budget
- Fund would be established through City Ordinance, but amount available for rebates would be included in the Annual Fiscal Budget

#### **Donation in lieu of Replanting**

 If unreasonable to replant trees on site, a donation can be made to the City for any tree with a diameter of 12 inches (~37in circumference) or less; these funds would go toward helping treat oak wilt

#### **Need for additional Man-Power**

- Many cities who have similar tree ordinances have staff dedicated to Urban Forestry.
- An additional position may need to be created to fulfill the added responsibility

## Topics for Discussion

Possible Impact to Property Owners

Currently, only infrastructure development is required to provide Tree Preservation Plans. By passing a private property ordinance, each lot with trees that meet the criteria would need to submit a Tree Plan for review by city staff and/or by Council prior to any building or lot preparation to commence.




