RECOMMENDED COUNCIL ACTION: Motion to approve application and to issue a drinking establishment (on-premise) liquor license to Dane Hansen for Stockmans Casino to be located at 1560 West Williams Avenue.

DISCUSSION: Dane Hansen, Assistant General Manager of Stockmans Casino has made an application for a drinking establishment (on-premise) liquor license for Stockmans Casino to be located at 1560 West Williams Avenue. A drinking establishment liquor license is a privileged license that allows the licensee to sell alcoholic beverages from a fixed and definite place of business for consumption upon the premises only.

The application has been reviewed by Police Chief Ron Wenger, Deputy City Clerk Elsie Lee, City Engineer Derek Zimney, and Deputy City Attorney Trent deBraga and has been recommended for approval.

On January 4, 2024 the Fallon Police Department received an application for City Liquor License from Mr. Dane Hansen of 446 W Clearview Drive #102 Carson City, Nevada 89703. Mr. Hansen is seeking a city liquor license to operate the bar within the Stockman's Casino, located at 1560 West Williams Avenue in the City of Fallon.

A review of Mr. Hansen's references were all very favorable, with all speaking very highly of him.

I have performed a basic criminal background check which included the Fallon Police Local Database and CPClear. I found that Mr. Hansen has no reported criminal activity. He was arrested in 1983 in Reno Nevada on a warrant issued after he failed to appear on a traffic citation. I have concluded that Mr. Hansen has passed the basic background check.

During a personal interview, I had Mr. Hansen update his personal phone number and that physical address of the business in which he is applying for a liquor license. I also had Mr. Hansen correctly check the box in which an arrest would be recorded.

During the interview, I learned that Mr. Hansen would not be directly responsible for the bar on a day to day basis and had him add in the on-site supervisor line, the person who would be responsible for the bar in his absence. This person was named as the on-duty shift manager of the business which operates seven days a week and twenty-four hours a day.

I have also provided a supplemental form in which Mr. Hansen signed on October 12, 2023 indicating that he understands his responsibilities as they relate to the laws regarding underage drinking. At his request, I provided Mr. Hansen with a copy of FMC 5.08.
