City Engineer Derek Zimney stated I. H. Kent Company, owner of Churchill County Assessor's Parcel Number (APN) 001-144-04, has made application and submitted a map to adjust the boundary line with the two parcels to the South, 001-144-02 and 001-144-03. APN 001-144-02 is owned by Steve Bollenbacker & Charlene Blumhagen and 001-144-03 is owned by Lorenzo & Kristina Munoz. Approval of this map will adjust the property lines, expanding parcel 001-144-03 and parcel 001-144-02 to include a portion of parcel 001-144-04. Any additional development or improvements to these parcels shall be required to meet all applicable City of Fallon standards and requirements.

Councilman Harmon inquired on the map square footage.

City Engineer Derek Zimney stated the maps depicted the adjusted square footage amounts.

Councilman Harmon inquired if this property would be consistent with the neighborhood.

City Engineer Derek Zimney stated that, for a commercial building, the square footage is consistent with the area.

Councilwoman Kent stated that she would be abstaining from the vote on this agenda

Councilwoman Frost motioned to approve a Record of Survey Map in Support of a Boundary Line Adjustment between a parcel owned by I. H. Kent Company, a parcel owned by Steve Bollenbacker & Charlene Blumhagen, and a parcel owned by Lorenzo & Kristina Munoz, Churchill County Assessor's Parcel Numbers 001-144-04, 001-144-02 & 001-144-03, respectively; seconded by Councilman Harmon and approved with a 2-0 vote by the Council, with Councilwoman Kent abstaining.

Public hearing for Bill No 807: An ordinance amending Title 17, Buildings and Construction, Chapter 17.04, Construction Codes, Section 17.04.020, Adopted Building and Construction Codes, of the City of Fallon Municipal Code, for the purpose of adopting the 2024 editions of the International and Uniform Building Codes, as further set forth.

Deputy City Attorney Jaren Stanton stated that this bill was introduced 2 weeks ago. This bill is to adopt the amendments to the International Building Codes that Northern Nevada division went through. Derek and the Building Department worked through these and made sure that they worked for our area and our City. If you further questions about the specifics, I would refer those to him.

Mayor Tedford stated that this is the time for the Public Hearing. Are there any public comments on this bill?

No comments were noted.

Consideration and possible adoption of Bill 807: An ordinance amending Title 17, Buildings and Construction, Chapter 17.04, Construction Codes, Section 17.04.020, Adopted Building and Construction Codes, of the City of Fallon Municipal Code, for the purpose of adopting the 2024 editions of the International and Uniform Building Codes, as further set forth.

Deputy City Attorney Jaren Stanton stated that he has nothing further on this item. The recommendation, from staff, would be to adopt these codes, as amended.

Mayor Tedford inquired whether there were any questions or comments from the Council or the public.

Councilwoman Frost inquired if this bill has already been adopted by Churchill County.

Deputy City Attorney Jaren Stanton stated that the bill has been approved by Churchill County. I don't know when their enforcement date is, but they have adopted them.

Councilwoman Kent inquired on when the City will be enforcing these codes.

Deputy City Attorney Jaren Stanton stated that if they are adopted today, we have to publish them in the newspaper. Our actual enactment date would be in approximately 2 weeks. Derek is prepared to send out letters to all the building officials within our jurisdiction and let them know that we are having a 6-month period, in which we allow them to come to compliance. July 1, 2026, we will be in full enforcement.

Councilwoman Kent inquired on building codes reverting to older codes.

City Engineer Derek Zimney stated that we have seen a few examples in the energy and electric codes, where they change the code, and go back to the way things were, over time. The codes are always evolving and being evaluated. These are international codes, not just Nevada.

There is always a possibility that things could change back, certainly.

Councilman Harmon inquired if changes revert, if it then has to be brought back to the Council for approval.

City Engineer Derek Zimney stated that we would enforce the codes, as they are, for the 4 years. They would come back to Council after the 4 years.

Councilman Harmon inquired on how many years the international codes are generally updated.

City Engineer Derek Zimney stated that every 3 years they are updated.

Mayor Tedford inquired whether there were any further questions or comments from the Council or the public.

No further comments noted.

Councilwoman Kent motioned to adopt Bill 807: An ordinance amending Title 17, Buildings and Construction, Chapter 17.04, Construction Codes, Section 17.04.020, Adopted Building and Construction Codes, of the City of Fallon Municipal Code, for the purpose of adopting the 2024 editions of the International and Uniform Building Codes, as further set forth; seconded by Councilman Harmon and approved with a 3-0 vote by the Council.

Deputy City Attorney Jaren Stanton stated that Bill 808 was introduced at the City Council meeting on November 4th. Notice of this was published in the Fallon Post on November 18th. This is the public's opportunity to raise any comments they have regarding these fire codes.

Mayor Tedford stated this is the time for the Public Hearing on Bill No. 808. Are there any comments regarding these fire codes?

No comments were noted.

Consideration and possible adoption of Bill No. 808: An ordinance amending Title 16, Fire Prevention And Protection, Chapter 16.04, Fire Codes, Section 16.04.020, Adopted Fire Codes, of The City of Fallon Municipal Code, for the purpose of adopting the 2024 edition of the International Fire Code, and appendices B, C, D and F, as modified by NAC 477.281.

Deputy City Attorney Jaren Stanton stated that there has been an update in the international standards. These were reviewed by the Northern Nevada region and internally by staff. It is staff's recommendation, at this time, to adopt these amendments as set forth.

Mayor Tedford stated that these are not only reviewed internally by our staff, but also by the Fire Marshal, who is here today, Brad Dolan. The Fire Department has also reviewed these amendments. Are there any questions or comments from the Council or the public?

Councilwoman Frost inquired if this bill has already been adopted by Churchill County. This will be the same as the process from Bill No. 807?

Deputy City Attorney Jaren Stanton stated that the bill has been approved by Churchill County. These bills will be handled exactly the same way.

Councilman Harmon inquired on Fire Marshal Brad Dolan's recent trainings. Do your recent training courses cover these new codes.

Fire Marshal Brad Dolan greeted the Council. I believe things are always evolving, like Derek talked about. We don't have as many things change as rapidly as the other codes. The lithium battery thing is probably the biggest item that has been added into the code book, this year. We were looking forward to these chapters. It is just based on storage and all the things that you wonder about how to deal with. Otherwise, it is similar for us. If something changes, it will be in the next book in 4 years. Training is always evolving, just like the codes are. I feel like we are up to date now and moving forward. The County is already running with the new codes. I believe we are good and moving in the right direction.

Mayor Tedford inquired whether there were any further questions or comments from the Council or the public.

No further comments noted.

- Various training courses were provided for sworn-in and non-sworn-in officers.
- Police officers participated in several various public relations events.

Mayor Tedford inquired if there were any comments or questions.

Councilwoman Frost inquired on the Citizen Survey comments.

Chief Daniel Babiarz stated that the program has been moved to the Police App. for the availability of citizen comments on responses to calls. This is something that we have noticed a decline in feedback. I think, internally, we can have a conversation about bringing it back to the way it was.

Councilwoman Frost agreed. I think it is important that people are able to give us feedback so we can address any concerns that they may have. Also, reward and celebrate the people that are doing a great job.

No further comments were noted.
