Appellant present and sworn in by the Clerk. Officer present and sworn in by the Clerk. Appellant stated name, John Davis, address of business 319 Moody Blvd, Flagler Beach, address of residence, 64 La Mancha Drive, Palm Coast for the record. Appellant gave testimony as to having a loaner car at the time of the citation and parked in that particular spot due to the hazard of a paver missing. Appellant stated he did park over the missing paver after a customer expressed concern someone might be injured. Appellant reported the City has since replaced the paver after the citation was received. City Attorney questioned Sergeant Yelvington. Sergeant Yelvington testified to writing the citation for parking on the sidewalk and had submitted photographic evidence. Magistrate Popp inquired as to the City's disposition. City Attorney did not object to an educational effort. Magistrate Popp ordered community education of ten (10) licensed drivers with sixty (60) days to complete and submit completed form to the Clerk.

Appellant present and sworn in by the Clerk. Officer present and sworn in by the Clerk. Appellant stated name, Daniel Bach, address 49 North Park Circle Palm Coast, Florida, for the record. Appellant testified he thought he was parking in a legal parking space due to the red brick area. Appellant expressed his concern over the red brick area not being properly marked as no parking zones. Discussion ensued regarding marking red brick areas as no parking zones. Officer Snyder testified to writing the citation and had submitted photographic evidence. Magistrate Popp inquired as to the City's disposition on an educational effort. City Attorney did not object. Magistrate Popp ordered community education of ten (10) licensed drivers with sixty (60) days to complete. Appellant

is to submit competed form to the Clerk. Appellant did request the City make an effort to eliminate the confusion with red brick pavers.

Magistrate Popp ordered community education of ten (10) licensed drivers with sixty (60) days to complete. Appellant is to submit completed form to the Clerk.

Appellant testified as to why and how she parked in the manner she did. Magistrate Popp explained the safety hazards with parking in the wrong direction. Magistrate Popp inquired as to the City's disposition. City did not object to a reduction in fine and an educational effort. Magistrate Popp ordered the fine reduced to \$25.00 and education of ten (10) licensed drivers with sixty (60) days to complete. Appellant directed to pay reduced fine with the Finance Department in City Hall and submit the completed community education form to the Clerk.

Code Enforcement Officer sworn in by the Clerk. Respondent was not present. Mr. Gifford testified to multiple methods and attempts to serve respondents with notices including posting notices. Most contacts with the residents are family members, not the property owner. Mr. Gifford presented evidence and photographs of the current state of the violation. There is no latch on the gate, the contractor building next-door is putting up a fence, but not right away, City Attorney stated it does not appear the property owners are receiving the notices and order, but it does appear they are avoiding Code Enforcement. The City Attorney recommended imposing the previous orders with retroactive fines and additional \$250 every day the violation is not cured. Also recommending a status hearing next month with the stipulation, if the respondents comply, the Magistrate may order some relief from the fines. The City Attorney hopes this will motivate the Respondents to comply. Magistrate Popp agreed. Magistrate Popp ordered a status hearing for June, a running fine of \$250.00 a day with retroactive fines from the April 2024 hearing date. Magistrate Popp advised Code Enforcement and

the Clerk to make every attempt to serve orders to Respondents including reaching out to the rear estate agent listing the property for sale.

FINDINGS OF FACT, CONCLUSIONS OF LAW, AND ORDER

THIS MATTER having come before the Code Enforcement Magistrate for the City of Flagler Beach, Florida on May 22, 2024 after due notice to Respondents and the undersigned having received evidence and heard testimony under oath thereupon issues the following Findings of Fact and Order:

FINDINGS OF FACT

- 1. The property subject to this proceeding is located at 1816 S Daytona Avenue, Flagler Beach, Florida, and has Flagler County Tax Parcel ID 18-12-32-2750-00270-0050 (the "Subject Property").
- 2. Thomas T. Turner and Monzell Turner are the record owners of the Subject Property.
- 3. On April 2, 2024, the Code Enforcement Officer for the City of Flagler Beach properly served a Notice of Violation on Respondent. Said Notice of Violation cited a violation of Section 303.2 of the International Property Maintenance Code, as adopted by the City of Flagler Beach, related to swimming pool enclosures.
- 4. Specifically, there is a swimming pool in the rear yard of the Subject Property and one side of the rear yard currently does not have a fence. Plastic construction fencing has been erected to create a temporary barrier; however, the construction fencing is not a code compliant barrier and has been the only obstacle on that side of the fence for several months.
- 5. On April 26, 2024, the undersigned entered an Order requiring Respondents to obtain a permit to install the missing portions of fence necessary to secure the pool within fifteen

days of April 26, 2024 and requiring Respondents to complete the fence installation within thirty days of April 26, 2024.

- 6. Respondents have not applied for permits, obtained permits, or installed the necessary portions of fence.
- 7. The undersigned also ordered Respondents to attend the May 22, 2024 hearing either in person or by telephone.
- 8. Respondents did not attend the hearing and have made no effort to communicate with the Code Enforcement Officer regarding this violation.

BASED UPON THE FOREGOING, IT IS ORDERED:

- 9. As of May 22, 2024 fines in this case have accrued to \$7,250.00 and continue to accrue at the rate of \$250.00 per day until the violation is cured.
- 10. The City shall schedule and notice this matter for a Hearing to Impose Fines and Create Lien to be held at the regular hearing date in June.
- 11. Unless the Respondents shall have taken prompt and decisive action to address this violation that represents a public safety hazard, the undersigned shall impose all fines accrued as of that date, which fines, once imposed, will constitute a lien against the Subject Property.
- 12. If Respondents take prompt and decisive action to remedy the violation, the undersigned will consider such actions in any request for abatement or reduction of the fines accrued.
- 13. Respondents are reminded that pursuant to Chapter 162, Florida Statutes, they are legally required to notify any potential purchasers of the Subject Property of this code enforcement action.

Respondents remain responsible the City's costs incurred in prosecution in the amount of \$24.00, which was required to be paid within thirty days of the April 24, 2024 but has yet to be paid.
