1. Election of Officers

5. Update: 850 Main Street Redevelopment

Chairman Freeman delivered the update:

• The upstairs ballroom has been renovated and will continue to be used as an event space. The front of the building has been reconfigured and potentially designed for a coffee shop. The DA would like to appoint someone to operate the coffee shop. Attorney Glaze informed the board that they cannot manage the project but can contract a vendor to do so. He even suggested soliciting RFQs (Request for Quotes) for the job. Potentially a massage therapist would also occupy one of the suites. Phase II of the redevelopment will begin once funds are generated from phase I.

OTHER DISCUSSION:

- Attorney Glaze reiterated the attendance policy as described in their bylaws and discussed the process for board member selection. He also suggested creating packets for the board members with their bylaws and the state laws governing their board as a point of reference.
- Prestwick Development made a presentation to the board about a proposed housing development on Main Street targeting the working class. The development will be comprised of 1-, 2-, and 3-bedroom units. The board requested examples of their previously developed communities. Prestwick invited the board to tour any of their established communities to better understand their goal & vision.
