(b) Subject to compliance with the other provisions of this chapter, executive sessions shall be permitted for: (1) Meetings when any agency is discussing or voting to: (A) Authorize the settlement of any matter which may be properly discussed in executive session in accordance with paragraph (1) of Code Section 50-14-2; (B) Authorize negotiations to purchase, dispose of or lease property; (C) Authorize the ordering of an appraisal related to the acquisition or disposal of real estate; (D) Enter into a contract to purchase, dispose of, or lease property subject to approval in a subsequent public vote; or (E) Enter into an option to purchase, dispose of, or lease real estate subject to approval in subsequent public vote.
