CITY MANAGER'S REPORT: Nathaniel Clark, Police Chief/Public Safety Director

- We are recognizing officers for their work beyond the call of duty. Our first recipient is Raymond Daniel, a 24year veteran with the department
- Finance Department is in the process of enhancing our service delivery to the community, citizens, and our guests by way of a drive-through window. Interim Finance Director, Ms. Darquita Williams, gave the following information, on Monday, March 22nd, we will be opening our Drive-Thru to the public from 8:00am 4:00pm, to allow for balancing of the drawers. Will be taking the following payments property taxes, business license, and sanitation payments. Thanks to the Public Works for the installation of the Drive-Thru. Notice have been placed on the city's website.
- Parks & Recreation Spring Fest on April 3, 2021 from 11am 2pm at Kiwanis Stadium, South Avenue, Forest Park. There will food, games for all that participate.
- The Demolition of 890 Conley Road, formerly Briarwood Forest Apartments. The demolition is in process and is about 90% complete. We will work with the Land Bank Authority to clear the title to the property so that we can put the land up for bid for residential use. We have had several inquiries about the lot already.
- Councilmember James continues to have her Virtual Neighborhood Meeting every 3rd Thursday at 5pm. An opportunity for residents to learn about the different things that are happening in the city, department heads giving updates on their departments.
- Councilmember Wells' "Wellness with Wells" starts back this Tuesday from 6:00pm-7:00pm at the Recreation Center. Congratulations to the Girls Basketball Team and Sanaya Fagin, a member of the team, is celebrating being the McDonald's All-Star American and her 18th birthday today, we wish you Happy Birthday. If you need rental assistance or any type of assistance, you can go to <u>www.georgiarentalassistance.ga.gov</u>, please take advantage of this resource.
- Councilmember Gutierrez's Food Truck at the Fountain returns the first Friday in April. Will be starting a
 monthly cleanup in his area and will be identifying an area for the cleanup on the first Saturday of each month
 and on March 27th and April 3rd, he will be collaborating with a non-profit, who has a grant with USDA, who
 will giving away food boxes.
- Councilmember Antoine announced the Community Center on Main Street still money for energy assistance (\$800), for residents of Henry and Clayton.
- Councilmember Mears congratulated the Girls Basketball Team played in the state games and won it last year and barely missed it this year. We should be proud of them for bringing a lot of pride to our city and for all the hard work and efforts. So, when you see them, please congratulate them for a job well done.
- Mayor Butler and I have been discussing the re-opening of the city on April 1st. An action plan was previously distributed to council.

COVID-19 UPDATE: Deputy Fire Chief, Clemons and Division Chief, Joel Turner

The report was given by Deputy Fire Chief Clemons -There are general improvements in positive case numbers over the past two weeks. The current average rate of daily positives among those tested statewide is 5.4% for the past two weeks; 2.0% lower than two weeks ago.

As of today, 3/15/2021:

 Clayton County's 2-week average rate of daily positives is 8.1%, which is a 1.3% reduction since reported last meeting by DC Turner.

Currently reported by Clayton Co Health District this afternoon: 3/15/2021

- Forest Park currently has 2078 cumulative cases that is 9.6% of county cases in the 30297-zip code. This remains consistent with the numberswe have seen for the area over the past several weeks.
- Forest Park Fire has had three members test positive and are currently working the Isolation Protocol.

Everyone is still highly encouraged to follow good personal hygiene practices - wash hands frequently; use hand sanitizer; maintain physical distancing; and use of masks.

OLD BUSINESS:

1. Discussion of the status of Venue Night Club operating at 4730 Frontage Road - Councilmember Mears

Comments/Questions from Council:

Attorney Williams – This item was requested to be put on the agenda to give Council an update on where that stands; most of last year the Venue Nightclub was not in operation, and in late December early January they approached City staff to inquire about getting current on their operation fees and reopening and at the time when the request came in and we received it, we asked staff to stand down so we could look at the settlement agreement we had with the two clubs as well as the ordinance to make sure that we followed the proper process to allow them to reopen. I had previously communicated Council some of the information regarding that, but our ordinance provides as well as a settlement, as long as they are current on their fees, they have the ability to pay the fees and reopen. So, the administration of the ordinance is in the purview of the city manager as the Police Chief, and so that advice was given and subsequently they came in and paid all their fees and to my knowledge they are currently operating. And that is the update as it stands now and if there are any questions, I will answer them either here or in Executive Session.

Councilmember Mears – I was the one to ask for it to be on the agenda, the biggest problem I have is communication; this City is a beautiful, nice, and wonderful place to live, but it is has underground signal points and there is nothing that can be done around here that somebody do not know about it, just as soon as it happens, most of the time. I asked for a briefing on the situation, was primarily because I had received several calls, is to make sure that the integrity and safety of city is always at hand, I did not read the entire agreement, therefore I started asking questions and want to make sure we are where we are supposed to be, we are protected and everything is going to run like it is supposed to and we will not have any backdoor surprises.

Councilmember James – The Venue Nightclub, is this the same club that was operating before or is this a new company and ownership? The email that we recently received that names another company, name change and all, I do not want to be involved in any controversy. Is the amount of time that the business was closed and then reopened, isn't there a stipulation in the contract, that they have to come back before council? I understand that it was a large sum of money that was paid in fees, which means they were behind, so if they were behind why were they not in default, maybe that is an issue with staff, but I do not

understand, and it does not make sense. Maybe we can discuss now or in Executive Session?

Attorney Williams – The same company that was part of the settlement agreement, (Red-Eyed Entertainment). I cannot speak to the ownership, but the company/entity that was party to the settlement agreement is the entity that has the business license. The company is Red-Eyed Entertainment or similar, they are currently listed as DBA the Venue; and a request came in about changing the DBA to another name, King of Diamonds, but as far as the city is concerned what you name yourself or how you do business is of no consequence, it is the corporate entity itself is the same entity they can call themselves whatever that is a civil between them and whoever else may have a claim to name. But in terms of the entity that is contracted with the city and the settlement agreement and the entity that has the license, is the same entity. No, there is a provision in the settlement about if they are behind or if they have not paid their fees and they are in default, then at that point there is an issue, but in the settlement, they do not lose their vested rights to operate they are in default and they do not cure the default. We can have the conversation now, it all depends on what instructions you give, so I would probably suggest that if you want to explore it further, that we discuss it in Executive Session.

Councilmember Antoine – It makes sense to me, we are in the time where businesses shutting down, we are in an epidemic and we have business owners or people wanting to do business within the city, I do not think it is the time to give them a hard time on trying to bring business here. I am aware of the name technicality and all that, but if they are caught up with their fees and want to open a business in Forest Park, understand they could go anywhere, cities are supposed to welcome businesses and we can make it customer friendly, and I am for letting them reopen.

Councilmember Mears - Do not misunderstand me, I am not against businesses coming here, we need all the businesses we can get. I just want to make sure Forest Park, which we are all stewards of the city, that we look after the best interests of the city and when there are people in your ward or in the city that come to you with questions, it is our responsibility to go out, research and find out what is what and then go back and give them answers. When I do not know the whole situation and cannot explain it to someone if I do not know myself. A point of information that I found out today about the situation, I understand that the club that is there leased all the rights and paperwork from the old club that was formerly there, which I have been told that is perfectly legal. It was never about whether they should be here, I just want to make sure that the council in the mix when everything works out, we are all on the same page and got the same information.

NEW BUSINESS:

 Discussion to Approve an Agreement Between Georgia Power Company and the City of Forest Park to Provide Engineering and Design Services Related to Street Lighting Poles for Main Street Phase
 Director of Planning, James Shelby, Interim City Manager, Shalonda Brown

Background and Summary

Main Street Streetscape Project Phase 2 includes the existing spaces within the public rights-of-way between College Street (the Fountain) and Jonesboro Road. Phase 2 is divided into two parts. Phase 2A will extend from College Street (the Fountain) east to Phillips Drive. Phase 2B will extend from Phillips Drive to Jonesboro Road. Improvements includes new street lighting poles that will be engineered and provided by Georgia Power Company (GPC). GPC is asking to enter a preliminary engineering and/or design services agreement with the City of Forest Park to create a list of construction drawings and a billable estimate to the City of Forest Park related to new street lighting poles.

Comments/Questions from Council:

Councilmember James – I would like to find out if the discussion about the poles will include underground wiring? Could that possibly be in the conversation?

James Shelby – If you recall there were several options for the poles on Main Street, and to put the poles with wiring underground, which we would all love to see, would cost us \$22million. To do the wiring underground is much easier on Phase 1, because we had torn down all the building and there were no buildings to extend wires to, so it was easier to go underground. We are going to try to go underground as much as possible, but the poles that we are using would be up so high, it would help camouflage the fact that we still have overhead wiring.

Councilmember Gutierrez – When are we getting started on this, because I think Jonesboro Road and Forest Parkway with new lights, would just transform our city, I love this that we are doing for Main Street, but in the future that will be something hopefully, if GA Power has grants, that is something we can talk about in the future.

James Shelby – I spoke with Public Works today, and we are looking to replace those little candy cane green poles on Jonesboro Road, they are getting an estimate for this and once received we will bring it back to council for approval.

Councilmember Mears – When we get these project expenses from GA Power, I hope it is including maintenance and upkeep.

3. Discussion and Approval of Resolution 2021-13 for a Community Garden – Tarik Maxwell, Recreation & Leisure Director and LaShawn Gardiner, Financial Analyst

Background and Summary:

The Georgia Department of Public Health with support from the Department of Human Services and the United States Department of Agriculture has available funding for eligible communities to develop Community Gardens through its Supplemental Nutrition Assistance Program Education (SNAP-ED) and Obesity Prevention Grant Program. Priority is given to applications that are received from communities that are part of the 5 SNAP-Ed funded public health districts. Clayton County is designated within the 5 SNAP-Ed public health districts. DPH will award at least 30 grants in the amount of \$2,500.00 for each approved garden site for FY21. The Department of Recreation and Leisure Services will spearhead this project if awarded.

Comments/Questions from Council:

Councilmember Gutierrez – Do we have a site for this already? I have one constituent that is always asking about this, so I am excited we are doing this. We currently have a pocket park, is it possible or not to have a garden, can we get money for that one also?

Tarik Maxwell – We are going to look at some of the pocket parks within the city and once we determine how much grant we have we are going to try, if we can get them all approved. We are going to try to have a garden in each pocket park within the council's wards. Once awarded, we are going to reach out to some of the patrons within the community to help volunteer for the upkeep and maintenance of the gardens and follow the guidelines that is given to us. If we already have a location, we can add that to the request, because we request the locations, and they approve it. So, it does not if one exists, we just put in the locations and if we get approved for all of them, they give us the money per location, if not, we just pick which ones we will do.

1. Presentation of the Yard for the Quarter in Ward 3 - Councilmember Gutierrez

Councilmen Gutierrez presented the Yard of the Quarter Award to the Quinto-Vélez family of 4457 Berkshire Road, who have lived in Forest Park for over 20 years.

PUBLIC COMMENTS: (3 MINUTE LIMIT) There were two (2) speakers for Public Comments

- Robin Kemp There was a story about public comment period for the U.S. Army Corp of Engineers that closes on March 26th and it has to do with the Corp proposed cleanup plan of the plume on the North side of Ft. Gillem, coming from the north dump. It has been my observation that quite a few people were not even aware of this long-standing problem over there, I just wanted to make everyone aware that if you had any thoughts about it to please take a look the story we wrote, try to work around the technical terms and just look at the plan which in plain English basically means, sticking microbes into the ground, feeding the microbes and letting them eat the bad stuff and that's basically what they are proposing. And it is also Sunshine Week in the world of Journalism and open records and I just wanted to let everyone know that we are going to have a seminar on Friday, a zoom meeting and will announce the time probably tomorrow, if anyone is interested in learning more about open records and open meetings, we are happy to teach you about them.
- Chris Deluca I live behind the waste management and they are doing some things that do not quite equal up with the code that you have in place. They are facilitating animals, noise pollution at all hours of the night, they are operating 24 hours a day, and air pollution. They tell me that they work for the city and there is nothing I can do about them. I want to know if there is anything the mayor and council or city management, if there is anything you can do to help the community with this terrible problem we have. What do we do about them blatantly violating our code and the laws?

Councilmember Wells – Mr. Deluca and I have had many of conversations about this and I do not want you to think it is falling on deaf ears, I have been fighting against waste management for years now, but I cannot do it on my own, although it is in Ward 4, I am the only one fighting the battle, so I am glad you called in, because our City Attorney is here, our Interim City Manager is not here, but we have the Public Safety Director, and we are working on some things and hopefully we can get an update because my goal, a lot of our goals, is to get waste management out of our community and out of a residential area. City Attorney, can you address the issue with Code Enforcement do not want to enforce the ordinances when it comes to waste management, they are not exempt, because they are causing a disturbance in our community.

City Attorney – Code Enforcement and the applicable staff, where violations are identified they need to enforce the code.

Councilmember James – Mr. Deluca, I will reach out to you to discuss this with you as well.

Councilmember Gutierrez – I think it starts also with this narrative, we are here and can stick up for this, but you live there and having that experience. Hearing your story and everything that is happening is going to help push this forward and getting out of there and into a space where there are no residents living in the area next to trash.

RESOLUTION NO. 2021-16

A RESOLUTION TO APPROVE AN ADOPT-A-ROAD PROGRAM FOR THE CITY OF FOREST PARK

WHEREAS, the City of Forest Park ("City") is a municipal corporation duly organized and existing under the laws of the State of Georgia and is charged with being fiscally responsible concerning the use and expenditure of all public funds; and

WHEREAS, the City Council desires to establish a program to allow volunteers and/or volunteer organizations to "adopt" certain roads which would commit such persons to monthly clean-ups of those roads;

WHEREAS, the Mayor and Council believe that the program is in the best interest of the City and its citizens;

THEREFORE, THE CITY COUNCIL OF THE CITY OF FOREST PARK HEREBY RESOLVES:

SECTION 1. Approval. The program attached hereto as Exhibit A is hereby approved.

SECTION 2. Public Record. This document shall be maintained as a public record by the City Clerk and shall be accessible to the public during all normal business hours of the City of Forest Park.

SECTION 3. Authorization of Execution. The Mayor or Mayor Pro Tem is hereby authorized to sign all documents necessary to effectuate this Resolution.

SECTION 4. Attestation. The City Clerk is authorized to execute, attest to, and seal any documents which may be necessary to effectuate this ordinance, subject to approval as to form by the City Attorney.

SECTION 5. Effective Date. This resolution shall become effective immediately upon its adoption by the Mayor and City Council of the City of Forest Park as provided in the City Charter.
