COVID-19 UPDATE: Deputy Fire Chief Clemons

The Delta Variant and what we know:

- 1. Delta Variant is 51.7% more transmissible and, currently, the most dominant strain of the Covid 19 variants.
- 2. It has rapidly overtaken the Alpha Variant or B.1.1.7, which had been dominant in the U.S. since March and dropped to 28.7% of Covid-19 infections during the same period.
- 3. Covid-19 vaccines available in the U.S. protect against the Delta variant, but the virus is of great risk to people who aren't vaccinated, according to public-health and infectious-disease experts. It is estimated to be at least 50% more transmissible than the Alpha variant and in unvaccinated people it is more likely to cause severe disease requiring hospitalization.
- 4. The Centers for Disease Control and Prevention (CDC) estimates the Delta variant accounts for 78% of new COVID cases in Georgia, making vaccination more urgent than ever. The Delta variant spreads more than twice as easily from one person to another, compared with earlier strains. The highest spread of cases and severe outcomes are happening in places with low vaccination rates, and virtually all hospitalizations and deaths continue to be among the unvaccinated.
- 5. If you receive either Moderna or Pfizer vaccine, you must get your second dose to ensure you are fully protected. Individuals are considered fully vaccinated two weeks after their final dose of vaccine.
- 6. People who are unvaccinated or skip their second dose of vaccine are targets for infection

As of August 1, 2021, Clayton County has 25,637 cases of 2019 Novel Coronavirus (Covid-19) and 498 confirmed deaths. There were 426 new positive Covid-19 tests reported in Clayton County between July 24 and July 30th. Clayton County continues to account for 2.7% of the total cases in Georgia, and Forest Park representing 9.3% of cumulative Cases. Between July 26th and August 1st there have been at least 24 new cases in Forest Park.

- In Clayton County 104,667 residents (37%) have received at least one dose of the Covid-19 vaccine and 91,359 (32%) have been fully vaccinated.
- 5.9% of the positive cases in Clayton County have been hospitalized and 2.0% of positive cases in Clayton County have died.
- The average percent of Positive PCR tests in Clayton County over the last 7 days is 10.4%.
- The total number of cases (PCR and Antigen) per 100,000 people in Clayton County is 9,226. Blacks still represents the highest number of Covid cases varying roughly 57.4%
- Overall, in Georgia ages 18-29 have tested positive for Covid
- Ages 80 and older have died
- Ages 60-69 have been hospitalized
- The Georgia Department of Public Health (DPH) is urging Georgians to get vaccinated as the number of new COVID-19 cases increases daily and the Delta variant spreads.

Continue wearing masks, social distancing, washing your hands and seriously considered being vaccinated. The Clayton County Health District continues to encourage and make available opportunities for the public to receive the vaccine at a location in Jonesboro. They also have a program for providing homebound individuals with the vaccine in their own homes. Both are available through pre-registration with the Health District. Questions from Governing Body:



Mayor Butler – With the increase and variance and everything of that nature, I know you and Dr. Cooper are monitoring the data, but just let us know at any time if we need to revise our practices.

Deputy Chief Clemons – Yes, will do. With the Fire Department, I have talked with Division Chief Turner, who is over the tracking of data, from employees and things of that nature so, he and I are working on a process and a selection to keep everyone informed.

PRESENTATION(S):

1. Façade Grant Program – Economic Development Department

Background/History:

The Development Authority of the City of Forest Park recently approved a Facade Grant program to assist local businesses in improving the exteriors of their buildings. The Development Authority is utilizing its own funds for the program. No action by the City Council is necessary.

Bruce Abraham, Economic Development Director – Explained the Façade Grant Program and the application process on the city's website. If you receive calls about this, please refer them to me. This will cover the Main Street area from West Street to College Street and this is the first phase, and the Development Authority has allocated \$200,000.00 for this area, which is \$25,000 in grants, which would give us eight grants. There are approximately 12 properties that are probably eligible for this money on Main Street to fix up their properties for painting, structural stabilization, canopies, awnings, gutters, downspouts, exterior doors and windows and landscaping.

Comments from Governing Body: There were no comments

OLD BUSINESS:

2. Discussion to approve a Sister Cities Program Budget – Department

Background/History:

On September 8, 2020, the City Council Approved resolution no. 20-21 giving the city authorization to participate in Sister Cities International with 3 cities in Haiti, Ghana, and Senegal. In the initial request the budgeted dollar amount approved was \$15,000.

Comments from Governing Body:

Councilmember Antoine – This is going to be the same as before, tablets, iPhones and book bags and laptops. I am asking the mayor and council, so we do not have to come back each year, that we put in the budget so, we will not have to do this each year.

Councilmember Mears – I can understand the need for the help for this program, but I think we need to make it a moderate amount so that we can use more money that we have or will have and resources to help the people in the City of Forest Park. We have a lot of needy people living in homes they should not be living in and a lot of things, I know it is bad over there, but if you ride around here, just a mile from here you will see a lot of places that are atrocious so, I would like the council to take that in consideration if and when we come up with an amount for this program.

Councilmember Akins-Wells – I agree with Councilmember Mears, I am all for Sister City, but I am also for taking care of home first. I would like to know, who is making sure that the funds are being distributed the way they should be and that the items are getting to the proper places? Who is in control of that?

Councilmember Antoine – The two schools that chose, there are two principals, both have responsibility of their school; there is 250 kids in one school and 300 kids in the other school.

Councilmember Akins-Wells – No, my question is who from the city making sure that the funds are being distributed the way they should be and that the items are getting to the proper places? So, we are just approving this and do not know what is going on with it? Who else beside you, Councilmember Antoine is making sure things are being distributed?

Councilmember Antoine – We've seen the pictures I sent, I sent videos to most of the councilmembers. I was in contact with the principal while he made sure each kid is still using the tablets and they are functioning; they have internet access.

Mayor Butler – Attorney Williams, can you elaborate on the process you went through to verify who these items were being sent to?

Attorney Williams – The local government there does not have an internet presence, so, it was hard to sort of identify specifically the counterpart, their city manager or what have you. So, Mr. Francois Iverson is one of the primary contacts along with the principals, that we have relied on, their efforts to confirm that the items have been received at the right place. As the Councilmember has indicated, he has seen that but beyond that, it is very difficult for us her to confirm exactly what is happening on the ground there.

Councilmember Akins-Wells – I think it should be difficult for us to be so quick to send stuff until we know what is doing on.

Councilmember Mears – Rumors are like noses, everybody got one, I would like some confirmation on the authenticity on the point that we are in the Sister City management group. I do not know, rumor has it that investigations have shown that they have no proof that we are in that group. Can somebody explain to us why we are not on their roster or registered to the point where they cannot give some information. I know the children and these countries need help, but I heard the latest on what congress did this afternoon about evicting people from their home. I am not opposed to giving some type of relief fund to this group on a basis, but we are about to get in a crisis here in Forest Park, so, we got to keep that in mind, we need to take care of home first and I agree we need assist Sister City.

City Manager – I can respond to that, we did get that information, but we did get confirmation from Sister Cities International, that the City of Forest Park is a partner with them. We that to send, which was not done when the initial request was done, we must send the letters to them, stating that we have approved being a part of their organization. So, we are in the process of correcting that now, but we are a part of Sister Cities International.

Councilmember James – I am not opposed to this, initially I thought when we first signed up for the Sister Cities, that it was an annual budget amount, but one thing that is not clear to me now is, are we focused on one of the cities as opposed to all three of the cities that we initially signed up for. I want to make sure, even if we approve the budget amount, I don't think it should be the exact same thing as far as the allocation is concerned what we did the last time; I think we had an actual line-item of what was going to be spent and what funds were going to be used for so, I think that's important to make sure that we identify first of all which city we are going to be supporting in the next year and also to identify what specific needs those that

specific city is in need of. I am not for a blanket \$15,000 for what we did last time I would rather be \$15,000 set aside in the budget for sister cities, but make sure that we are spreading the love to all the cities that we signed up for.

Councilmember Akins-Wells - I agree with what Councilman Mears said about city of Forest Park, because that's my main focus I'm not completely opposed to it but I wish we put some of the same effort into our own people and like Councilmember Mears was saying we are getting ready to have a disaster here so, is there some type of program that we can come up so we can make sure that these families right here, the people who we work for are taken care of.

City Manager - Madam Mayor and Council, I apologize but I need to bring up Major Johnson from the Forest Park Police Department to introduce some new recruits to the City Council as we do with the fire recruits.

Major Johnson - I am here on behalf of Chief Clark, who's on vacation he will return on tomorrow. I have the pleasure of introducing the police department's five new employees three of them are civilians and two of them are police officers and they are all here with us tonight. Ms. Yalanda Green was hired on July the 21st as the records supervisor. She has an extensive background in law enforcement, has worked with numerous law enforcement entities in her career. She has worked with Georgia Bureau of Investigations as a secretary with GC IC and she's an experienced crime analyst and an ex-employee of the Forest Park Police Department where she worked in the records division; she was blessed enough to get the opportunity to apply for records supervisor and is now our records supervisor. Ms. Lena Adams who was hired on July 14th. Ms. Adams is our police analyst, she's a retired police officer from the Miami Dade Police Department in Florida where she held numerous positions there, including police analyst. Ms. Adams is also a certified schoolteacher and is fluent not only in English but also Spanish and Creole. Ms. Lakeya Payton was hired July 14th as well, she is now under the supervision of Ms. Green as an office assistant. She came to the state of Georgia from Michigan; when she was in Michigan she worked as a clerk with the Kent County Sheriff's Department. Now we have our mandated officers; we have senior police officer, Das Sager who was hired in December of 2020 he came to Forest Park from the Clayton County Sheriff's Office where he was a correctional sergeant; he has successfully completed the requirements at the Fulton County public safety training center on July 9th and graduated with the distinction of class corporal and he is assigned to Charlie Team. And finally, we have senior police officer Joshua Cruzleon, who was hired in April of this year he is an active member of the Georgia Army National Guard. He also successfully completed the requirements for the Fulton County public safety training center on July 9th and he is assigned to the Delta Team, if you would please welcome our new employees.

NEW BUSINESS:

3. Discussion to Approve Rezoning at 4914 West Street from Commercial to Residential PBZ

Background/History:

The Planning Commission held a public meeting on July 15, 2021, to discuss rezoning the property at 4914 West Street from Commercial to Residential to build 18 multi-family units. The Planning Commission Board approved the rezoning at 4914 West Street. The property is currently zoned C-1, due to a rezoning several years ago. Prior to this rezoning, it was zoned RM-85. The property currently houses a daycare and several offices. The owners would like to develop the land behind the existing building. They would like to build multi-family units on the property and eventually rehabilitate the building.

James Shelby, Director of PB&Z – The applicant is requesting a rezoning from Commercial to Residential and are here for any questions you may have. There will be a Public Hearing during the Regular Council meeting.

Comments from Governing Body:

Councilmember Mears – The size and type houses, the remodeling updates they have made on the apartments at the end of Moore are spectacular; is the housing that they are planning to put on that property, would be somewhere in the area or close to the houses.

Randy Pemsler, Pemsler Haas Architects – I am not familiar with the project that you are speaking of. These units are proposed to be approximately 600 sq. ft in area, one-bedroom flats, fully accessible ground floor and two units above accessed via stairway. We are not seeking supportive housing or any kind of funding, these will be market rate units. Not sure that I can compare this project to that project that you are speaking of, because I am not familiar with that development. They would wrap round the existing commercial building and would have their own separate curb cuts and dumpster and open space that would be in the rear of the building.

Councilmember Mears – (comments were inaudible) when we have different people coming in with different building strategies, it would be a shame to downgrade what they have spent over there with a substandard building over here that just my concern, that it would be somewhere in line, value wise with both places so they would simultaneously somewhat be the same.

James Shelby – I am familiar with both projects that you are speaking of, and we worked very hard to get them to that point so, we will not let that good work go to waste. I am familiar with this project, it would be similar or better that the other project and not only will we pay attention to the landscaping, but also to the elevations will look like. We have had good discussion with the applicant so, I think you will be pleasantly surprised at the outcome.

Councilmember Akins-Wells – I have a question about the existing building, what will that be once the apartments are built?

James Shelby – It will be two phases; first phase will be the construction of the apartments and the second phase will be renovation of the existing building. We have discussed apartments or lofts; The existing tenants would remain, the accounting office and the childcare facility.

4. Discussion on the Changing of the Organizational Chart for PB&Z - Planning Building and Zoning

Background/History:

The Department of Planning Building and Zoning is currently advertising for a Planner I. Since the advertisement, we have gotten only three applications. In the field of Planning, Planner I is considered an entry level position, and the duties aligned with the current position are more aligned with a Planner II position. The department is requesting to change the title of the position from Planner I to City Planner to reflect the current duties and needs of the department. The current salary range is competitive with surrounding jurisdictions for a City Planner. The request will not have an impact on the budget.

Comments from Governing Body: There were no comments

5. Discussion on Noah's Ark and Forest Avenue Tank Reconditioning – Public Works Department

Background/History:

The Clayton County Water Authority is about to enter into a contract with an experience and qualified contractor to recondition five ground storage tanks, three of which are located at 1101 Forest Avenue, Forest Park, GA (Forest Avenue Tanks). The City of Forest Park desires to utilize the Authority's contractor to paint its city logo on one of the three Forest Avenue Tanks. The Authority with its own resources has already bid and awarded Sothern Tank & Tower, Inc as the lowest responsible bidder to complete the project. The Authority will pay for the upfront costs, including labor, materials, and equipment to begin the project, in which Forest Park will reimburse the Authority for our portion of our logo totaling \$14,000.00.

Arthur Geeter, Procurement Manager – It was brought to our attention that the Clayton County Water Department was going to paint all their water towers and we caught them at the right time so, that we could place our new City logo and say welcome to Forest Park on the water tank, for viewers to see when entering the city. The total bill is \$400,000 for all towers and we will reimburse them \$14,000 for placing our logo.

Comments from Governing Body:

Councilmember Gutierrez – In the bidding, we found a company that does art, and this is their cost?

Procurement Manager – Clayton County Water did the procurement.

Councilmember Gutierrez – In the future if we would want to decorate those in a different way, is that possible, or would we have to go through Clayton County?

Procurement Manager – We would have to do a change order and we would have to inquire what exactly would you want to change and hopefully we could catch them before they begin the work, and it would be an additional fee.

Councilmember Gutierrez – They are beautiful, and it a huge canvas and it is one that was identified with the Teen Council and Director Jinks mentioned that something was in the works of putting our nice new logo out there, but if we can get the other two that would be beautiful.

Councilmember James – The water tower that is on Conley Road, is it included.

Bobby Jinks, **Director of Public Works** – No, it was not scheduled to be painted. The three to be painted are located where the American Flag is located, which is the main focal point of the intersection, and they will put their logo on a different tank further back.

6. Downtown Development Authority and Urban Redevelopment Authority Board Appointments – Economic Development Department

Background/History:

There are vacancies on the DDA which also serves as the board for the URA pursuant to O.C.G.A. 35-61-18(b) which states that "If the governing body of a municipality designates members of a downtown development authority as an urban redevelopment agency, the method of appointment, number of commissioners, and terms of office shall be in conformity with the requirements of Code Section 36-42-4."

This item will be discussed during Executive Session.

7. Discussion to Approve the Confirmation of Fire Chief – Executive Offices

Background/History:

Discussion to approve the confirmation of the City of Forest Park, Georgia Fire Chief

City Manager – We did a nationwide search for the City of Forest Park Fire Chief and had a panel of outside deputy fire chiefs and city managers that sat on the panel with me to interview four (4) highly qualified candidates, one backed out, but we still had three candidates and we all agreed at the end of the interviews that we had the best candidate all along which is something that just confirmed it for us all. Madam Mayor and City Council I will be bringing forth out Interim Fire Chief Latosha Clemons as our fire chief nominee for confirmation.

Comments from Governing Body: There was no discussion

8. Discussion to approve Resolution 2021-26 with Family Literacy of Georgia to accept a donation of a Little Free Library – Legislative

Background/History:

It is proposed that the City of Forest Park accept a donation of a Little Free Library from Family Literacy of Georgia for placement at Starr Park. The resolution authorizes the Little Free Library at that location and the terms of the partnership agreement with Family Literacy of Georgia and the Little Free Library Read in Color program.

Comments from Governing Body:

Councilmember James – I did not get a chance to contact the young lady about the donation, it is a powerful opportunity and Councilmember Gutierrez was able to sit in the meeting with her. It is free to the city, they are a nationwide partnership and will supply all the books and equipment, we will provide the location. They will put it on their GPS, so when people are traveling through and want to find a little library, they will find Forest Park on the nationwide GPS. This is a great opportunity to partnership with this organization.

Councilmember Mears – Do we have any accessibility or places to go ahead and put this in, a general location? Will this be a building?

Mayor Butler / Councilmember James – Starr Park and would be somewhere by one of the benches that already exist.

Councilmember Gutierrez – I have one in my Ward; I am waiting on a piece of the bench for the other one; one on South Avenue and the other one at Parkwood Drive. It is a little house sitting on a pole, and it on the honor system, where you go and take a book and leave a book to promote literacy.

Mayor Butler – The residents at Park at Fort Gillem are wanting something for their children there so, can we add a location or with the setup you currently have you thought about expanding there?

Councilmember Gutierrez – Yes, that is something we could do. We would just have to purchase one

Mayor Butler - Have we identified that staff who will be responsible for fulfilling all our requirements for the program? It says Forest Park will create activities to encourage clients to take a book, stock the structure with the books they provide.

Councilmember Gutierrez – The way I did it, I identified neighbors that would keep an eye on it and if they it is getting low, they would replace the books or let us know, because we have some book donations for replenishing. But that could be something that parks, and rec can do to promote it.

2. Council Approval Resolution 2021-29 of Cemetery Initiative — City Attorney

RESOLUTION NO. <u>2021-29</u>

A RESOLUTION TO AUTHORIZE MAINTENANCE OF CERTAIN CEMETERIES WITH THE CITY LIMITS OF FOREST PARK

WHEREAS, the City of Forest Park ("City") is a municipal corporation duly organized and existing under the laws of the State of Georgia and is charged with being fiscally responsible concerning the use and expenditure of all public funds; and

WHEREAS, there exist certain cemeteries within the corporate limits of the City that are not being maintained and appear to be abandoned inasmuch as they show signs of neglect including, without limitation, the unchecked growth of vegetation, repeated and unchecked acts of vandalism, or the disintegration of grave markers or boundaries and for which no person can be found who is legally responsible and financially capable of the upkeep of such cemeteries;

WHEREAS, O.C.G.A. § 36-72-3 authorizes counties and municipalities to preserve and protect any abandoned cemetery or any burial ground which the county or municipality determines has been abandoned or is not being maintained by the person who is legally responsible for its upkeep, whether or not that person is financially capable of doing so, to expend public money in connection therewith, to provide for reimbursement of such funds by billing any legally responsible person or levying upon any of his property as authorized by local ordinance, and to exercise the power of eminent domain to acquire any interest in land necessary for that purpose; and

WHEREAS, it is proposed that the City take certain steps (i) to declare such cemeteries abandoned, (ii) to begin maintaining such cemeteries by keeping them clean and free from unchecked grown of vegetation, and (iii)to exercise the power of eminent domain for such purposes;

THEREFORE, THE CITY COUNCIL OF THE CITY OF FOREST PARK HEREBY RESOLVES:

SECTION 1. Declaration of Abandonment. The cemeteries listed on the attached Exhibit "A" are hereby declared abandoned.

SECTION 2. Authorization of Maintenance. The City Manager is authorized to direct the Public Works staff and/or the City's on-call landscape maintenance vendors to maintain said cemeteries by keeping them clear of unchecked vegetation, trash, and debris.

SECTION 3. Eminent Domain. The City Manager is authorized to initiate such steps as are necessary to provide for the acquisition of the abandoned cemeteries by eminent domain. The City Manager and the City's outside legal counsel are further authorized to identify and engage appraisers, surveyors, and other consultants to provide appraisal reports, trade fixture reports, sign appraisals, title reports, surveys, legal descriptions, environmental assessments, moving estimates and any other reports (collectively "Reports") that are necessary or desirable to quantify the nature

and extent of the potential acquisition the abandoned cemeteries. Any engaged Consultants are authorized to enter private property on the City's behalf to survey, inspect and appraisal such property for the purpose of quantifying the nature and extent of the potential acquisition of private property rights and to determine just and adequate compensation for such potential acquisition.

SECTION 3. Public Record. This document shall be maintained as a public record by the City Clerk and shall be accessible to the public during all normal business hours of the City of Forest Park.

SECTION 4. Authorization of Execution. The mayor or is hereby authorized to sign all documents necessary to effectuate this Resolution.

SECTION 5. Attestation. The City Clerk is authorized to execute, attest to, and seal any documents which may be necessary to effectuate this ordinance, subject to approval as to form by the City Attorney.

SECTION 6. Effective Date. This resolution shall become effective immediately upon its adoption by the Mayor and City Council of the City of Forest Park as provided in the City Charter.

A RESOLUTION BY MAYOR AND CITY COUNCIL OF FOREST PARK, GEORGIA TO SUPPORT THE SUBMISSION OF A LIVABLE CENTERS INITIATIVE-TRANSPORTATION PROGRAM GRANT APPLICATION FOR PRELIMINARY ENGINEERING TO THE ATLANTA REGIONAL COMMISSION WHICH REQUIRES A 20% LOCAL MATCH, FOR THE FOREST PARKWAY-STATE ROUTE 331 PEDESTRIAN OVERPASS BRIDGE, CROSSING FROM STARR PARK TO THE MAIN STREET MODEL MILE GREENWAY TRAIL IN AN AMOUNT NOT TO EXCEED \$200,000.00: AND FOR OTHER PURPOSES.

WHEREAS, the Atlanta Regional Commission (ARC) announced a call for funding for Livable Centers Initiative (LCI)-Transportation projects for Preliminary Engineering (PE) proposals only and requires a 20% local match: and

WHEREAS, applications are due by August 27, 2021, and will be competitively selected for awards based on predetermined selection criteria; and

WHEREAS, the LCI grant program has existed to empower communities across Metro Atlanta to become more livable, walkable, and sustainable; and

WHEREAS, the LCI program was created to allocate federal transportation dollars for planning in local communities; and

WHEREAS, the grants are designed to help communities become more vibrant, walkable places that offer increased mobility options, encourage healthy lifestyles, and provide improved access to jobs and services; and

WHEREAS, the submission of an application for funding assistance, if awarded, will aid in preliminary costs associated with engineering and design of the pedestrian overpass bridge; and

WHEREAS, if awarded, the grant agreement will impose certain oversight conditions upon the City of Forest Park.

NOW THEREFORE, BE IT RESOLVED that the City of Forest Park City Council supports the submission of an LCI-Transportation grant application to the ARC for the aforementioned project in an amount not to exceed \$200,000.00.

- **Section 1.** The Mayor and City Council of Forest Park, Georgia hereby authorizes the submittal of appropriate documents to the Atlanta Regional Commission to apply for the LCI-Transportation grant. Furthermore, approval is hereby granted for the acceptance of funding from the ARC for the purposes as specified if funding is awarded to the City of Forest Park.
- **Section 2.** If any section, sentence, clause, or phrase of this Resolution is for any reason held to be invalid or unconstitutional by a decision of the court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Resolution, and such remainder shall remain in full force and effect.

WHEREAS, Forest Park is permitted to conduct municipal elections; and

WHEREAS, the City of Forest Park has its own Electronic Voting Units and requests the use of the Board's equipment to accommodate the electors of the city; and

WHEREAS, the Constitution of the State of Georgia provides that governments and public agencies may contract with one another to provide services, facilities, or equipment pursuant to Article IX, Section 3, Paragraph 1(a) and (b); and

WHEREAS, the Clayton County Board of Elections and Registration is the custodian of certain State owned election equipment that can be loaned to various municipalities in Clayton County to conduct elections.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council authorize the entry of the attached Intergovernmental Agreement with Clayton County Board of Elections and Registration for Election equipment; authorize the Mayor to execute the document on behalf of the City; and provide for an effective date.

INTERGOVERNMENTAL AGREEMENT

This agreement made and entered into this	_ by and between C	layton (County
Board of Elections and Registration (hereinafter referred to	as "the Board") ar	nd the	City of
Forest Park, a political subdivision of the State of Georgia (hereinafter referred	to as '	"Forest
Park").			

ARTICLE 1

PURPOSE OF AGREEMENT

The purpose of Intergovernmental Agreement is to provide the City of Forest Park with equipment to conduct its municipal election with State owned equipment on loan from the Clayton County Board of Elections. In order to facilitate the City of Forest Park's municipal election process the parties have agreed as follows:

- 1. Responsibilities of Parties
 - A. The County Election Superintendent shall supply the following equipment to the City of Forest Park:
 - 1. (8) Image Cast X (ICX)
 - 2. (8) Ballot Marking Printer
 - 3. (4) Uninterrupted Power Supply (UPS)
 - 4. (4) Memory Cards (2 per ICP)
 - 5. (2) Poll Worker Smart Cards
 - 6. (1) Audio Tactile Interface Kit (ATI) which includes the following: ATI USB,

ATI cable

ATI headphones

- 8. (2) Technician Smart Cards
- 9. (40) Voter Smart Cards
- 10. (2) Image Cast Precinct Scanner (ICP)
- 11. (2) Ballot Plastic Box for ICP
- 12 (1) USB Flash Drive
- 13. (10) Privacy Screen
- 14. (2) ICP Scanner Paper Roll
- 15. And other peripherals associated with the ICX Voting System (Dominion Voting System)
- B. The County Election Superintendent shall supply to the City of Forest Park one (1) Ballot Marking Device and all equipment needed to be used as a Demonstrator Unit.

- C. The County Election Superintendent shall designate a date, time and place for the City of Forest Park to retrieve and return the items listed under Section 1(A) of this agreement.
- D. A state Election Equipment Log, attached herein as "Exhibit A" shall be maintained by both parties of this agreement.
- E. _____ will be the contractor for the City of Forest Park to supply the following:
 - 1. Provide programming services.
 - 2. Training of Election Superintendent, Deputy Election Superintendent, Poll Manager, two (2) Assistant Managers and two (2) Clerks.
 - 3. Conducting the Logic and Accuracy Testing.
 - 4. Technical Support on Election Day.
 - 5. Chain of Custody report, attached herein as "Exhibit B" shall be executed.
- F. The City of Forest Park shall be responsible for retrieving and returning voting equipment.
- G. The City of Forest Park shall be responsible for the printing of Absentee Ballots.
- H. The City of Forest Park shall hire an experienced poll manager and two assistant managers
- I. The City Election Superintendent shall train the Poll Clerks.
- J. The Elections Superintendent and staff shall attend the state mandated training prior to the election.
- K. All City of Forest Park election's staff shall sign an Oath of Custodians and Deputy custodians of Ballot Marking Devices as required by the Georgia Elections Code, attached herein as "Exhibit C."
- 2. Costs to the City of Forest Park:
 - A. There is no charge to Forest Park for actual use of the state owned voting systems.
 - B. Forest Park is responsible for any damage to the voting units and peripherals in its possession that is not covered under the State of Georgia's warranty. (Note: The voting machines are no longer under warranty with the State)

ARTICLE II

DURATION OF AGREEMENT

This Agreement shall be effective from ______, 2021 to December 31, 2021. This Agreement shall terminate absolutely and without further obligation on the part of either party upon expiration of aforementioned period.

ARTICLE III

1. This Agreement in no way is deemed to create a debt incurred by the City of Forest Park for the payment of any sum.

- 2. This Agreement constitutes the entire Agreement and understanding among the parties hereto and supersedes and revokes any prior agreement or understanding relating to the subject matter of this Agreement. No change, amendment, termination, or attempted waiver of any of the provisions herein shall be binding upon the other parties unless reduced to writing and signed by all parties hereon.
- 3. Nothing contained in the Agreement shall create a contractual relationship with or a cause of action in favor of a third party against Forest Park.
- 4. This Agreement may not be assigned by either party hereto without written agreement by both parties. This Agreement and the rights of the parties hereunder shall be binding upon and inure to the benefit of the parties hereto and their respective successors and, if applicable, or assigns.
- 5. Any notices or communications required or permitted hereunder shall be sufficiently given if sent by Registered or Certified Mail, Return Receipt Requested, Prepaid Postage, and addressed as follows:

- 6. The captions used in this Agreement are inserted for convenience only and shall not constitute a part hereof.
- 7. No waiver by either party of any default by the other party in the performance of any provision of this Agreement shall operate as to be construed as a waiver of any future default, whether like or difference in character.
- 8. This Agreement shall be governed and construed in accordance with the laws of the State of Georgia.

9. If any provision of this Agreement, or application thereof to any person or circumstance, shall to any extent be invalid, then such provision shall be modified if possible, to fulfill the intent of the parties as reflected in the original provision, the remainder of this Agreement or the application of such provision to persons or circumstances other than those as to which it is held invalid, shall not be affected thereby, and each provision of this Agreement shall be valid and enforced to the fullest extent permitted by law.
